

Coronavirus confirmed in South Africa

Yesterday a 38 year old man from KwaZulu-Natal tested positive for coronavirus Covid-19. It is the first coronavirus case to be confirmed in South Africa. The confirmed coronavirus victim was reported to be part of a group of ten, including his wife, who flew back from Italy on 1st March to OR Tambo airport in Johannesburg and then changed planes for KwaZulu-Natal. On Tuesday 3rd March the man went to see his doctor, complaining of fever, headache, malaise, a sore throat and a cough. The doctor took swabs and sent them to a laboratory for testing. Since the doctor's appointment the 38 year old man has been self-isolating, presumably at home. The doctor has also self-isolated. The result of the laboratory test was announced yesterday by South Africa's Health Minister. According to the Health Minister, the man did not show symptoms until days after his return, and is the reason why he was not identified when screened at the airport.

Just hours before the first South African coronavirus case was announced news websites were reporting that the National Institute for Communicable Diseases had stated that despite testing, no Covid-19 cases had been confirmed in South Africa. One news website quoted 118 tests being made while another said the number was 180. Just a few hours after these reports were published, the first coronavirus case was confirmed.

There is now the complicated task of tracing all contacts, not only of the man who has tested positive but all the others in the group of ten who travelled together from Italy. Contamination could also have occurred on the planes they travelled on and at OR Tambo airport. It has not been mentioned in reports that other passengers on the same planes are being traced. Checking for any possible spreading of the coronavirus at OR Tambo airport is impossible. Also included in the tracer team's searches are all the contacts made by the 38 year old man from the time he arrived home on Sunday to the time he saw his doctor on Tuesday.

The Daily Maverick website drew attention to concerns among some over the effectiveness of screening processes for Covid-19, such as those being implemented at South Africa's airports. While screening at airports involves taking people's temperature, it does not involve taking samples from all travellers and testing those samples for Covid-19 – something that would be time-consuming, expensive and would probably make international travel untenable.

The Daily Maverick reported that according to Tim Tucker, adjunct associate professor at the University of Cape Town School of Public Health and Family Medicine, there will never be a "foolproof screening technique". "However, we do know that many or most people with active Covid-19 have a fever. So, detecting those with a raised temperature is a good start but will have inherent problems," he said. Tucker listed among these problems cases where people may have a fever because of another infection and these people will be flagged but not Covid-19 infected. There may be cases where people are Covid-19 infected but do not yet have a fever, or they may be infected "sub-clinically" with no symptoms and the fever may only develop later.

"Taking a person's temperature is a screening tool, not a per-



fect diagnostic test," he said. "We cannot test every person who comes through our border posts for Covid-19 nor should we. Thus, more simple screening processes are required."

South Africa's politicians are now getting very much involved with many issues related to the Covid-19 epidemic which some now say has become a pandemic. Government politicians are claiming to have effective processes in place while at the same time conceding there is a big and difficult job ahead. Opposition MPs are criticising what they say is inadequate screening at borders. "The majority of our people use alternative modes of transport and our country's borders don't start at and end at OR Tambo International Airport" was one comment. On the other hand critical-care physician Professor Guy Richards believes South Africa is ready. He is an expert at the quarantine treatment of highly infectious patients. Richards supervised treatment of an Ebola case at Charlotte Maxeke Johannesburg Academic Hospital, a designated Covid-19 quarantine hospital, and no health worker was infected. But the South African Emergency Medical Services personnel union are reported to be demanding the medical equipment needed to fight the coronavirus.

Meanwhile a widespread spate of panic buying cleared the shelves in many pharmacies across South Africa. Hand sanitisers and washes, gloves and masks have been scooped up while social media is saturated with updates on the coronavirus and advice on how to take precautions against it. In Nigeria, social media posts have included some stupid and dangerous advice on how to prevent contamination from Covid-19. "Here is what you should do to protect yourself from the disease. The disease will not affect you. Your body will fight the disease. You should use garlic in your drinking water and in your food, add it while cooking, chew it all the time and use



One such piece of advice is wash your hands thoroughly for at least 30 seconds with soap.

One hand washing advisor included photos to illustrate how ineffective just rinsing hands or a quick six second wash with soap really is. The white or lighter areas on the hands in the photos indicate contaminated areas. The bottom row shows the result after washing hands for 6, 15 and 30 seconds with soap. The low definition in the photos may not show it clearly but the message is a 30 second hand wash with plenty of soapy lather leaves hands just about germ free – for a while.

it all the time." It is suspected this advice came from a garlic grower eager to make money from a potentially disastrous situation.

South Africa is the seventh African country to have Covid-19 within its borders. Algeria is the worst affected with 17 cases as of yesterday. Senegal has 4 cases and Egypt 2 while Morocco, Nigeria, Tunisia and South Africa all have their first case, at the moment.

ST HELENA WATER LEVELS

Water levels around the Island are continuing to steadily rise following a few spells of downpour amidst another week of mostly sunshine on St Helena.

Contributing to the steady increase in stored water, average consumption rates for the past week have met the target level of 1000 cubic metres – a credit to us all. This type of water saving awareness and preservation must continue for stored water levels to reach desired capacities.

Remember, we are still currently under an Island-wide hosepipe ban.

While some recent bouts of rain can certainly be described as heavy, there is an issue that these showers are not being experienced Island-wide - especially over higher ground.

More consistent heavy rain, over higher ground, is needed for surface flows to increase and stocks to replenish. Until then, we must continue to keep consumption to essential needs only.

We all must spread the word to continue to preserve as much water as possible to ensure that the situation continues to improve.

Despite stored water level increasing as a whole, Red Hill is

still a problem area. Whereas Hutt's Gate reservoir is at 95% capacity, Red Hill remains dangerously low at just 22%. This is further aggravated by Red Hill being the largest supplier, contributing to around 45% of daily consumption.

Connect St Helena (CSH) is continuing to efficiently pump water to Red Hill until stocks begin to replenish.

If you see anyone using water irresponsibly or notice a burst pipe or leak, then please inform CSH immediately. Every drop counts, every action counts - Everyone must save every drop of water possible.

The information released last Friday telling us what our fishing industry might look like a couple of years from now is limited and confusing. Where a little sense can be made of it – or guessed – there is a strong indication the best opportunities for making fishing a thriving money-maker for St Helena are being given away to overseas interests. The South African company will be bringing its own fishing vessels with freezer facilities. Nothing wrong with that, thank you very much. But the fish when landed are packed immediately into reefers ready for export. This means freshly caught raw fish will leave Rupert's either from the adjacent wharf by ship or maybe some of it will go along the Haul Road to the airport to be flown out.

Raw fish has the lowest possible value. Adding value to the raw product will happen in South Africa and that is where the real profits will be made. If the fish is processed in Rupert's Valley the export value of the fish increases significantly. People here gain employment from the processing work and the more money from the sale of fish with added value stays on the Island. Surely that is one of the main aims of the Sustainable Economic Development Plan; a document which is often referred to in official publications to justify a range of proposals and actions. On this occasion, with the change of direction with the fisheries, it is being ignored.

A similar situation prevails with coffee. The green beans are



St Helena coffee commands premium prices across the world but we hand the profits to companies overseas instead of processing, packaging and marketing the final saleable product here and selling at the highest achievable price instead the lowest possible price. Once again the profits are given away to overseas businesses.

While all this is employment and profit is being given away we are assailed with pipe dreams about selling the Mantis Hotel at a commercial price when the tourist trade picks up. Meaningful suggestions about how to trigger a pick up in the tourist numbers are few and those that there are, seem likely to have minimal effect. As reported elsewhere in this edition of the Independent there was a 1% increase in 'genuine' tourist numbers in 2019 compared with the previous year. The tourist numbers are so low this means that if the 1% increase year on year continues through to 2040 we will see an additional 500 tourists getting off the planes compared with 2018. The situation will not change itself. A change of direction of some sort is definitely needed. A good manager knows where to look to find the person or people who know how to make a change of direction happen. A good manager knows he or she cannot do it all alone but does know where to find the right kind of help at the right time. Do we have any managers or decision-makers like that?

Which brings me to the Sarkin Report. Professor Jeremy Sarkin's second report was expected this week. He stated clearly and confidently he would have it completed by the end of February and it was suggested by a government source that it would be released this week. We can still hope it will be released today. Or are SHG sitting on this report about openness, transparency, accountability and responsibility for some reason best known to themselves?

If you want to help St Helena Tourism in their quest for a few short, simple, snappy words which will catch the eye of thousands of people across the world who are looking for somewhere different to go for their next holiday, help is at hand.

Here are some quotes from the descriptions of St Helena written by three people who write on travel and are skilled wordsmiths. Maybe one of the quotes will trigger the thought that comes before the brainwave that produces the slogan St Helena Tourism is looking for.

The usual view from most peoples' homes in the UK is a lot different to St Helena

In this particular garden the lady in the house almost choked on her cup of tea when she looked out to see a dozen cows enter her small back garden and start grazing on the apple trees and then the cows put away a dozen cab-



bages, half a dozen cauliflowers, Brussels sprouts, peas and beans. A local farmer herded the cows back to their nearby field after a few hours. As a thank you present the cows left plenty of manure to enrich the soil for more cabbages, cauliflowers, Brussels sprouts, peas and beans.

The "Infamous King of Spam" targets St Helena again

A series of very weird emails have been received by several people in St Helena from someone calling himself JP Monfort. His messages are confused, unclear and pointless; but he does keep sending them. Often they have attachments which put a drain on the meagre megabyte allowances we pay for. Strangely, Monfort appears to know something about his targets. One of his spam emails aimed at St Helena included the image below. It features a number of notable people but it includes Cathy Alberts who was a Director of Tourism before Helena Bennett. Monfort's information is always not up to date and his email addresses are sometimes out of date.



To avoid receiving spam emails starting a new email address and closing down the one used by Monfort is one way; but it is very inconvenient and will cause many complications.

A website run by Computer Facilities Technical Services (CFTS) was also targeted by Monfort. Subsequently they issued information of what can be done, if anything, to stop Monfort's spam emails. The information is not encouraging. CFTS say, "If you use a public email address such as Gmail, Yahoo or AOL (and Helanta) then there is absolutely nothing you can do except tighten up on blacklisting and filtering provided by your online software"

Then CFTS adds, "If you have your own email, through a host, and your own domain, the you can begin using expression filters for emails and blocking domains as well as the normal spam filters and services." CFTS said they finally managed to block "Mr Spam King" but it seems to be and expensive thing to do.

On spammers in general CFTS commented, "One thing most people don't realise is that 99% of what we call spam is really is a crime or at the very least attempted crime. Many of the spams are setting up the victim for a planned future crime. There are 80 criteria that can classify it as criminal activity. The question is still out there, if this guy (Monfort) really is a scammer or just massively unbalanced."

The last known Monfort spam assault on St Helena was in May 2016. His email was headed "A Special Warning For Saint Helena Governor Mark Andrew Capes" and in the text appeared –

SPECIAL WARNING FOR

Saint Helena Governor Mark Andrew Capes Beneath this headline was written,

"J.P.Monfort is uniquely trained and highly motivated. Specialist without equal, immune to any counter measures. There is no secret he cannot extract no security he cannot breach no person he cannot become. He has most likely anticipated this very conversation and is ready to strike in whatever direction we move. J.P.Monfort is the living manifestation of destiny and has made you, Saint Helena Governor Mark Andrew Capes, his lifetime mission to persuade and conquer. Desperate times require desperate measures. This message has been typed from Year 2210."

Please deliver this e-telegram to SEAN.BURNS @SAINTHELENA.GOV.SH at the earliest possible convenience. Mission Impossible Rogue Nation has inspired this communication. This message will self-destruct on 1-January-2051. Over and out.

MV Helena - Voyage 26 Delay Notice

AW Ship Management regret to inform that owing to weather issues and port congestions in both Europe and Cape Town the transhipment containers on Voyage 26 have been delayed. The vessel carrying these containers discharged at Coega Port, located north of Port Elizabeth and unfortunately due to other vessels trying to maintain their schedules these containers have been rolled to a later feeder vessel not due into Cape Town until the 12th March.

In addition to these transhipment containers another shipment was due to arrive into Cape Town for Voyage 26 and this vessel also omitted their first Cape Town call, these containers are due to be discharged on the 15th March.

AW has been following the movements of these vessels closely and working with the shipping lines to try to mitigate these delays. St Helena Government have been informed and a joint decision has been made by both St Helena and Ascension Island Government. It has been agreed that the MV Helena will delay her departure for this cargo and to assist with maintaining schedules the Ascension call has been moved to Voyage 27.

An updated schedule will be placed on the website, but please find the below for your planning requirements.

Any Ascension breakbulk cargo already loaded onto the MV Helena will remain onboard unless the shipper request for it to be discharged.

Dear Editor,

I read with interest the letter on pages 10 & 11 of the St.Helena Independent dated 14th February 2020 from a gentleman back home who has worked on Falklands, who has 2 boys and who is going through 'financial stress'.

My name is Anthony Peters (well known as Tony Foot from Longwood) who is once again away from home working on Falkland Islands. After reading the article, i sympathize with this gentleman as i care about other people and their well being. I have walked many miles/ hours for charity for people who have been sick etc.. I would describe my personality as quiet, kind, helpful, sensible & easy going. I been having this strong wish to 'open up and let it all out from within me' about my experience of ANXI-ETY (unnecessary worrying) triggered by financial worries & my childs future because of her learning disability and not able to work because of her Autism Spectrum Disorder (ASD). However, i got no need to worry as she has a very caring mummy and step-daddy and i know she is in good hands, and i know she is loved and well cared for but its just the nature of me - sometimes worry when not necessary. With me it has been a combination of anxiety, but also a bit of depression originating from missing my daughter from my life, as she did'nt used to live with me anymore. Our lovely island home of St.Helena is going through a very difficult economic situation at present, and i am pretty sure there is a few more of my fellow saints back home who are going through stress/anxiety/ depression due to the financial difficulties being faced/bleak future of our island home.

I have been back on Falklands now for almost 6 months, after being home for past 5 years, having previously worked on Falklands for many years before this, for which i am so glad i managed to achieve something by getting my own house built. I'm so glad that i am not just starting to do house now with todays

cost of land/materials/labour. I was not bright at school and i did not have the talent/skills that many other men have today, so i was just a 'pen pusher'. Salaries on St.Helena are just way too low for the 21st century and life can become stressful and then this causes you to worry about the future, and you can become feeling insecure and you can then eventually end up with ANXIETY which is triggered by this continous worrying which sometimes can be uncontrollable. Because i did'nt have any tradesman skills i decided to leave my private sector 'pen pusher' job to have a go at a little shop in the market upstairs called 'Tonys Bits & Bobs' as at the time i thought i could make more money. I wanted to make more money somehow as i had a lovely child Regan growing up whom i absolutely love, and who by the way is 'autistic', and who dont live with me anymore which was hard to get used to. I could'nt afford to buy as much for her as i wished because the pays back home are in most cases just about enough to live on and now its getting worse.

Anyway as for the shop i did'nt have much idea about retail business but it was just a panic decision to try something out. I eventually discovered this was a bad decision, and a big mistake, and it caused my anxiety to get worst, as i got myself into bit of financial difficulty as the business was very slow going and i depended on this, and i lost some money as i had to give it up and sell off.

From this time on, i used to worry more and more about the future and i could feel it was affecting my mental health with these symptons:-

Continuous worrying and waking up feeling nervous - living in fear - heavy sweating in bed at night.

Having fear of going out and being around people - didnt feel like talking to anybody.

Deep in thought - not noticing people saying hello to me on the street. Couldnt get out bed and just not motivated to do anything - just wanted to lay in bed and cover my head up.

Having negative thoughts and being tempted to harm myself

Mind thinking too far ahead of me not taking one day at a time

Could not feel happy or enjoy my life (depression ??)

Lost interest in my family/relatives/

friends

Degrading myself and kept thinking i was a failure/useless

Very low confidence in myself

Didnt care about myself - started to hate myself.

Body felt drained/fatigue/kept yawning all through day - just sleeping too much on Sundays.

Low sex drive

I could tell things were going wrong with me so i got in touch with the mental health team to tell them how i was feeling. I then had therapy sessions with the Clinical Psycologist, Dr Tara Murphy who i met on wednesday afternoons at St.Johns Villa for an hour or so, who explained in detail how the human mind works and the things a person can do to help themselves when in these situations. After these sessions i used to then walk home to Longwood. It used to make me feel a bit better after talking to Tara, and i found her very professional, helpful and caring.

There was a few times that i went walking up to the top of Flagstaff and i felt the temptation to do something to myself, but i did not know which way to do it. I also stopped for a minute and thought about what the Psycologist taught me, and i thought about my partner and my daughter. I had a picture of them in my mind. Some mornings i woke up feeling terrible and i used to go up to Longwood Gate to ask my mum Barbara to please pray for me, as those negative thoughts were overpowering me, and i was having some dark days where i did'nt know what to do with myself. I used to keep saying to myself 'God please help me'. I couldnt stand these feelings and it was making me feel fed up to myself which led to me having these very dark thoughts . One Friday evening in July 2018, i went up to Maisies shop at Longwood and i bought 2 flasks of vodka and a box of paracetamols and i went home got in bed and poured some vodka down my throat and swallowed some paracetamols behind it. Later on that evening, my mum and some of my longwood friends were outside shouting 'Tony Tony you in there '. My phone was constantly ringing. I did not answer them, then eventually i heard somebody breaking the glass in my house door to try unlock it to get in. It was police to check on me if i was ok. I then heard the ambulance outside and

the police/nurses lifted me out of my bed and lied me down in back of ambulance. They then took me to hospital where i was for about 3 -4 days for rest/review/ recovery. It never had to happen to me so i am still here today thanks to god. This has been the darkest day of my life so far. I have had few dissapointments in my life (dear Johns etc) but i have not experienced anything like this.

Since i have been back on Falklands this time (arrived 12th Sept 2019) i was really struggling with these negative thoughts for the first couple months and it was very hard just to simply get out of bed. I did not make it to work some days so i explained my situation to Sodexo management here, and they were very helpful and supportive of me. One morning in mid September 2019 not long after arriving back on Falklands, i woke up feeling terrible and my mind was just all over the place and once again i was tempted to do something to myself. I felt miserable and so wished to be out of this misery. I have never told anybody this part but i put a black bin bag down over my head, layed in bed and i strapped some packing tape around my throat to try suffocate myself. Once again i had to stop and think about my daughter Regan and my partner who would have been left behind. Lester and Tina put me on to this SSAFA Social Worker lady over at WVRS (Rockhoppers) where people can go if they have any mental health issues here at MPA. They were all very supportive and helpful. I have been having reviews at the Medical Centre here at MPA, and i must say the support has been very good. I feel much more relaxed and stress free. I feel much more brighter and more positive nowadays, and those bad thoughts seemed to have gone away. My my mind has calmed down quite a bit to what it used to be. I work at Top Naafi doing general cleaning, i now feel settled and i did'nt know that i would enjoy cleaning (i can deep clean your house when i come home ha! ha!). There is nothing wrong with cleaning - aint we do it in our own home ?) Some days i wake up though and i have this little bit of worry in the back of my mind about the future but this is what ANXIETY is all about. It tends to be first thing mornings when i wake up, but it gradually fades away when i start to do things at work. In these situations i have to distract my mind from these thoughts by thinking about something positive, or do something to keep myself occupied. If i sit around doing nothing this is when i start to go back in to 'thinking mode'. I know how to deal with this now. I have now learned to stay positive as i am not alone, and there is still lot more to live for at the moment.

I feel that i have made much progress over past 3-4 months, and now seem to have recovered as i have now got myself motivated again and i feel energetic and a bit more happier. I wake up between 03.45 - 4.00 am every morning to start work at 5.00 am, so i got this routine going now. I seemed to have got through it. I dont have anymore thoughts of harming myself. I felt trapped in this dark place where i was lost, and now seem to have found my way back. The Senior Medical Officer here at MPA has since done some health screening (blood tests) on me to check my heart, lungs, liver, kidneys, thyroids, cholesterol, blood cells, diabetes etc and the results have all been positive. She has told me that i am very fit and healthy, and to keep doing what i been doing. I would therefore like to end by saying 'Thank you Lord'as my prayers have been answered and i just wanted to put the message out there to anybody back home who are experiencing these sort of feelings, to please go forward to speak to someone in the mental health team. You need to get it off your chest, dont bottle it up. I have found that when i tell somebody about it, it makes me feel better. I am feeling better already just by typing this article on my laptop. There is help out there. Please tell your problem to a close friend, family member or Ian Rummery and the team there at St.John's Villa over behind the hospital. Some people are too afraid to come forward with mental health issues as they are worried about what other people will think of them. People will probably think you are weak, you are a 'softie', or you cant handle pressure but dont take no notice to those kind of people. They can be ignorant as they dont understand the about the human mind (psycology) and how every human being is different. The human mind is very powerful. Not everybody is the same. We all think/feel/behave differently to different situations. Some people are more sensitive than others. Its just like my daughter who is 'Autistic' and there is a few more back there on island with this disorder. I know people who have said these children are rude and ill mannered because they dont understand what AUTISM is and what's going on in these peoples brains. Some people need to be educated a bit more about these various mental health issues. They assume too much and jump to conclusions as they just dont understand and they have 'narrow minds'. If you're on internet anytime google search 'GENERALIZED ANXI-ETY DISORDER' which is constantly worrying, sometimes over silly little things. Its a disorder. We are not alone as millions of people in world experience this some time in their lives. So now you know why i'm going grey (ha! ha!), and why i always look so serious and bit 'far out' sometimes. Dont judge people - you just dont know whats going on in their head.

Thanks very much for your understanding and please dont be afraid to go forward and speak up, as there is nothing to be ashamed of. I have told alot of people what happened to me and they have said that it is really good that you have talked about it. Please dont suffer in silence - mental health problems are common. It doesnt make you a bad person so dont bother what other people think of you. If we going to worry about what other people think of us we wont get anywhere. And yes, i do agree with the gentlemans letter in the independent where he says people are 'nosey'. Unfortunatley it is the 'Saint' culture where we tend to worry more about what other people are doing rather than concentrate on ourselves and whats going on in 'our own back yard'.

I hope and pray that sometime soon, something will change on St.Helena and that the future will get a bit brighter because most of us like to be home – there is no place like it – i dont care where you have been!. Just take a look at the beautiful scenery photos/videos that 'Saint Cooks', Tourism & Darrin and Sharon Henry have on internet. Take noticeof the greenery when you drive around island (but dont take notice to untidy road sides which need *Continued on NEXT PAGE*

some care and attention).

Its beautiful - you don't appreciate it until you leave it. Its nothing wrong with the place....it's the people who run it. The Falklands is economically better than St.Helena but is nowhere as beautiful. You drive to town (Stanley) 35 miles away and you dont even see a tree. The government here have got it made financially due to tourism, fishing licenses, 4 flights per week, and i would say that the councillors here (MLA's) are more qualified and know what they are talking about. We hear alot about our councillors back home dont know what they talking about. One weekend few weeks ago there was 4 cruise ships in. Maybe in future there will be oil. If we all could make a decent salary back home and save a bit of money and could afford to go on a little holiday once in a while im sure most of we Saints would come home tomorrow. Unfortnately not all of us are bright/talented, so we dont have much choice but have to keep leaving our home/family/children.

Thank you for taking time to read my article-keep positive - feel free to contact me at anytime. Dont be afraid to ask me anything about my experience. Hope to be home on leave around 11th July 2020 god willing! Bye for now!

Dear Editor

I wrote to this paper 2 weeks ago and whilst there has been some response from Government on what is being done in terms of Covid 19 the response hasn't been satisfactory and I feel that more can be done to protect the island. Our processes seems to be geared toward the best case scenario rather than the worst and toward it being picked up at the airport as opposed to it being detected and found on the island among our locals after the carrier might have come and gone.

We have been informed that people arriving from China will be isolated? How effective is that going to be, we allow them to our shores only to then direct them to the isolation unit in Bradleys. We hope that as they read this advice that they will decide not to come but how fool proof is that? What's stopping us from banning them? Its not discriminative or victimisation it is strong measures to contain the virus. WHO has given us the tool to do this in declaring this a global emergency.

The information in this week's press release is already out-dated with a growing number of cases in other countries in Europe. Has our Government stepped up to this, will the screening be extended to these countries for tomorrow's flight?

It was interesting to hear on the BBC this evening when Dr Tedros Adhanom Ghebreyesus head of WHO said "It would be a fatal mistake for Government's not to take this serious"

Another also said that the costs to take preventative measures will far outweigh the costs to any country if they become infected, the costs to their economy but most importantly the cost of life would be much more devastating than taking any measures to prevent the virus. Meaning it would be wiser to lose money in the process of prevention than it would be to spend a lot more of it trying to save lives once people already have the virus.

If we took such advice we can stop this from happening to St Helena. We can close the borders:

How difficult it is to stop 1 flight per week to the island until we reach some stability with the virus. The loss of life would be a greater loss than this.

How difficult is it to stop the 3 cruise ships from coming here? We have turned them away in rough sea conditions, what difference would it make to us now?

NHS and medical staff throughout the world are reporting on how draining the virus has been with them having to do long hours of work and the lack of resources human and physical resources

(masks and respirators etc). Under Normal conditions our hospital struggles so how would we cope in an outbreak?

Many countries are saying we are ready but these words are not being echoed by St Helena Government, there is no strong message saying we are ready... kits only becoming available in 3-4 months is a sign that we are not ready ? No dedicated phone line to deal with these enquiries is another sign. The contact details given to the passengers on entry are the usual contact for the hospital, without being disrespectful to our receptionists currently at the hospital, these calls should not be taken by our everyday receptionists. There should be someone trained who can effectively communicate to senior staff but at the same time provide useful information to the caller.

I do not see Government leading by example or being wise about their travel.. The Tourism team heading to Berlin would be a prime example of irresponsible thinking, they are exposing themselves at a mass gathering with contacts from many different countries. Will they be isolated on their return?

It is important that we remember that the whole world is already suffering from financial losses due to the impact of the virus on the travel industry so St Helena will not be alone and our attempt to continue business has usual will by no means help the global economy when it is not even enough to sustain ourselves.

Formal Legislative Council Meeting - 28 February 2020 - Statement to the Adjournment Debate - Cllr Cyril Leo

Mr Speaker and fellow elected representatives.

Let us go back in time and focus our minds on one day in the life of St Helena

when all Saint Helenians at home and throughout the world looked to the future with unprecedented excitement and optimism. On that special April day in 2016, the St Helena Airport, a £285 million project funded by the British Government, was about to accommodate the very first Comair 737 commercial flight; it was intended to be the first of many regular Comair 737 commercial flights to St Helena. There were numerous Saint Helenians standing on the hills near the new airport. We were witnessing a momentous start of something that would bring unparalleled opportunities for social and economic development to the people of St Helena. Standing on the hill near to me were two small boys and I capture the special moment in time for them on camera giving their thumbsup. St Helena would now be able to offer all of her children a future full of opportunities and options. However, here we are four years on and air access is still to deliver on the expectation and promise; the economic benefits for the people of St Helena have yet to materialise.

We have seen how major game changing development has failed to deliver on expectation and promise for the people of St Helena in the past.

Let us now focus our attention on the present.

Once again Saint Helenians have been gifted with another unprecedented opportunity to positively transform the social and economic fabric of our community. The European Commission has provided the people of St Helena with funding for a fibre optic cable that will link St Helena to the wider world. The fibre-optic cable is expected to also bring unparalleled opportunities for social and economic development to the people of St Helena.

The European Development funding of the cable for St Helena equates to some \pounds 14.3 million. The St Helena Government has an obligation to ensure that

the people of St Helena will be the recipients of maximum benefits from the sub-sea cable. Corporate monopoly in St Helena cannot have the freedom to extract unregulated profits, from the fibre-optic cable enterprise, at the expense of the people of St Helena.

St Helena is heavily dependent on financial aid from the United Kingdom. Some four years ago DFID stopped providing capital programme funding for the island and this gradually undermined progress, largely contributed to the current serious social and economic decline and eroded confidence in the future.

We have now secured a financial aid commitment of £30 million from the United Kingdom for capital project funding. The commitment will bring some consolation to the community during these current social and economic difficulties. However, more momentum is now urgently required from SHG in the delivery of the actual project work.

Technical work is ongoing to activate construction work within the Comprehensive Development Areas at Half Tree Hollow, Bottom Woods and Bunkers Hill in particular. The Forestry section has released some 200 plots of land for Government Landlord Housing, first time housebuilders and market value plots. All of these various options for construction work will have a positive impact on the private sector. But here again, momentum is now urgently required to progress the projects and thereby energise economic activity within the community.

Capital funding has now been set aside for new sewage systems to serve Half Tree Hollow, Jamestown and Bottom Woods; ultimately, this also will mean even more construction opportunities for the private sector and economic activity within the wider community. Collectively, the development will create wide ranging employment opportunities.

Other positives include the renewable energy development that will see the installation of three powerful wind turbines at Deadwood Plain.

To inject additional financial energy into St Helena's economy we must also find ways of increasing the customer base and the tax base. Constituents who invest and risk their hard earned resources in local business ventures often complain about the limited customer base on the island. An Independent Economic Review is being carried out and its 'SH2050' progressive approach will inform Saint Helenians on the vision for the next thirty years. It is suggested that the population of St Helena should be gradually increased to double by 2050. More details on the 2050 vision will be forthcoming for public information and consultation.

Mr Speaker - there are still many obstacles to be addressed and overcome by this Council and there are many constraints that elected members have no control over. The cost of fuel within the world markets and the knock-on negative impact it has on local freight charges is one example. The high cost of living on St Helena, mainly due to the ever increasing freight costs, remains a very serious concern. SHG is currently seeking financial assistance from DFID to provide some measure of freight subsidy. The matter must be addressed by SHG and DFID with greater purpose and urgency.

As we persistently work to address the social and economic negatives impacting St Helena, let us also, as a community, be inspired and spurred on by the positives.

New tobacco control legislation

The Public Health Committee (PHC) are currently carrying out public consultation meetings on new Tobacco Control legislation the aim of which "*is to help* protect the public from the harm tobacco causes and to ensure the wellbeing of our people now and into the future."

There are two parts to the PHC's aim and I'll refer to them as 1 - to help protect the public from the harm tobacco causes, and 2 - to ensure the wellbeing of our people now and into the future.

1 – 'to help protect the public from the harm tobacco causes'. The NHS and Macmillan websites provide a wealth of information and it points out that everyone has a certain risk of developing cancer. A combination of genes, lifestyle and environment can affect this risk. For most people increasing age is the biggest risk factor for developing cancer. Doctors do not know the exact causes of cancer but there are risk factors that can increase ones chance of developing it.

The PHC are addressing smoking which is to do with people's *lifestyle* but there are a number of parts to lifestyle.

The Health directorate are again employing a dietician but that along with the Tobacco Control legislation will **NOT** *ensure the wellbeing of our people now and into the future* unless other direct factors are addressed collectively.

Main issues affecting our people are:

Income – the money we make has an effect on our health and people with higher incomes tend to be healthier than people with low incomes. People with low incomes are more likely to live in poverty, something which is very

evident on St Helena at the moment; and they face situations that can lead to poor health. If those who can only afford to buy a few cigarettes at a time and will no longer be able to do that after the new legislation comes into being it will not stop them from smoking. They will buy a packet and go without something else which can further lead to poor health. The price of healthy foods on St Helena prevents our people with low incomes from eating healthy, they have no choice and together with trying to make ends meet is extremely hard work for them.

Moreover people are being laid off work because there is no work. It is expected some parents go without proper meals so that they can feed their children. The minimum income level for determining the poverty line is just £71.50 a week but if one gets £72 a week they're above the poverty line! How can one lead healthy lifestyle on £72 a week out of which has to come food, rent, medication, spectacles (it's absolutely ridiculous that 20% customs duty is charged on spectacles which is not a luxury but a necessity for people), school uniforms for the kids to name a few. It is suggested that people buy local but local produce is expensive. One week local potatoes were £4 a gallon, the next time it went up to £5 a gallon, people tend to take advantage when things are in short supply. Our Councillors should try living on £72 a week with the expenses that low income people have to contend with and experience what it's like. The personal tax allowance of £7000 is not helpful for families with children. Since doing away with allowances for children it does not help families with two or more children. With a couple one may earn more than £7000 and is therefore taxed, whilst the spouse may not earn £7000 but the one who is taxed is not able to use the partners remaining personal allowance allowing them to have more disposal income to have a better quality of life.

This is ridiculous in these difficult times. The personal allowance has not been increased since it was introduced despite the cost of groceries continuously increasing each time the ship arrives! People are experiencing these difficulties and wondering when or if they'll ever get out of these dark times which all contribute to health issues.

Housing – people with poor living conditions have a higher risk of developing health problems. Conditions such as pests, mould, structural problems and toxins can affect our health. Social housing should be in good condition. The stress of living in poorly maintained accommodation causes health issues.

Before legislating just for tobacco a whole host of issues need to be considered collectively to achieve the aim *ensure the wellbeing of our people now and into the future* and not dealing with the complexity of the matter by piecemeal.

I refer to Connect's proposed increase in tariffs from 1 April 2020.

As a domestic user the quarterly standing charge will increase by £1.03. Secondly, the treated water per cubic meter will be increased by categorised units. Connect says 'The combined effect for most people will be less than the inflationary increase on their bill'. They also said the Minimum Income Standard will be adjusted to take into account this? The majority of people are not in receipt of benefits because they're slightly above the poverty line. Being on the poverty line and over can be just £1 and means one doesn't get the benefit, but people are trying to make ends meet and keep their heads above water. To the excessively paid management employees of Connect how you can sleep at night?

The domestic drainage charges - For those connected to a communal system its increasing by £1.80 and for emptying septic tanks a mega £7.14! Yet when they do come to empty the septic tank they use the customer's water for which the customer will pay for as well! The sewage smell when approaching the Ball Alley at Ladder Hill is at times disgusting and embarrassing (unless you're familiar with the smell near Heathrow UK). No doubt this is because it's not working properly and to top it all there are homes and restaurants nearby. It is suggested there should be a process in place for reporting complaints like this to an independent body who would monitor the number of complaints annually and impose a fine accordingly. They should not be allowed to pass the fine onto customers when tariff increases are proposed.

From experience when lodging complaints about the water - taste, smell, colour, samples are taken but no further follow up with the customer. What kind of customer service is that! Never heard of Connect carrying out customer surveys and is that not something they ought to be doing as an essential service provider? Wonder why they don't – is it because they don't want to see the reality in black and white or is it their self-worth falsely telling them otherwise.

If there is no need to increase the electricity tariff, then income they're getting must be over and above, so why can't they take some of that to offset the cost of the water rather than requesting the full subsidy required for the water. We all know that subsidy is after all tax payer's money (whether that be St Helena or the UK!) so in effect the tax payer is contributing twice.

During Exco's radio discussion at Saint FM recently, Councillor Lawson Henry said that Directors of subsidised organisations will no longer be able to pay themselves bonuses without permission from SHG – so right! That is why the Directors are so comfortable in their cushy jobs! If SHG can make that decision why can't they go a bit further and ring-fence the salaries of the Directors so that they're not increasing year on year.

Are customers getting value for money since the privatisation of these essential services? It certainly doesn't feel like it. Again it's down to the monopoly. It would be good to know from SHG if Connect has been contracted to provide the services for life or a specific number of years and if so how much long they have got. It's time SHG advertise the business for offshore investor interest to identify if it could be operated in a more cost effect way since it'll only be a matter of time before SHG will not be subsidising Connect anymore....after all they did so with the Fisheries!!







As the Canadian Maple Leaf train curved like a worm around New York's upstate lakes, my twelve hour journey to Toronto was well underway. The crisp morning shadows sat aimlessly on the 'blanket of glass'. The only disturbance being the the odd boat seen steaming along with dark pine forestry and mountains in the background.

With New York City behind me and Canada ahead of me, I felt like I was a cowgirl, riding into parts of the Wild-West. I considered the landscape in perhaps the late 1700s and how Mohawks would have roamed. The battle to preserve what was their heritage and mystical beliefs pursuing.

Thirty years ago there was an uprising between the Mohawk Community and Canadian officials over the proposals to bulldoze an ancient forest with ancient burial grounds. Bulldoze without any repatriation or governance. This ended in blood being shed. It was called the Oka Crisis.

Today, there is another uprising due to a gas pipeline initiative through the Mohawk's community. Blockades have rendered the train lines between Toronto, Montreal and Quebec redundant and rail staff are being laid off until such time the dispute is resolved. Whilst I have visited Toronto on a number of occasions, this was the first time that I meandered the many neighbourhoods. Toronto has everything that New York has (not the constant fast forward and smelly subways) and so much more for less of the price. Their wide open spaces allow for breath to be taken. I like that Canadians are polite (for the most part) and speak calmly and quietly (for the most part). I don't frequent pubs as much as I did but when I do, I do not feel intimidated like I sometimes felt in New York. I've swapped alcohol now for Chai Tea and Cranberry Juice.

Toronto has many transport systems from the Subway, to the tram to the GO Train which runs efficiently throughout the suburbs. What made me giggle one morning was seeing a chap riding his bicycle in the snow (thicker tyres) and I thought"if we had this much snow in Britain, riding a bicycle would the last thing we attempt". Life doesn't stop with adverse whether here and I understand why as opposed to Britain which doesn't yearly have these weather conditions.

Having not grown up with snow, it is always a novelty to see it. So I was ecstatic (no one would play with me so I went out on my own and sang songs from Frozen whilst I messed about) when I arrived and there was so much snow the next morning. To walk along the lakes and see the icicles hanging like frozen daggers from trees, or clothed around rocks reminded me that nature is more powerful and beautiful than anything we humans could conjure up.

The temperatures on occasions have dumped the battery from my phone within minutes and taking a photo without my gloves has sometimes been challenging, but in general, the collective temperatures have not been anywhere near where they should be. Some days have been like a spring day.

I've seen ice sculptures so brilliantly shaped, I've seen Prince's home on the Bridle Path in Forest Hills (elite) where he designed his own gate. I've seen Drake's new home in the



same area. I've picked up Rush Memorabilia and enjoyed a Rush Tribute band. I haven't seen Harry or Meghan yet and don't think I will since they are on the West Coast. I was also very fortunate to attend a Dog Rescue event with some friends. The dog meat market continues to exist in places like South Korea. Over the years, I have learnt to see animals and especially pets as all part of the universal family who have feelings just like humans. If you have a dog or cat (not a big fan of cats - bit surly), please remember to love them as unconditionally as they want to love you.

As I meandered along Queen's Quay in Downtown Toronto, I spoke with a Pike fisherman who had swapped his warm weather salmon lake fishing. I was reminded of how vast the lakes are in Canada and how 'choppy' it can get. We consider the sea to be perhaps the only band of water that can be battered by nature's great forces, but these sized lakes also can be quite unpredictable at times.

In 2001 post the 911 disaster, planes were instructed to land in a small place called Gander in Newfoundland, Canada. It has a population of ten thousand people. An airport which welcomed thirty eight planes, and six thousand, seven hundred people. There is a play called Come from Away, I had to see this play in solidarity to small communities who become giants in the world when those in need come to their shores. It was said "kindness is woven into their nature". As I sat and watched, I thought of my little home far away and how it resonated with this place called Gander. On so many occasions the island of St Helena has been a haven to the troubled / weary traveller? Called upon, I have no doubt that on a grander scale, we too would take in large numbers in their dire need. God Bless St Helena, Gander and places like such.

The Canadian Opera Company hosts free performances on a number of days every week. This ranges from all genres within the 'classical / theatrical' band. One afternoon, I stood and watched the traffic and people bustle about outside as a string quartet played (3 violins and a cello - or it might have been a double bass). Not a lot in life is free, yet, here we all were, being treated to a first class performance with not a penny spent. The music drained through my soul like a hot shower on a winter's night. I wish I had learnt to play an instrument so eloquently, there is still time.

My good friend works in the Marriage Chambers in City Hall. One Tuesday I was doing some research on my laptop when a couple came in to be married that afternoon without the second witness. I was so pleased to be that second witness. There is something truly uplifting about the union of two people. I was honoured. I was dressed in my South London sweater and jeans, that's the most casual I have ever been at a wedding.

I do however question the marriage license system in Canada and Toronto specifically. People who don't speak any English, who don't even know their spouse's surname seem to get a licence so easily. I am glad that Britain is starting to manage the immigration points system a little better. Whilst I believe the world belongs to all of us, all of the world does

not owe us a living. There are far too many people who use Britain and other countries as a cash cow. I understand how this has frustrated the various societies. In the time I have been in the UK, I have been fortunate not to have to call upon the Welfare system and I hope I never have to.

Finally, my steps take me to Montreal and Quebec City. I have lengthened my stay in Montreal as it's such a beautiful vibrant city where modern meets old French culture. I could be in France. The main language spoken here is French. I have been to the Basilica where Celine Dion was married. Stunning. Old Town Montreal is like being in Europe. Residue from Old World influence. As I spoke to Terrance, a businessman travelling to Quebec, he suggested that a lot of French people who once slated the Quebec French accent are coming to work in this part of the world as business initiatives are good. Thank goodness I have polished my "Bonjour" (hello) and 'Merci' (thank you).

Quebec City is meant to be even more charming and beautiful, albeit very very French and so this will be a challenge for me to navigate. Apparently, the people here are less forgiving of Canadians who don't speak French, I hope this isn't the same for a St Helenian who speaks zilch French.

Yesterday, as there were pink hues in the sky and the sun slipped away, I stood by the water's edge and I admired the beauty of my surroundings. The thick layers of white snow, a clock resembling the old Jamestown Clock reflecting off the icy lake, the quiet. I was so grateful at that moment for my journey. At times, I have felt sad, vulnerable, disappointment, angry etc. However, as I have gone along, I have righted my emotions with gratefulness. I have accepted my path, otherwise, I would not be standing here enjoying this beautiful scenery feeling a sense of peace that can only come through true acceptance of where we are in life.

I'm coming to the end of my book, Long Walk to Freedom, by Nelson Mandela. It's difficult to balance reading and writing and not missing the beauty of my surroundings. It's been so much food for thought as I ponder the changes on St Helena. Post Mandela's release and his subsequent negotiations with F W de Klerk, he was failed on further occasions in the pursuit for peace. So many times, fear of the majority continued to stall the process. Yet, there is a line that I love, "to make peace with an enemy, one must work with that enemy and that enemy becomes your partner". Who would have thought that on 10th May 1994, Nelson Mandela would stand as the country's first black President with the same 'enemy' as his deputy. What a statement of inclusion for all. I can only imagine what courage and trust it must have taken to provide a united front with memories of the past still in its infancy.

Like many Leaders, Nelson Mandela gave his life to a cause. Martin Luther King died for Freedom. Gandhi gave all he had to lead for change. Activists on a daily basis go to the extreme to get their point across. It's so sad that all of this must happen to change minds and hearts, to be heard and to receive compassion from our leaders.

I pray that St Helenians world-wide will find time to support change in the most positive way and that our island Government use precedence to ensure the islanders have the chance to be heard.

I want to help all I can. I want to be part of the movement for change on the island, yet I must also open my heart to the insecurities which lay within. The fears in me that I have allowed to increase over time. I must open my heart to having a periphery view, not always being right. I must known when I do not understand fully and be educated. I stand corrected. I must open my heart to change within me first before I can be the change in other things.

The Invincibles

The 2003–04 seasons were the 106th in the history of Arsenal Football Club. It began on 1 July 2003 and concluded on 30 June 2004, with competitive matches played between August and May. The club ended the Premier League campaign as champions without a single defeat – a record of 26 wins and 12 draws. Arsenal pretty much bottled it in cup competitions, whereas they were eliminated in the FA Cup and League Cup semi-finals to Manchester United and Middlesbrough respectively, and at the quarter-final stage of the UEFA Champions League to Chelsea. They ended up with 6 losses overall and only the one trophy to their name at the end of the season.

The main addition to the first team was goalkeeper Jens Lehmann for £1.5 million; striker José Antonio Reyes was later purchased in the winter transfer window. Arsenal retained their best players and successfully negotiated new contracts for captain Patrick Vieira and midfielder Robert Pires. The stability of the squad meant Arsenal were considered front-runners for the Premier League title, along with Manchester United, and Chelsea who were taken over by Russian billionaire Roman Abramovich.

In November, Arsenal beat Dynamo Kyiv by a single goal and more impressively scored five against Inter Milan at the San Siro – two results which kick-started their Champions League campaign. At the turn of the year, the team won nine league matches in a row to consolidate first position. In the first week of April, they were eliminated from the FA Cup and Champions League, but by the end of the month had secured their status as league champions, with a 2–2 draw against local rivals Tottenham Hotspur. Arsenal's top goalscorer for the third year running was Thierry Henry, who scored 39 goals in 51 games. The Frenchman was given the accolade of PFA Players' Player of the Year by his fellow peers and the FWA Footballer of the Year by football writers. Although the Arsenal team were unsuccessful in cup competitions, their dominance in the league was regarded by many commentators as a standalone achievement. They acquired the nickname "The Invincibles", much like the Preston North End team that went unbeaten in the inaugural Football League season. The club was awarded a golden replica trophy by the Premier League once the season concluded and they remained unbeaten for 49 games, setting a new record. In 2012, the Arsenal team of 2003–04 won the "Best Team" category in the Premier League 20 Seasons Awards, even though they ended with 6 losses overall and only the one trophy to their name at the end of the season.

Amazedly this team didn't kick on to dominate both domestically or in Europe; in fact Arsenal has fail to lift the Premier League title since.

As for Liverpool they fail to bounce back from that defeat by Watford as they suffered a 2-0 loss to Chelsea in the FA Cup.

Preferred bidder for fisheries announced

"Glorified exploratory fishing exercise" or "Upfront investment, collaborative approach with local commercial fishermen, breadth of experience and no requirement for ongoing annual government subsidy"

SHG announced last Friday that a South African trading company is the preferred bidder to take over from St Helena Fisheries Corporation. Operating as a co-operative it will include commercial fishermen and selected local businesses as business partners in what is intended to be known as the St Helena Fisheries Co-operative. A little confusingly SHFC will remain the short version of the name for the new organisation which will be involved with commercial fishing, marketing and supply chain activities.

The traditional local supply of fish will not involve the new SHFC as local deliveries of fish by van around the Island will only continue if a local enterprise takes on this operation as a separate and independent commercial activity. It appears the "supply chain activities" the South African trading company will be involved with is the export of fish.

Called PQ Trading STH (PQTSH) it is assumed 'PQ' stands for Participation Quota which is a commonly used abbreviation for the term in South Africa and it fits with the co-operative concept. The STH indicates St Helena and the announcement indicated the company will be registered in St Helena but will no doubt have strong links to the parent company in South Africa.

The official announcement from SHG also says the proposal from the preferred bidder is to concentrate fishing activity on the sea mounts and to put resources into exploratory fishing on Cardno seamount to get a better understanding of what fish are present there and in what numbers. This work will be done in conjunction with the SHG marine team. How this emphasis on off-shore fishing will affect the livelihoods of the majority of local on-shore fishermen is not made clear in the announcement.

The value placed by SHG in their choice of preferred bidder included what they described as the "collective involvement spanning several decades of extensive experience in the industry" which PQSTH shared with its South African business partners, international buyers and other professionals in the fishing industry. Other considerations SHG said which affected their choice was that PQSTH's proposal included upfront investment, a collaborative approach with other stakeholders in the fishing industry and that there was no requirement for an ongoing government subsidy to support PQSTH's proposed operation.

It is likely to be 3 or 4 months before a date is announced for the start of the PQSTH operation. The new regime will include "catch directives" to local fishermen. This means the types of fish required to be caught and the amounts for each type will be specified to fishermen based on customer preference. It is assumed customer preference will include the premium quality fish required to serve the export market which consisted mainly of South African restaurants and premium quality fish suppliers when the old SHFC attempted to develop this market. It is also pointed out the majority of staff in the new fish processing operation will be employed locally although it is indicated it will be lead by imported South African staff. The announcement mentions that Saints will be phased in to replace ex-pat staff whenever this is possible.

The proposal from PQSTH includes replacing the life expired freezer in the fish processing factory with one that can blast freeze to -45°C. In addition they intend to bring in two medium size freezer vessels and one ice vessel. This, it is said, will reduce the pressure on the processing factory to freeze AND process. It is also said the freezer vessels will deliver their catches to Rupert's and they will be transferred to reefers; effectively bypassing the fish processing factory which presumably is waiting with a newly equipped blast freeze facility. The role of the blast freezing facility within the fish processing factory in this arrangement is unclear.

The SHG announcement points out the volume of mature tuna at the Cardno and Bonaparte seamounts remain undefined and "cannot be regarded as guaranteed to deliver the required volume to a potential investor or vessel owner." For this reason PQSTH will be monitoring the tuna and bait resources at the two seamounts over a two year period. It will only be after the results of this monitoring have been assessed that a decision will be made on what type and size of fish processing factory should be built. In view of the fact that the volume of fish available cannot yet be guaranteed as viable for a potential investor or vessel owner the future of fish processing in St Helena is called into question and opens up the possibility that no new factory will be built and the present life-expired factory will be permanently closed or its operations significantly reduced. Despite these unknowns the SHG announcement maintains that PQSTH is "investing to build a profitable and sustainable fishing industry on St Helena". It also raises the question; will the blast freezer ever be built in the current or new fish processing factory?

The St Helena Commercial Fishermen's Association (SHCFA) issued a statement after the SHG announcement was published which included, "The proposal which Executive Council has endorsed is high risk for St Helena and by far and large is initially going to be a glorified exploratory fishing exercise. The press release clearly states that the company PQTSH "will undertake a 2 year due diligence exercise in order to verify tuna and bait resources over the seamounts because these resources are undefined and unknown and cannot be guaranteed to deliver the required volume to a potential investor or vessel owner". In other words, these investors are not yet sure as to whether their proposal will even be viable, and therefore there can be no guarantee that they will remain past the 2 year due diligence exercise."

After pointing out that last Friday's SHG announcement was the first official information published on what will take over from the old SHFC the SHCFA statement included, "It is therefore the first time that we could also confirm that in order for this proposal to be a genuine success for the island from our perspective, it will of course require buy-in from local fishers. Yet so far, we have been given no date or plan for when consultation with fishermen, as *key stakeholders*, will take place.

If no or few local fishermen join this co-operative, it will quite frankly be nothing more than a foreign fishing operation, backed by SHG, competing with the private sector."

The lengthy SHCFA statement adds, "The press release provides very little other information beyond what the SHCFA already knows and as a consequence, we will be submitting a list of questions to SHG during this coming week. These questions will need to be answered with some urgency because if this proposal does come to fruition; it will bring major changes to the local fishing sector whether we choose to join the co-op or not, therefore we will need to prepare with some urgency for every eventuality."



There is an 'exit strategy' to end subsidies for the Mantis Hotel But where is the door?

Councillors Derek Thomas and Lawson Henry, along with Financial Secretary Dax Richards volunteered to go to the Saint FM studio to face questions about the additional £500,000 taken from SHG reserves to keep the Mantis Hotel open. Dax Richards pointed out the money was used to pay for unscheduled extra costs at the time the former government offices were converted into the hotel with the extension built at the back. Two years after the bill for the extra costs was presented the payment became due and since no other financial institution was willing to step forward the only option was to raid the government coffers.

The two councillors, to cut what they said to just a few words, told Saint FM listeners to look on the bright side. The hotel was being managed at less cost now after further cost-cutting measures were put in place and, come next April, the operating subsidy for the next financial year will only be £200,000. They also claimed there is now an exit strategy for unburdening both the state and the taxpayers from the current shortfall between costs and revenue. The exit strategy relies on more people using the hotel. What else could it be? In fact, enough additional hotel guests are required to make the hotel a going concern and a reasonable prospect for a commercial investor. Hanging on until this happens was described as 'protecting the investment' but how long the investment (or white elephant) will need 'protecting' was not discussed in too much depth. In the meantime the protected investment is propped up with hundreds of thousands more pounds sterling from public funds and gap widens between what the whole project costs and the money the hotel can eventually be sold for.

Back in November SHG issued a press release which made it very clear, enough is enough; propping up state owned entities which always make big losses had to stop. The press release said, "The SHFC's business model has been broken for some time but masked by SHG paying out ever growing levels of subsidy to the fishing sector on an annual basis. This is money SHG can no longer afford. The fish factory has not made any profit for several years; it continues to build up ever-increasing losses, in the forlorn hope that it just might earn some cash from overseas sales to pay back the hundreds of thousands of pounds that have been sunk into the venture." The radio discussion on the continuing cost of keeping the Mantis Hotel open did not include what business model is being employed to get the exit strategy actually moving towards the exit. It is however certainly true that a different approach is being taken with the hotel compared to the fisheries despite it not being known for how long six figure sums will need to be paid out every year because of what Paul O'Sullivan describes as the footfall is not falling at the entrance to the Mantis Hotel.

SHG will very likely find the exit door about the same time Paul O'Sullivan decides to make his entrance into the St Helena luxury holiday home market. At the moment O'Sullivan is getting the preparatory work completed. He too has spent a few hundred thousand pounds on the preparation but subject to his plans succeeding in getting development permission nothing else will happen until there are clear signs the first phase of his holiday home development at Horse Pasture will be a commercial success. He will attempt to help make this happen with his proposal for a direct air service between Europe and St Helena. But for O'Sullivan too, none of this is going to happen this year and maybe not next year ether.

At the moment there are no clear signs that any tourism related development will be a commercial success. The number of arrivals which are classified as non-Saint tourist / leisure increased by just 1% in 2019 compared with 2018. It appears some of these arrivals stayed longer in 2019 because the number of bed nights for the busier part of the year shows a bigger increase. But still, the numbers fall far short of supporting a significant investment in St Helena tourism. The strategy is going to be a long drawn out affair and the exit door is a long way off.


