Saturday is the day for the Carpe Diem crew

At 12 noon tomorrow Bishop Dale Bowers and Father David Musgrave will be at the landing steps to officiate at a short ceremony to bless the yacht and its crew and wish them God's speed and safe passage. At about 1pm James Herne together with his son Josh as assistant skipper and the volunteer all Saint crew will sail for Cape Town and the Royal Cape Yacht Club. The Royal Cape is organising this year's Cape to St Helena Race where the prize for the yacht that takes line honours is the Governor's Cup.

Sixteen yachts are registered for Cape to St Helena Race starting on 26th December. Race rules allow fifteen days for yachts to finish the race. A series of events is scheduled for race entrants and their families and friends after they cross the finishing line and step onto dry land. Starting on 7th January through to 15th January there are tours, a football match with BBQ, a fish-fry at the St Helena Yacht Club, a night at Wicked Wahoo and another at Anne's Place. A presentation at Plantation House will take place on Friday 11th January.

The Herne's are overwhelmed with the generosity of individuals and some corporate donors. Individual donations have reached four figures but the number of people calling at the Yacht Club or seeing the Herne's in the street and making a cash donation there and then has been more than heart warming for St Helena's sea-faring family.

At the last meeting of SHG's Economic Development Committee the "opening of the yacht club by a local family has

occurred and the Cup Race" was listed as a notable event which supported the Sustainable Economic Development Plan. Despite this, the total amount of sponsorship attracted to fund the Carpe Diem entry for the Cape to St Helena Race fell short of the target. To make the money go further the existing sails were repaired and strengthened but it would be unwise to start the race without a spare set of sails. New sails will be bought from the Herne family budget when the Carpe Diem team arrives in Cape Town.

What are they talking about?

The reports from Government Committees during November covered the Economic Development Committee which met on the 1st, the Public Health Committee on the 7th, followed by the Social and Community Development Committee on the 14th and then the Environment and Natural Resources Committee which met on 15th November. In contrast, there were six government press releases issued covering just police training from a total of 14 press releases involving the police service in some way or other.

The **Economic Development Committee** heard an update from Enterprise St Helena and then listened to progress so far with the Sustainable Economic Development Plan. Listed among the progress items was the refurbishment of the toilets near the museum and litter picking sessions. Two initiatives driven by the Education Committee were included in the list of progress items and some other initiatives were from the private sector. A list of economic development initiatives driven by the Economic Development Committee would be of interest for the December end-of-year meeting.

At the **Public Health Committee**, members heard the people are here to install the new patient electronic record system and a new radiographer is in place. A revision to the three year strategic plan is underway. When the councillors and government officers have agreed the various parts of it, they will let us know what the health plan is going to be. Tobacco legislation will be reviewed soon.

The **Community and Social Development Committee** seems to be finding development of Freedom of Information (Fol) legislation next to impossible. Already reduced to an 'Information Bill' the intent of government officers appears to be to making Fol in St Helena a shadow of what was originally

envisaged, with no resistance from councillors. Legal advice to councillors at November's meeting was along the lines that the European Union has introduced some additional regulations fairly recently which may apply to Overseas Territories. The official line is that for this reason councillors agreed consultation on the Information Bill should be halted while further "assessments" are made.

A new Immigration Bill should be ready for public consultation early next year and work on new social security legislation appears to be plodding on.

The **Environment and Natural Resources Committee** were told fifty-one applications for funding had been received for a share of the limited pot of money in the Community and District Roads Fund. The response is not surprising considering the continued degradation of all roads and tracks. Because of the unsurprisingly high number of applications, decisions on who will get what has been put back to an unspecified later date. It will be remembered this fund offers a maximum of £2,500 to tax and duty payers for DIY plans to improve their own local roads.

A report concluded there are up to 50 unwelcome terrestrial and marine species which may colonise St Helena territory over the next 10 years; 20 of them are prioritised as a greater risk. Biosecurity will use this list and the associated information and advice in an effort to keep this 'caravan of unwanted immigrants' away from our borders.

The Draft Building Regulations continues on its slow course towards the statute book and approval has been given for a new 'pilot' Government Landlord House to be built at Half Tree Hollow – subject, it is assumed, to planning permission.

Is it Time to Change Tourism Strategy?

OPINION: After reading the facts why flights to the Island are often cancelled or delayed due to our weather conditions and the fairly limited options we have to do something about it might be time to look at a new tourism strategy and market. (See pages 5-7)

All promotional efforts so far have been directed towards short stay tourism, with guests staying on the Island for maybe a week or two. Some early figures suggested that we should get about 30,000 of these tourists per year in a few years, time. Most of us just brush these figures away as unfounded fantasies but we actually need tourists on the Island to have any chance of improving our economy. With each delayed or cancelled flight we losing credibility in this tourism market. The short stay tourists are ones most vulnerable to flight delays. Just a few days delay and their holiday is ruined.

I would like to suggest that we start looking at a completely different type of market - the residential tourism market. The northern part of the world like Scandinavia, partly UK and northern North America have horrible weather in the winter, it is cold and dark. People who can afford it and have the opportunity would be interested in spending maybe three or six months in a nice house in the southern hemisphere where there is summer. Apart from retired people there are many business owners who actually can run their business perfectly well from a place like St Helena and could enjoy sunshine instead of snow-drift. Under St Helena's circumstances as these tourists would not be discouraged if the flight is a few days late or even cancelled for a week as it would have very little impact on their long term stay.

I know that SHELCO sought to sell some chalets for this purpose but there are many places on the Island suitable to maybe build small condominiums or groups of houses for this purpose. These can be in several price categories and sizes. There is definitely a market for this of tourism. The people

coming will spend money in shops, restaurants, bars and other facilities. The drawback is obviously that they do not sleep in hotels or self-catering accommodation but, even if it looks gloomy at the moment, some short stay tourists will still find their way to the Island to utilise the tourism beds.

St Helena will lend itself to the residential tourism market as our weather is warm, but not hot, in the summer, our culture is European, we speak English, it is safe and the food is not that far off from European. This could be an attractive market for us in the future. Still, we have some infrastructure issues to sort out, the first one is telecommunication. With the speed and price of internet communication on the Island it would be difficult to attract many tourists. They need to have efficient contact with their businesses, families and friends overseas. It is not likely that this improvement can be achieved without the possibilities the fibre-optic cable can give us. Another needed infrastructure improvement is the banking facilities on the Island. Paying 5% or more to get money on a Visa card is not acceptable if we want people to come to the Island, especially as you get currency which you cannot use anywhere else.

I think it is worthwhile to further explore this type of tourism and it would be highly profitable for the Island.



Editorial

It's been a few weeks since I wrote anything on this page and maybe getting back into the usual routine helps to give the impression of a sense of security. A sense of security is something I probably need and I know I will not get it next time I have to fly into Johannesburg to get the St Helena plane the following morning. Why is it my one night stay in Johannesburg turns into a week? It's happened twice now and it is not just bad for me it's grievously injurious for the whole Island. The future for St Helena is fragile; it will take some inspirational thinking to work a way out of the sticky mess we find ourselves in and have been put in.

One year on from the start of scheduled air services and the firm economic foundation expected from the air service show little sign of materialising; it increasingly shows it will be a long time before it delivers anything of true worth. This is undeniable and the truth of it stands out in what was listed as progress so far in implementing the Sustainable Economic Development Plan at the last Economic Development Committee meeting.

Here are some of the examples of economic progress from that list:-

The buy local, supply local campaign is going strong – but not one word about whether the campaign is getting results. In tourism there is a new public relations firm appointed, advertises for the Festival of Running and inclusion on the short list

for Dive Awards – stretch your imagination to find progress in economic development from any of that.

The museum toilets refurbished and a litter campaign undertaken – this shows a real sign of desperation for some poor government soul trying to be positive.

The private sector has exported fish and locally made jewellery – the Fisheries Corporation is not in the private sector and there is still no publicly announced progress in attempts to place it at least halfway into the private sector.

Kind words were written about the St Helena Community College and hopes expressed for the proposed St Helena Research Institute – a good education system is a foundation stone for a thriving economy but it does not guarantee the best educated will stick around in St Helena if real signs of economic growth are not visible and tangible. The Facts About Delayed Flights

During this winter and spring we have seen numerous delays and cancellations of the SA Airlink weekly flights from Johannesburg. This has caused tremendous frustration among passengers and the St Helena public. Many have experienced days of uncertain waiting for flight confirmation or the ordeal of spending thousands of pounds extra to rebook their tickets to complete their journeys. This is affecting not only the Saint community here and overseas but also our fledgling tourism industry. Only last week we had a mass cancellation on the flight arriving last Friday. After the plane was cancelled on Saturday 17th November, a new attempt was made on Tuesday 20th November. 80 passengers were counted on the flight leaving Johannesburg last Tuesday. This plane had to turn back to Johannesburg from Windhoek as the weather conditions over St Helena had deteriorated to such an extent that a landing was unlikely. When the flight finally arrived last Friday only 49 people were onboard, the other 31 had returned home without ever reaching the Island. This is disastrous for the Island and its future.

We also have issues with communication of flight related issues and it appears that SA Airlink still has some major issues to sort out when it comes to dealing with stranded passengers in Johannesburg.

This article will deal with the reasons for the delays, the possibilities to remedy the problem and the reality facing the St Helena Airport operations. We have spent considerable time to find out the facts and options for a reliable and viable air service to St Helena.

St Helena Airport has on their website an excellent article about the problems we have but maybe it has maybe not been given the publicity it deserves. Therefore we have decided to publish their article alongside ours.

There seem to be a perception, especially on social media, that this problem can be easily sorted by instrument landing systems or other technical gadgets and it is due to incompetence or ignorance by people involved in St Helena air access we have these cancellations and delays. This is far from the truth.

There is no doubt that St Helena is one of the trickiest places in the world to build an airport. One being its remoteness, with the only possible land based flights coming from about 2,000nm away, and secondly its mountainous terrain and lack of possible diversion airports in the close proximity - Ascension is 700nm away.

The main problem for the St Helena Airport is the frequent low cloud base. This is especially prevalent in the winter but can occur at any time of the year. The high mountains surrounding the runway to the west, east and south of the airport makes a landing, even under good weather conditions, into a challenge. However, the airport has been deemed safe by the airport regulator, Air Safety Support International (ASSI), which is the body regulating all airports in the British Overseas Territories. They are the body telling us what we can do and what we cannot do when it comes to the Airport and aviation in St Helena.

St Helena Airport is featuring the article below on their website. We are republishing it to give it a wider audience which it deserves. It is consistent with our artice but has slightly different emphasis

Weather-related delays at St Helena Airport

Weather-related delays

Weather-related delays at airports are an inconvenient yet inevitable fact of life. The vast majority of airports around the world will suffer from weather-related delays from time to time. Airports located on islands tend to be more regularly affected by inclement weather than those on the mainland due to their isolated location. St Helena Airport is no different.

Due to the predominantly south-easterly wind direction and absence of any land between the Island and the African mainland, St Helena Island suffers from inclement weather more often, and is therefore susceptible to more delays to air travel. This page gives a brief explanation of how weather can affect flights to and from St Helena.

Location

St Helena is located in the middle of the South Atlantic Ocean. The nearest significant landmass is western Africa, some 1200 miles to the east. The nearest alternate airfield to St Helena is on Ascension Island, 700 miles to the north. Due to the predominantly south-easterly wind direction, this means that cold weather fronts and air masses can travel thousands of uninterrupted miles across the ocean before they reach St Helena.

Elevation

St Helena Airport is located about 1000ft above sea level. This means that it is more susceptible to low cloud bases. For example, London Heathrow is 83ft above sea level, meaning that a cloud base at 1000ft would give 917ft of visibility below it; the same cloud base at St Helena would be below the runway – a whiteout at the Airport!

The weather patterns at St Helena are such that low cloud is a common occurrence due to the lack of intervening land or high ground between the African coastline and the Island, and the elevation of the Airport.

Topography

Many airports are located on large flat areas, devoid of high terrain or surrounded by large areas of water. St Helena Airport has high terrain immediately to the north, south and west of its location, and is surrounded by water on three sides. This environment creates natural hazards that need to be managed in order to ensure flights operate as safely as possible. As such, aircraft due to arrive at St Helena Airport will not despatch until it is certain the weather conditions are such that these natural hazards are clearly visible to the pilots as they approach the Airport.

Navigation aids and instrument landing procedures

Many airports, including St Helena, have various navigation aids and landing systems installed to aid pilots to find them

ASSI has approved St Helena Airport as a Class III airport with Visual Approach Rules only. Due to surrounding terrain, the rules for visual approach are very strict with a requirement of a cloud base of no lower than 900ft, this is if it is scattered clouds. If only 1/3 of sky is open then it will be 1500ft and a visibility of no less than 5,000 metres. Forecasting these conditions for a window of 4.5 hours at least six hours in advance is not an easy task and on most occasions where we have had delays the conditions for landing could not have been met upon arrival of the plane.

The consequences of not being able to land when the plane arrives are severe. Before the plane descend for landing at St Helena the pilot could decide to continue the flight to Ascension. It is highly unlikely that this would be a very popular option. What do you do with maybe 80 un-announced visitors on Ascension? They will have to stay on Ascension over night as the crew's permitted daily flight hours would have expired and the plane has to wait until the next day.

If the pilot decides to make an attempt to descend to St Helena but fails to land due to low clouds the prospects are even worse. He will not have enough fuel to ascend again to continue to Ascension but after circling and waiting for the clouds to lift for about two hours or so, the only option is to land in James' Bay with consequences we really do not want to talk about.

What we need to change the current situation is a reliable instrument landing system which can be approved by the regulator, ASSI.

Already in the feasibility study for the airport in 2005, the consultants, Atkins, wrote in their main report that "Without an instrument approach the provision of a viable air service is not possible". This was seven years before we started building the airport. They also said that "An approach would only offer a descent through cloud to a minimum height of some 600ft above aerodrome level and this might not result in an acceptable runway utilisation". Now we know that ASSI only approved a minimum cloud height of 900ft, this makes matters even worse.

In 2005 Atkins also said that "The correct alignment and location of the runway are critical in achieving an instrument approach that would give the required minimum descent height. This in turn limits the scope for selecting the optimum engineering solution for construction".

Most airports in world have some type of instrument landing system to assist the pilots landing during bad weather conditions over the runway. The most common system is simply called Instrument Landing System or ILS. There are three main categories of ILS, Cat I, II and III. The easiest one to achieve is CAT I, which would allow the plane to land when the cloud base is as low as 200ft (60mtrs). If this could be installed it would be a great help to airport operations.

An ILS system operates with a localizer which is telling the pilot the right horizontal approach to the runway and on glide-path indication, which gives the pilot the vertical approach angle.

and land safely. Some rely on ground-based equipment to emit signals which are then picked-up and processed by airborne aircraft; others rely on satellites and Global Positioning Systems (GPSs) to ensure aircraft can be accurately located in the air and guided safely to the ground.

Airports also publish procedures that advise pilots how to navigate and land safely – these are called Instrument Flight Procedures (IFPs). St Helena Airport uses a combination of navigation aids and IFPs to assist pilots, but fundamentally, pilots on final approach to the Airport need to see the runway well in advance of the wheels touching the ground.

The Airport's Regulator has set a minimum height of around 900ft above the Airport's elevation at which the pilot must be able to see the runway before they can make an attempt to land. That means that the cloud base needs to be around 1900ft above sea level (1000ft airport elevation + 900ft minimum height) to allow the pilot to see the runway. Given the low cloud bases experienced in St Helena, this can cause delays and cancellations to flights because the cloud base is forecasted to be too low (less than 1900ft above sea level) to see the runway.


Visibilities need to be 4000 metres or more for a pilot to visually land on the airfield. This means that periods of drizzle, rain showers, fog and fog patches may reduce visibilities to values below this minimum operating threshold, and in fog, the visibility may be just a few hundred metres at times.

The Weather Window

Given the isolated location of the Island, it is essential that any flight coming to the Island can arrive and depart safely. Also, given that St Helena Airport is daylight-operations only, aircraft arriving and departing on the same day need assurance that they can do so. Furthermore, should a departure need to divert back due to an emergency, the weather needs to be within the operators despatch criteria, permitting the aircraft to return to the Island.

So in all, about 4½ hours of satisfactory weather is required to ensure safe air operations to and from St Helena. This is known as the weather window.

The diagram below shows the typical weather window required for the weekly scheduled flight from South Africa. This shows that the weather window starts just after the point of no return for the flight to the Island from Windhoek, continues through the arrival, turnaround and departure at St Helena Airport, and then finishes just at the point of no return for the flight back to Johannesburg. The "point of no return" is the point at which the aircraft has gone too far to be able to turn back to the airport it has just come from; in other words, the point at which the destination (or alternate) airport is nearer to the aircraft than the departure airport.



An advanced ILS Cat-III could allow a plane to land in more or less any visibility conditions.

Unfortunately, due to the mountainous terrain in St Helena ILS cannot be certified for use on the Island. We do have a Localizer system on St Helena that is installed at an offset of 5 deg. This brings or assist the pilot with the approach at a 5 degree angle. This makes sure that he stays away from the Barn. Once he crosses the runway centreline he turns and lines up with the runway to make the visual landing. The biggest obstacle in the approach on runway 20 (from the north) is the Barn which is only a few degrees west of the plane's approach path. To use ILS ASSI would not allow any major obstacle closer than 35 degrees from the planes approach measured from the southern end of the airport. The runway alignment is far from being within the limits for the use of ILS. The reasons for these limits are several. Firstly, you do not want the plane to collide with the Barn, but also the huge obstacle the Barn represents can interrupt and distort the radio signals from the ground to the plane and mislead the instruments onboard the plane and thereby the pilot. This could obviously be detrimental for passengers and crew.



Recent months we have heard a lot about an approach/landing aid based on GPS signals called GBAS (Ground Based Augmentation System). The technical risk of implementing GBAS has delayed widespread acceptance of the technology as they have to "mitigate the impact of satellite signal deformation, ionosphere differential error, ephemeris error, and multipath." In simple terms it means that there is a risk that the satellite signal can drop out or be distorted during the approach of the plane, this is a particularly big risk over St Helena as the satellite coverage is very limited. St Helena Airport has a GBAS system installed, which could be used in bad weather conditions but, again the regulator ASSI, has decided not to approve its use. The Airport is currently been assisted by Air services Australia to get the GBAS approved. There is still a study that must take place on the effect / impact of the ionosphere on the reliability of the satellites. The study were done previously with only one base station recording data. This is not accurate enough and will be done with 3 -4 Base stations in the near future.

We know that this article is quite disappointing reading but it is the truth. As it stands at this moment instrument landing systems are not approved at St Helena Airport and we have to live with the weather problems we have.

Blowing up the Barn is not a viable solution and at this stage

Why doesn't St Helena Airport have a conventional Instrument Landing System?

Whilst St Helena has landing systems to aid pilots, it does not have a conventional array Instrument Landing System (ILS). This is a system that is located at one end of the runway and emits a beam down the runway and head-on to aircraft on final approach; the beam is then used to inform the pilot of the adjustments needed to stay on the ideal glide slope. So it will tell the pilot when they are too high or too low, and whether they are too far left or right of the beam. The pilot can then make adjustments to their flight path to stay on course. In theory such a system would be beneficial to St Helena Airport – it would allow a lower minimum height at which the pilot needs to see the runway, and it would aid the guidance of aircraft down onto the ideal approach path. But given the aforementioned high terrain that is in the immediate vicinity of the Airport, the margin of safety is likely to be too small to permit the installation of an ILS i.e. a deviation of even one or two degrees from the beam would bring the aircraft too close to high terrain. That high terrain can also interrupt the emitted beam meaning it cannot be picked up by the approaching aircraft.

However, St Helena Airport Ltd in conjunction with St Helena Government and other stakeholders continue to evaluate various options in order to reduce weather-related delays. It is important to ensure that any additional aids installed at St Helena Airport are 100% accurate and 100% reliable, and as such work is ongoing to determine the best way forward.

change of the approach and runway alignment is not really feasible either.

We know that there is activity to find some kind of solution in the future but it might not be in the near future.

Conclusion

Without the success of the trials with multiple GBAS ground stations to enable landing in St Helena under cloudy conditions there is not much hope that the St Helena Airport will be viable, at least not using the current blueprint for tourism development.

It is astonishing that the people from DfID originally taking the lead of the airport project spent all their efforts into building an airstrip at as low cost as possible without having much thought about the viability of operating it. We can see that Atkins had grave concerns over building an airport without instrument landing systems in place but still the airport was built with an alignment which made it close to impossible to use technology available.

I guess that it did not make it any easier when environmentalists stopped the use of the Central Basin on Prosperous Bay Plane for runway construction. This severely limited the options for a viable runway alignment. Now we have to pay for all these mistakes in the past.

Walter should have been present but due to the cancelled flights he had to return home from Johannesburg without being able to attend the ceremony and read out his prepared speech.

From Mr Walter Barshai:

I'd like to welcome everybody to the presentation, and very sorry that I could not be present myself, due to the unforeseen circumstances with the flights.

I believe in fate. Saul Solomon did not come to St Helena on his free will, yet, he came here not against his will. Some of your ancestors came here on their own free will, some were brought here against it, yet, you're all here now on your free will, you're here out of love for the island, because of your believe in the future of St Helena; same as Saul Solomon did for the rest of his life, after arriving here, and being stranded in anticipation to die. He also stayed out of his love for the island, and even after his death while on a trip to England, his body was smuggled back by his daughter. I tend to believe, after reading about his life, that this was his dying wish, to be buried here. I believe in fate, and I believe in love at first sight, and I share this with you, with Saul Solomon, this love and appreciation of what St Helena has to offer.

Please let me read you a page below...

About the year 1796 a young Jew aged twenty landed at St. Helena from an East India Company ship. He was ill and supposed to be dying, but he rallied and eventually opened a business in the island where he was joined a few years later by his brother Joseph. These two young Jews, Saul and Joseph Solomon, established a business which remains at St. Helena to this day.

In 1806 Saul Solomon received a Hebrew Prayer Book by a store-ship from his dear mother. It is from this prayer-book that the date of Saul's birth – 1776 is taken.

All we know of their mother is that her name was Phoebe de Metz (1745-1834), the wife of Nathaniel Solomon, she was married at the age of 14, she lived in much competency in London, and to her care were sent two little grandsons (Henry & Saul) from St. Helena.


The business at St. Helena prospered in many ways due to the introduction to St. Helena of Napoleon after Waterloo, and to its being a port of call for the East India Company's ships both going to and returning from India. In later years Saul Solomon was known as the "Merchant King of St Helena".

During Saul's business career, ships increased from about 150 to over a thousand a year, St. Helena became a haven for American whalers and a base for the Royal Navy's anti-slavery squadron, with a Vice-Admiralty Court condemning slavers and unseaworthy vessels to the benefit of Jamestown's ship chandlers.

The historical book

In Memory of Saul Solomon

Solomon had funds for speculation when it mattered, which perhaps explains partners such as Dickson and Taylor, George Janisch of Teutonic Hall, and Robert Morrison, who had the fact inscribed on his grave in 1865. (Daniel Hamilton's memorial in 1867 also records service to the Company). But when calamity fell, like the collapse of the St. Helena Whale Fishery Co., it was rivals, Thomas Baker, John Scott and others, who lost, not Solomon, Gideon or Moss. Ironically, forty years later his successors ignored, or were ignorant of, this experience and made a disastrous investment in the Island whaler, Elizabeth. If Saul speculated unwisely, it has yet to be discovered. At the watershed of St. Helena history - the Island's transfer from the Company to the Crown in 1836 - he was again among the winners, as old Company-landed families sold out at great loss, while merchants took their pickings and prospered.

Saul was no less skillful in climbing the social ladder as the Napoleonic era receded. Despite being 'in trade', which normally put one beyond the pale of polite society, he and his partners were invited to sit with 'gentlemen' on various committees - Benefit, Benevolent, Fire and those of other social welfare societies. Solomon, Gideon and Moss virtually ran the Annuity Fund Committee. Indicators abound of rising social status. In 1823 Saul's daughter Phoebe married Capt. T.M. Hunter of the St. Helena Artillery; in 1838 his son Henry (1806-1847) became Colonial Surgeon and Health Officer, whose widow married Governor Sir Patrick Ross; they were leading Freemasons, churchwardens and JPs. For 50 years they almost monopolized the prestigious post of Sheriff ("no salary") through Saul Solomon (1839-42, 1846-50), Lewis Gideon [who changed his name from Solomon] (1842-4, 1852-6), Nathaniel Solomon (1850-52, 1859-60), George Moss (1870-80) and Saul Solomon, jun. (1880-88).

From notes by Mary Brown, daughter of Henry Solomon (1816-1900) born in St Helena.

In short, during the founder's lifetime, Solomon & Co. became pillars of the Establishment and of the Church, to be symbolized finally by Humfrey Welby Solomon (1877-1960), grandson of Bishop Welby, Churchwarden and Member of Council (from 1898), commercial and social Island Supremo - "King Sol". His death on 30 October 1960 at 83 ended the Solomon dynasty at St. Helena, and in 1974 the firm, dominating Island production and commerce, was 'nationalized' by the St. Helena Government.

I'm in touch with Saul Solomon's descendants in Cape Town and Johannesburg and received their approval of the likeness of the painting I'm presenting to you today. I also obtained a book "The Solomons" by Saul's descendant, Richard Allen Solomon, who spent 25 years writing this book; I would also like to present a copy of the book to you, it is being sent to St Helena, and will arrive shortly. Saul Solomon was loved by the people of St Helena, for his kindness and charitable nature. He was presented with a walking stick with a golden top by the people, with a simple inscription: "To Saul Solomon from the people of St Helena." This stick is with his descendant, Richard Solomon, in Johannesburg.

I'm very proud and humbled to be able to contribute something to the company that great Saul Solomon founded so

long ago, and it is through his vision, Solomon & Company still dominates and impacts everybody's life on St Helena. Without this man, the island would not be as we know it today.

Thank you, again, for the opportunity to present this painting to your esteemed establishment.

Sugar and Slavery

Way back in the 1960's that lovely sweet stuff called sugar enjoyed a far easier time than it does today. 'Just a spoonful of sugar helps the medicine go down' was a famous song from the musical Mary Poppins. Everybody agreed. A now long forgotten pop group, The Archies, had a hit with a song called *Sugar Sugar*. The chorus went like this: 'Sugar, ah honey honey, you are my candy girl, and you've got me wanting you'. That sweet girl of the 1960's would be seen my many as positively poisonous today.

In addition to the bad reputation sugar has today for everybody's health there is a darker side to this oh-so-sweet food additive. Sugar production was a main reason for the expansion of the Atlantic slave trade in the 16th, 17th and 18th centuries. One million Africans were taken to Barbados and Jamaica alone to work on sugar plantations between 1701 and 1810. At that time sugar was produced on most Caribbean islands, meaning the total number of slaves taken in chains to the Caribbean sugar plantations is estimated to have been around 9 million; 2 million more died during the journey.

Slavery was the main reason for the expansion of sugar production and the reason why it is now all too common in the food we eat today. Between 1650 and 1800 each man, woman and child in Western Europe increased their consumption of sugar by a stupendous twenty-five times. Most of the rest of the world increased their daily intake soon after. As one history on sugar and slavery describes it, "The labour of enslaved Africans was integral to the cultivation of the cane and the production of sugar. Slaves toiled in the fields and the boiling houses, supplying the huge amounts of labour that sugar required."

Many will argue there is different type of 'slavery' today where food manufacturers are happy to get us all hooked on sugar.

Today sugar satisfies the sweet tooth we have inherited from past generations when sugar and slavery went hand-in-hand. For food manufacturers sugar lengthens the shelf life of a wide range of foods. Supposedly healthy foods such as yoghurt, granola bars and fruit flavoured water are often pumped up with sugar. The shelf life of bread, breakfast cereal and tinned foods are extended in the very same way. There can be as much sugar as anyone's body ever needs in one day in just one pizza. Any sugar consumed which is more than the body needs is converted by the body to fat and most of that fat is stored around the body.

Maybe those slaves in the Caribbean who lived a miserable existence over three centuries are now getting their own back? The result of their sweat, blood, misery and deaths means for us an increased chance of liver and heart disease, weight gain and no teeth if we consume too much of what they toiled away at producing.

The only live Football I saw last weekend was the Spurs V Chelsea match. Spurs performance was possibly the performance of the weekend and in their player 'Son' he put in the best individual performance.

Pochettino's men produced a terrific performance to move above Chelsea in the table to third, five points behind unbeaten leaders Manchester City, while their opponents drop to fourth. Spurs deservedly scored two goals in the first 16 minutes through midfielder Dele Alli's flicked header from Christian Eriksen's cross, and Harry Kane firing in a drive from long range.

Son Heung-min had struck straight at goalkeeper Kepa Arrizabalaga when through on goal and had a volley pushed away before scoring a brilliant goal in the second half.

The South Korea forward picked the ball up on the halfway line, outpaced Jorginho and darted past David Luiz before coolly rolling the ball into the net. Son Heung-min's strike was his 50th goal for Tottenham in 154 appearances for the club.

Although Man City's manager said his team was quite lucky and nowhere near their best; they did put 4 goals past West Ham. The game was over by half time after Silva; Sterling and Kane had scored, so they could be forgiven to have ease off in the second half. This is City's 8th consecutive win and they remain 2 points clear at the top.

Liverpool's unbeaten run continues as they beat Watford 3-0. It was quite a frustrating game for the Reds. But once Salah scored in the 67th minute there was only going to be one winner.

Alexander-Arnold scored a spectacular free kick to put Liverpool 2 nil up and despite Henderson being shown a red card with 8 minutes left Firmino scored in the last minute to complete a satisfying afternoon for Liverpool fans.

Whilst Liverpool fans are satisfied with their teams' performance this season the same can't be said about Manchester United fans as they had to indulge another frustrating afternoon of Football. Manager Jose Mourinho has accused his players of not showing "enough heart" after they limped to a goalless draw at home to Crystal Palace. Romelu Lukaku had an attempt ruled out for offside and another kept out by Wayne Hennessey, who also produced smart saves to deny Jesse Lingard.

But Palace, without a win in their previous seven league games and one point above the bottom three, created several chances as they tried to secure a first league win at Old Trafford since 1989.

Patrick van Aanholt twice went close, Andros Townsend blazed wide and a header by Cheikhou Kouyate was also disallowed for offside.

In other matches on Saturday Fulham came from a goal down to beat fellow strugglers Southampton 3-2; Everton beat Cardiff 1-0 and Leicester who was reduced to 10 men after just 28 minutes scored a later equaliser to draw 1-1 with Brighton.

Arsenal faced a tricky match away at Bournemouth by manage to extend their unbeaten run of 17 games in all competitions as they recorded a 2-1 win. Lerma's own goal and Aubameyang's eighth strike of the season secured their fourth Premier League away win of the campaign - equalling their tally for the whole of last season - and moved them to within

one point of the top four.



EXCO REPORT – TUESDAY 27 NOVEMBER 2018

Executive Council met today with two items on the open agenda. The first item concerned the draft Primary and Secondary Legislative Programmes. Council was asked to advise whether these Programmes should be approved for publication and to identify what further prioritisation of the legislation identified as a top priority, should be considered. In discussing this item, members were mindful of the capacity constraints within the Attorney General's Chambers and were keen to emphasise that any prioritisation of the programmes should also be capable of being delivered within a reasonable timeframe. Members agreed that the programmes should be published and that the items on the programme should be prioritised by the appropriate Council Committees.

Council then went on to consider a request to increase the Minimum Income Standard (MIS) in line with the current policy which will increase weekly payments for Basic Island Pension and Income Related Benefits. Members were also asked to advise whether the Social Security (Amendment No. 2) Regulations should be approved and be effective from 30 November 2018.

The MIS includes the following;

- a. Food & drink, based on healthy international diet guidelines and local menus;
- b. Utilities;
- c. Clothing and shoes;
- d. Essential items e.g. cups, washing up liquid
- e. Toiletries
- f. Bus fares
- g. Newspaper

Members noted that the proposal will see an increase in the MIS of 1.62% which is £1.10. This increase provides an uplift which is greater than general price inflation. Members questioned whether the increase took account of price changes and were informed that previous changes have been incorporated including increased freight charges and the reduction in custom duties on certain items. Recent changes however, including the latest freight charges will be factored into the next review.

Members advised the Governor that they were content to approve the proposed changes, noting that this would go some way towards supporting the more vulnerable members of society. They were also happy to approve an ex gratia payment to be backdated to the 1 November 2018.


The Land Development Control Authority will hold its monthly meeting on **Wednesday, 12th December 2018, at 9 am at the St Helena Community College, Jamestown.**
