Remembrance Sunday Service

A Divine Service, in honour of those who had lost their lives or had been injured during active duty, was held at the Cenotaph in Jamestown on Sunday, 11 November 2018.

Her Excellency Governor Lisa Honan arrived at 10.55am, and The Most Reverend Dr Thabo Cecil Makgoba – Archbishop of Cape Town and Metropolitan of the Anglican Church of Southern Africa, invited those in attendance to pray, before observing a two-minute silence, signalled by the Last Post which was solemnly played by the Scouts. Following the two-minute silence, the poem 'Tribute to the Millions' was read by Chief Secretary, Susan O'Bey, to mark the 100th anniversary of the end of World War One.

Wreaths were laid by HE Governor Lisa Honan, The President of the French Republic (Michel Dancoisne-Martineau), the Royal Navy (Father Jack Horner), the Army (Nigel Dollery), the Royal Air Force (Marco Yon), the Merchant Navy (Ethel Benjamin), the St Helena Police Service (Garry Henry), and the St Helena Fire & Rescue Service (Kyle Yon). Several schoolchildren also laid wreaths.

The Right Reverend Allan John Kannemeyer – Bishop of the Diocese of Pretoria read the Lesson and prayers were led by Father David Musgrave, Lieutenant Coral Yon, Elder Brian Joshua and Bishop Elect Dale Bowers. During the Service, hymns were sung, including 'O God, Our Help in Ages Past', 'The Lord's My Shepherd' and 'Praise My Soul the King of Heaven'. The Act of Commitment was made and acts of peace were then offered. The Service concluded with the National Anthem and Blessing, followed by the March-Past outside the Court House.

Remembrance Sunday on St Helena was duly observed and very well attended.



Editorial

We have seen a lot of big events this week, especially last weekend when we had the centenary of the first world war armistice on 11th November 1918. We also had the enthronement of Bishop Dale and later the lighting of the Beacon at Kingshurst.

The end of festival of running and the opening of the Bank of St Helena Youth Games were also on the event calendar.

When it comes to political news it has been much drier. Really, there has been very little to report. I am getting seriously worried about the fibre-optic cable as a financial close for the South Atlantic Express (SAEx) is dragging on. The financial close means that finances have been guaranteed and the project can start. We suspect that Telecom Italia through their subsidiary Sparkle is one of the main investors in the project and Telecom Italia is in quite a bit of problem at the moment. Their credit rating has fallen and it seems like they are trying to sell off Sparkle, which will leave the SAEx project in the lurk, at least in the short term.

You might ask why I worry about these kind of things. To me and many others interested in the development of St Helena the fibre optic cable is absolutely imperative to ever get this Island to move forward. We need the cable and we need the ground stations to support the usage of the bandwidth it creates. We believe that the cable consultant Tony Fisk is arriving shortly. His main task will be to decide where the cable, if there is one should be landed on the Island. As far as I know there have several suggestions, from Rupert's to Sandy

Big Visitor at Ascension Island



Yesterday morning the super yacht Dorothea III visited Ascension Island. She is 47 metres long and has a beam of 12 metres.

The yacht is owned by Steven and Dorothea Green. He is the founder and chairman of Greenstreet Partners, former chairman and CEO of Samsonite Corporation and was U.S. ambassador to Singapore from 1997 to 2001.

The yacht has since left Ascension and it looks like she is heading for Brazil. It would have been nice to see her in James' Bay but from her course it seems unlikely, at least in the near future. It has been said that the Dorothea III is worth \$50 million

Bay. For St Helena to get the promised EU money to pay for the spur from the main cable to the Island we will need to decide on a landing site before the end of this year. This is doable but EU also ask for a route survey to be undertaken before the end of June next year. This might be a problem, if there is no financial close for SAEx there cannot be a route survey. For St Helena's sake, I hope it sort itself out.

Anyway - hope you don't blow away over weekend, gusts of Gale force are expected.

SENIOR AIRLINK DELEGATION VISITS ST HELENA



A meeting was held on Saturday, 10 November 2018, to undertake the first annual review of the contract to provide an air service to St Helena. Chief Financial Officer in Airlink, de Villiers Engelbrecht, joined representatives from the St Helena Government (SHG), Enterprise St Helena (ESH), and Legislative Council for the meeting. Representatives from the Department for International Development (DFID) joined via telephone link.

The meeting was chaired by SHG Deputy Airport Contracts Manager, James Kellett, who led discussion on a wide range of topics. Agenda items included a review of the annual performance of the contract in its first year, marketing activities actioned to date, plans for 2019 and beyond in respect of commercial and marketing activities, and discussion on various operational matters.

James commented:

"We are all pleased with the first year of operations and in particular to have a service that experienced a small surplus; this has only been possible due to the close cooperation of SHG, Airlink, airport staff and subcontractors, and ESH. We now turn our focus to using the lessons learnt from this initial year as the service grows in the second year of operations".

The meeting also included discussion around ongoing operations from Johannesburg, future plans for the air service, as well as planning for the additional flights due to commence in December 2018.

Chief Executive for Economic Development, Dawn Cranswick, said:

"The Review Meeting provided some useful insights into Airlink's promotion of St Helena as one of their destinations, and we will be working together on co-ordination of our activities for the future."

Airlink's CEO and Managing director, Rodger Foster, added:

"The occasion of the first anniversary of the St Helena air link is worthy of celebration, especially so given that during the first year of operations over 6,000 customers experienced the time efficiency of air access. We are delighted to have delivered safe and reliable air services and to have transformed access to and from St Helena. Airlink is privileged to have a close working relationship with the St Helena Government and we will continue to look for ways in which the service may be improved and in particular in addressing the wishes of our customers."

SHG, Airlink, DFID and ESH will continue to meet on a regular basis to monitor the performance of the service, plan for future changes, and to discuss operational matters as they arise.

EXCO REPORT – TUESDAY 13 NOVEMBER 2018

Executive Council met today with just one item on the open agenda. This was to consider an increase in fees and charges under the Road Traffic Ordinance 1985. Operations and Civil Contingencies Manager, Ian Johnson, said:





Over the weekend of 2 & 3 November, the students were paired up with an experienced Police Officer and went out on patrol. They dealt with a variety of incidents from parking obstructions to dealing with intoxicated members of the public. The debrief on Monday morning highlighted that Policing is diverse and no shift is exactly the same. The students expressed their enjoyment of putting what they have been learning into practice.

Monday, saw the students attending Magistrates Court for a visit, whilst also giving evidence relating to the stop/search exercise they had conducted the previous Thursday. The experience highlighted the importance of taking their time whilst completing paperwork and to pay more attention to detail. Thanks go to the Chief Magistrate for his time during the visit.

On Tuesday, the students were introduced to traffic legislation, exploring the difference between a mechanically propelled vehicle and a motor vehicle. The afternoon saw more scenario training taking place outside of Donny's Club. Students noted that it is fairly difficult to stop a vehicle in a safe, controlled manner, and then to start applying applicable legislation, ensuring that the correct piece of legislation is used.

On Wednesday, the students took part in the major incident exercise at St Helena Airport.

They then returned to the classroom on Thursday where a guest speaker spoke about Construction & Use offences, how to spot defective windows, wipers, and exhausts.



Sunday's Manchester derby highlighted how far United is behind City in terms of class. City outplayed them for 90% of the match and totally deserved all 3 points. It is heart-breaking to see how much United have fallen since the departure of Sir Alex Ferguson and consequently the year of their last League Title.

Mourinho was less than gracious in defeat he said the hosts had an advantage as their past two games - home thrashings of Southampton and Shakhtar Donetsk in which they won by an aggregate 12-1 - were significantly more straightforward than his team's most recent matches.

This was United's third away game in succession, following back-to-back wins at Bournemouth last weekend and Juventus on Wednesday.

"It's a heavy result for the effort of a team that had three away matches in the same week, with a super difficult match of a high, demanding level in Juventus against a team that had two friendly matches at home against Southampton and Shakhtar," Mourinho told BBC Radio 5 live.

Liverpool briefly went to the top of the table as they defeated Fulham 2-0. Fulham thought they had scored only for the goal to be ruled offside. 14 seconds later Salah scored after Allison took a quick free kick. This goal was controversial as the ball was still moving when the goal keeper kicked it.

Xherdan Shaqiri's cushioned finish in the second half confirmed victory for the Reds who equalled their best start to a Premier League season, which came in 2002-03.

Chelsea dropped points against Everton as they could only draw 0-0.

Arsenal scored late as they rescued a point in their home game against Wolves. In a thrilling contest, Wolves almost snatched it in stoppage time when 18-year-old substitute Morgan Gibbs-White hit the bar.

The fifth-placed Gunners are three points behind fourth-placed Tottenham, while Wolves remain 11th in the table.

Cardiff picked up 3 more vital points as they defeated Brighton 2-1. Brighton was reduce to 10 men after just 34 minutes. Brighton boss Chris Hughton said he was "angry" over an offside claim in the build-up to Sol Bamba's last-minute winner.

Huddersfield took a 6 minute lead against West Ham and looked on course for their second win only for Felipe Anderson to equalise with a fine goal in the 74th minute.

Leicester returned to the Kings Power Stadium for the first time since the death of their Chairman Vichai Srivaddhanaprabha. In an emotional match they could only draw 0-0 with Burnley.

Newcastle has picked up two consecutive wins as they beat Bournemouth 2-1. On loan striker Salomon Rondon scored twice for the magpies; this result moves them up to 14th place. Referee Simon Hooper can in for a lot of criticism as Southampton had a good goal disallowed for offside in their match with Watford which ended in a draw. The referee incorrectly believed Austin's shot had gone in off team-mate Maya Yoshida, who was in an offside position.

Juan Foyth who concedes two penalties in Spurs last match

was the hero as he scored the only goal in their win against Crystal palace. Palace have now failed to win in seven games in all competitions and were left rueing James Tomkins' failure to hit the target with a free header when it was goalless.




