Editorial

Exports from the Overseas Territories after Brexit



Lord Jones of Cheltenham has been asking questions about agriculture and meat exports from the Falklands after Britain leaves the European Union. Lord Ahmad, the UK Government's Foreign and Commonwealth spokesman in the House of Lords gave an answer which is less than encouraging. "The EU's non-preferential import duty on sheep meat is 12.8 per cent, plus a fixed amount, on average, of €55.68 per 100kg, depending on the cut. Implementation of such terms may render this trade no longer profitable." Lord Ahmad finished by saying "the majority of Falkland meat exports go to the UK and the Government will maintain duty-free access to the UK market post-EU Exit for all goods originating in British Overseas Territories, which will ensure the Falkland Islands' meat industry remains viable."

At a time when the St Helena Government is restructuring taxes to encourage exports our dear old Mother Country is making sure the whole of Europe is "no longer profitable" for exports of coffee and prime cuts of tuna.

Correction to last Week's Independent

We wish to point out that the late Brian's surname is FREDERICK - no S on the end.

It's a strange collection of news this week. Eric Benjamin attracts a lot of attention for the wrong reasons and much is being made of Napoléon's liking for the wines from Groot Constantia. Me being me I did have to wonder if Napoléon really did drink wine from the Cape. I did a bit of digging and found a report about a drinks provisions list compiled for the Emperor for his consumption while in exile here. The list was sold by auction in Salisbury, Wiltshire. The list is reported to be dated 1820 and shows a daily allowance of 50 bottles of wines and spirits together with a monthly allowance of 34 bottles of from France, Spain, Portugal and South Africa. I'm not convinced this report in The Drinks Business dated 29th September 2015 is entirely accurate but the report does mention 31 bottles of 'Cape Wine' on the daily list and 14 bottles of "Constanter" (Constantia) wine on the monthly list.

It's a lot of wine! Obviously the wine supplied was drunk by all members of Napoleon's entourage but 50 bottles a day means no-one ever went thirsty for a single second.

In addition to the wine in the provisions list, which sold at auction for £800, there was also a formidable range of food; 50 lbs of beef and veal, 68lbs of bread, 50lbs of mutton and pork, one roasting pig, two turkeys, 12 pigeons, four ducks, nine fowls, two geese, 42 eggs, 15 bottles of milk, cheese, mustard, salt, flour, rice, vegetables and "tongues". With items either provided daily or monthly like the wine. How did they manage to do this? The MV Helena only left a few days ago but I noticed today the chiller cabinets in shops are starting to look bare already. How did they manage to keep this supply going in the days of sailing ships when today, with engine-driven ships and planes it is still stop-start, yes and then no, maybe next ship maybe never.

Imprison them in St Helena

As the final bastion of the Islamic State (so-called) is encircled by the US backed Syrian Democratic Forces a Trump supporting news website follows up one of Trumps tweets. Trump is twittering about European countries taking some of the IS prisoners, at least 800 of them. The website, Front Page Mag, offers the option, "every last one of these monsters could be fenced in forever on say St Helena". They continue by suggesting Europeans should have prisons after the fashion of Guantanamo military prison. The UK does have immigrant detention centres already and their reputations are just a shade better than Guantanamo under President J Dubya Bush.



Dragging this Island into the discussion every time someone somewhere needs to find a place to exile a particularly dangerous and unwholesome person or persons is too regular an occurrence. Would SHG offer the old Blue Hill School as accommodation for a few Islamic State so-called soldiers?

RMS and Extreme E Racing

We have reported previously about the RMS being renamed 'St Helena' and being converted into the mobile administration centre and car carrier for the Formula E cars. Readers may remember the new Formula E set-up starts in January 2021 and the five race calendar runs through to August as electric 4x4s compete in endurance races in the Amazon, The Arctic, the Sahara, Himalayas and Indian Ocean Islands. The events will be televised but not broadcast until October/November 2021 in a five episode documentary format. This in itself is unusual, to say the least. Even more remarkable is the results of the races will not be publicised until the races are broadcast on TV three months after the racing calendar has been completed.

Alejandro Agag, The Chairman of Formula E, is quoted in Autosport "There is going to be a lot of the documentary part of it. The science part of it, we're going to have scientists on the boat." By 'boat' Agag is referring to the ship which used to be our RMS. There is a good possibility the former RMS will be shown in the TV series. Agag added, "It's going to be a lot of content – we're going to do a lot of teasing". By this Agag meant there will be regular snippets of information about the races on-line before the TV series starts in October/November. On the format for the TV series Agag explained,

"We call it a docu-sport – this halfway between a documentary and a sport." It is understood Channel Four in the UK is close to completing a deal to broadcast the 2021 Formula E season.

Napoleon's Favourite Wine?

A government press release this week tells us of an exhibition at the Groot Constantia wine estate; dating back to 1685 it is the oldest in South Africa. The exhibition promotes the link between the vineyard and St Helena at the time of Napoleon and the exiled Emperor's partiality for wines from the Constantia Valley, tucked away on the other side of Table Mountain from Cape Town. The exhibition is opened today and continues until June.



A half bottle of Grand Constantia can cost up to £50 for a half bottle (375 ml) while other wines offered from the Constantia valley vineyard range from £14 to £27 for a full bottle (750ml).

The exiled Emperor would surely have chosen the £50 bottle and bought it by the case. James M'Gregor, a missionary who lived in St Helena a few years after Napoleon died noted in his memoirs that the average annual charge to the British Government for keeping St Helena going was about £90,000 before Napoleon arrived. During the seven years Napoleon lived here the figure rose to an average of £242,000. M'Gregor points out the cost to the British Government of Napoleon's exile was at least £1 million. £1 million in 1815 is worth £86,739,633.86 today's devalued money. Some of that would have been spent on the finest wine that can be produced from the Constantia Valley in the shadow of Table Mountain.

Supreme Court Sentencing

“You seemed to regard her need for money as giving you leverage in trying to take sexual advantage of her”

Judge Patrick Thomas QC sentenced Eric Benjamin on Tuesday afternoon. After giving a brief description of each of the offences Benjamin was charged, Judge Thomas concluded with the following words.

“There is no mitigation from the way you have conducted yourself since these matters came to light. You fought this case to the bitter end. Your positive good character, your work for the island, are of little weight bearing in mind the way you abused your high reputation in order to commit these offences with, as you thought, impunity. Your age cannot assist you. Your ill-health does. You have had heart and prostate trouble, and you are diabetic. This means that the effect on you of a prison sentence will be greater than it would be on a healthier man.

Having decided on the appropriate sentences, I step back and consider totality. Having done so, I reduce the sentence I had in mind for Count 3 by 6 months. These are the sentences of the court:

On Count 3, 4½ years’ imprisonment

On Counts 1, 2 and 4, 6 months’ imprisonment on each, all sentences consecutive.

This makes 6 years’ imprisonment in all.

You may expect to serve two thirds of this sentence, after which you may expect to be released on licence. If you reoffend during the period of licence, you can expect to be recalled to prison. You will be obliged to report your address to the police for life. In the circumstances of this case I cannot find it necessary to make a Sexual Offences Prevention Order, so I do not. I make no order for costs”.

Benjamin was found guilty on all four charges brought against him; two counts of sexual assault, one of indecent assault and one of attempted rape. The attempted rape was referred to by the judge as

Count 3 for which Benjamin was sentenced to 4½ years’ imprisonment. The two sexual assaults and the indecent assault each earned him a further six months in prison.

Benjamin has an offence dating back 50 years however this historic offence was ignored; he was sentenced on the basis of someone with no criminal record. One of the offences he was found guilty of on Tuesday dates back 20 years. Judge Thomas said when sentencing Benjamin, “I, and everyone else I am sure, will ignore the blemish on your record over 50 years ago and treat you as a man with no convictions. But you have held a dark secret: 20 years ago you took advantage of a 16-year-old girl and kissed her on the lips while trying to force your tongue into her mouth. A sexual act which you knew perfectly well she did not want.”

The other offences were more recent. Judge Thomas continued, “And then, towards the end of 2016, you did the same thing to another young woman, who had gone to you for help. Like the first girl, she did not make public what you had done, though she did report it in confidence to her line manager. The

young woman was desperate for help, and you were the person to whom she turned again not long afterwards. You must have thought that her silence meant that she was a safe target. This time, as she was once again alone with you in the study which you also used as a photographic studio in your home, you went much further. You forced her to the floor and started to remove her clothing, telling her you wanted to have her just once. Fortunately her phone rang, and you were sufficiently distracted to enable her to make her escape. But you had already gone so far in what you intended that the jury who heard your case was sure that you attempted to rape her.” With this girl Benjamin was charged with sexual assault for the first offence against the girl as well as attempted rape on the second occasion the same girl had to turn to Benjamin for help.

The fourth offence was described by the judge during sentencing as one which occurred after the attempted rape where the abused, at that time had remained silent despite Benjamin committing two sexual offences against her. “Still she did not make public what you had done. This meant that when a third young woman came to your studio at the end of 2016 you felt safe enough to try to put your tongue in her mouth when you kissed her against her will. And even now all three women kept quiet about you.”

After a long period of silence endured by all of the girls Benjamin preyed upon, Judge Thomas described how the truth finally emerged into daylight. “Each of the latter two ladies was seeking help and counsel from a psychologist, and as a result that lady came to know that you had behaved in similar abusive ways with those two women. Professionally and sensibly she knew that she had to do something about this. She consulted the Attorney General’s department, and acted on the advice she received. She did not tell either

of the women anything about the other, but she encouraged and advised them to speak to the police. With immense bravery in the circumstances, which calls for the highest commendation from anyone concerned about the interests of justice, they separately came forward.

Their complaints were handled with tact and sensitivity by the police. The first complainant was also seen, and the case for the jury to consider was complete.”

Judge Thomas gave his view on how Benjamin reacted to the charges levelled against him. “Your response to the truth emerging was to lie: you denied what you must have known you had done, and I have no doubt you relied on your prestige in the community as a shield against the truth emerging.” Later in his sentencing Judge Thomas observed, “But the actual sexual assaults were relatively, I stress relatively, minor, and not persisted in at the time. If you had had the courage to admit what you had done those, of themselves, might not have called for an immediate custodial sentence. As it is, they do, and the custodial sentences must be consecutive, though tempered by the principle of totality.”

When assessing the severity of each offence Judge Thomas explained that guidelines exist but they are a guide and when sentencing he could step outside the guidelines “either upwards or downwards”. On Count 1 the judge said, “It was committed against a 16 year old girl, who had been entrusted to you, a much older and highly respected man, for you to take photographs of her with the backdrop of this island. As a result of her age, the breach of trust element and the location, an isolated spot where she must have felt very alone and unprotected, this attempt to force your tongue between her lips is a Category 3A offence”,

Continuing through the list of offences Judge Thomas said, “The similar offence against the other two women would fall into a lower category, 3B, but it is plainly an aggravating feature that you had already committed the first offence. It also an aggravating feature that, although these ladies were not, perhaps, to be described in the words of the *Guidelines* as particularly vulnerable, they were, each of them, certainly vulnerable in a variety of ways which you, in the position you held as a lay advocate, knew all about. They had approached you for help. The second complainant had a variety of problems which had led her into financial difficulties and put her at grave risk of losing her job, which she later did. She actually approached you in the hope of borrowing money to help her through her difficulties, and it is a disturbing feature of what happened later that you seemed to regard her need for money as giving you leverage in trying to take sexual advantage of her.” The judge added, “The third complainant, as you well knew, also had a variety of emotional and financial problems. Again, there was an element of “if I do something for you, you should do something for me” about your dealings with her.”

Judge Thomas then gave his assessment of the most seri-

ous charge, attempted rape. “The offence which formed Count 3, the offence of attempted rape, is plainly the most serious of these charges. The second complainant, desperate for help, had gone to you again. You must, as I have said, thought that this gave you free rein to do what you wanted with her. You were saying that you just wanted her once. You forced her to the floor, and started to remove her outer clothing, and removed some of your own. Her phone rang, and perhaps this brought you to your senses. She pretended it was her office on the phone, and you let her go. She fled. But still, despite all this, and for reasons that anyone could understand relating to your status on the island, she did not report the matter to the authorities. This was a Category 3 B offence, but with significant aggravating features as I have outlined, and as a completed offence has a starting point of 5 years’ imprisonment with a range of 4-7 years. The psychological effect of what you did to this already troubled young lady, as she explained in her realistic and well-expressed Victim Impact Statement, was very considerable. “

The judge commented on the work of the jury. “Your case was heard by a jury of your peers, and they decided that they were sure of your guilt. I will comment now on how impressed I am, as a judge who has over many years taken part in many, many jury trials, by the focus and diligence of the jury of islanders who heard your case and judged you impartially and without fear or favour.”

- **Medical, Dentistry and Pharmacy (Amendment) Bill, 2019**

First Supplementary Appropriation (2018/2019) Bill, 2019

This Bill seeks to increase the 2018/19 budgets approved by Legislative Council in July 2018 for the respective directorate expenditure based on the latest available forecast.

St Helena National Trust (Amendment) Bill

This Bill seeks to amend the St Helena National Trust Ordinance, 2001, to further regulate the powers and procedures of the Trust and the composition and procedures of the Trust Council.

The Bill makes provision for the appointment of a Director of the National Trust who will be responsible for the day-to-day functioning of the Trust.

The Bill also provides for the accounts of the Trust to be audited either by the Chief Auditor or an auditor approved by the Chief Auditor.

Medical, Dentistry and Pharmacy (Amendment) Bill, 2019

This Bill seeks to amend the requirements in the Medical Practitioners Ordinance, 1910, the Pharmacy and Poisons Ordinance, 1937, and the Dentists Ordinance, 1955, relating to the qualification to practice medicine, pharmacy and dentistry in St Helena.

The order paper for the ninth meeting of Legislative Council will be made available closer to the date.

MAKING A FORMAL COMPLAINT ABOUT SHG SERVICES

St Helena Government (SHG) aims to provide the best quality and standard of service to its customers but there may be occasions where you are dissatisfied with the standard of service received.

If you have received a service that falls below your expectations then SHG wants to hear about it.

SHG Complaint Procedure

Submitting a complaint about SHG can be done via the straightforward and simple Complaint Procedure. SHG treats all complaints seriously and deals with them promptly and professionally. The organisation learns from complaints which help us to improve our service to customers.

The SHG Complaint Procedure covers all sections of SHG with the following exceptions:

- Complaints on Hospital services should be made via their separate procedure
- Complaints regarding the St Helena Police Service should be made in line with the requirements set out in the Police Service Ordinance (available on the SHG website)
- SHG staff wanting to make complaints against managers or other staff members should follow the Code of Management procedures

How do I make a complaint?

Complaints can be made in writing using the SHG Complaint Form – General, available on the SHG website here: <http://www.sainthelena.gov.sh/complaint-procedures/>, by telephone, email or in person via the following contact details:

Ideally, a complaint should be made within one month from the day that you have received a disservice. Anonymous complaints can be submitted to SHG but you will not receive a response if a contact name or address is not provided.

Complaints can be made through your Councillor, Lay Advocate or the Public Solicitor.

What happens to my complaint?

SHG will aim to acknowledge receipt of your complaint within three working days and will aim to send you a more detailed response within 10 working days to inform you of what action has been taken as a result of your complaint.

What happens if I do not get a response or I am not happy with the response?

If either of the above happens, you should make a stage two complaint by completing the SHG Complaint Procedure Form - Stage 2 and 3 available on the SHG website here: <http://www.sainthelena.gov.sh/complaint-procedures/> and submit to the Information & Research Support Officer via the above contact details.

SHG will aim to acknowledge receipt of your complaint within three working days and you will be informed of the person investigating your complaint. You can expect a more detailed response from the appointed investigating officer within 10 working days informing you of what action has been taken as a result of your complaint. Alternatively, it may explain that a full response will be sent to you later and the reasons for the delay. The response will also tell you when the officer intends to conclude the investigation.

What happens if I still do not get a response or I'm still not happy with the response?

If this happens you should make a stage 3 complaint. Again, complete the SHG Complaint Procedure Form - Stage 2 and 3 and this time submit it to the Chief Secretary at the Castle or via email: susan.obey@sainthelena.gov.sh The Chief Secretary will aim to acknowledge receipt of your complaint within three working days and will state how the review is to be conducted. She will appoint a Reviewing Officer who will aim to respond to you within 28 working days. Their response should let you know why action has been delayed and when you are likely to receive a response.

Shredder machine

Plastic waste is shredded into flakes which will be used in the other machines to create new things. You can select the output size of these flakes by changing the sieve inside the machine to create different patterns and processes.

Extrusion machine

Extrusion is a continuous process where plastic flakes are inserted into the hopper and extruded into a line of plastic. These lines can be used to make new raw materials such as 3d printing filament, make granulated plastic, spun around a mold, or used in your own new and creative ways.

Injection machine

Plastic flakes are heated and injected into a mold. It's a relatively quick process which is well suited for creating small objects repeatedly. You can make the molds completely yourself by using CNC mills or lathes, or by simply welding them.

Compression machine

Plastic is heated inside the oven and slowly pressed into a mould with a carjack. Well suited for making large and more solid objects, the oven itself is also a great machine for prototyping and making plastic tests with.

Armchair Supporters View by Nick Stevens

Last weekend we saw a break for EPL football as the 5th round of the FA cup took place.

Watford reached the FA Cup quarter-finals for the second time in four seasons after a hard-fought win against battling Queens Park Rangers.

Capoue's scored the only goal in first half stoppage time, after Cleverley's miss-hit, proved the difference.

Championship side QPR went close through Massimo Luongo, while Watford keeper Gomes marked his 38th birthday with a fine save to deny Wells.

Watford progressed after scoring from their only shot on target. They will now play home to Crystal Palace.

Crystal Palace beat Doncaster Rovers 2-0 on Sunday with goals from Schlupp and Max Meyer. The Eagles have never won the FA Cup, losing twice in finals to Manchester United in 1990 and 2016, but this was also only the second time in 23 years they had reached the last eight.

On Saturday Ashley Cole scored on his debut for Frank Lampard's Derby this was however not enough as Brighton had by then took a 2 goal lead with strikes from Brighton's Anthony Knockaert and Jurgen Locadia. Brighton progress through to the Quarter Finals to play away at Millwall.

Millwall defeated AFC Wimbledon scoring the only goal in the 5th minute. Murray scored what proved to be the winner; he was also the goal scoring hero in the previous round when his goal in the 94th minute knocked out Everton.

After a goalless first half the EPL Champions Man City scored 4 goals against Newport County on a terrible pitch. Youngster Foden scored twice and Sane' and Marhez scored one each. Newport who had a good FA Cup run scored a consolation goal through Pdraig Amond.

Man City will now play Swansea in the next round. The Swans defeated Brentford 4-1.

Wolves overcame spirited Bristol City at Ashton Gate to reach the FA Cup quarter-finals for the first time since 2003.

After a quiet opening, Cavaleiro stroked home the only goal with the game's first shot following good work by Doherty down the right.

Wolves will now face Manchester United. Manchester United scored two first half goals with strikes from Ander Herrea and Paul Pogba to defeat Chelsea.

The result throws Chelsea's Manager Sarri's reign deeper into crisis, while United delivered the perfect response to their first defeat under Ole Gunnar Solskjaer.

As Chelsea slumped tamely to another defeat, their fans turned on Sarri. They jeered his substitutions, mocked his 'Sarri-ball' philosophy, demanded the return of Frank Lampard as manager, and joined United's fans in chants of "you're getting sacked in the morning".

In Tuesday's Champions League matches Liverpool drew 0-0 at home against Bayern Munich despite dominating the game. Although this result might give Bayern an edge in the tie, I feel Liverpool might create even more chances in Munich as Bayern will no doubt attack the 'Reds' more and leave more

space at the back.

In the other match Lyon drew 0-0 with Barcelona despite the Spanish team having 25 shots at goal.

On Wednesday Man City can from 2-1 down and with 10 men they beat Schalke 3-2. Atletico Madrid defeated Juventus 2-0 in the other match.

This weekend will see the first domestic Silverware contested in England as Chelsea play Man City in the EFL Cup at Wembley on Sunday.

We will see Premier League matches on Friday; Saturday, Sunday, Tuesday and Wednesday.

On Friday evening Cardiff will host Watford and West Ham will play Fulham at 19.45.

Saturday matches will see Burnley play at home to Spurs in the early game; Bournemouth will host Wolves and Newcastle will play Huddersfield Town at 3pm. In the late game Leicester City will host Crystal Palace.

Two matches will be played on Sunday both starting at 14.05. Arsenal will play Southampton and in the match of the weekend Liverpool will come to Old Trafford for a mouth-watering clash with their fiercest rivals Manchester United. Liverpool will no doubt go into the game as favourites and if they manage to pick up all 3 points I think it would give them the confidence to go on and win the League. If however Liverpool drop points it will hand a huge advantage to Man City; especially as the Manchester derby will need to be reschedule for later in the season due to FA Cup commitments.

The Falkland Islands are not within an Anglican Communion province but is an Extra Provincial area under the metropolitanical authority of the Archbishop of Canterbury. The Bishop to the Falklands is a post held by the Bishop at Lambeth – the senior episcopal assistant to the Archbishop of Canterbury at Lambeth Palace.

Despite the remoteness of the cathedral on the South Atlantic islands, a full slate of clergy were present for to watch Denise Blake and Antonia and Stirling Harcus make their confirmation vows during what was described as a "joyous" service. In addition to Bishop Tim, the interim priest in charge of the Falkland Islands, Ian Faulds was joined by other Christ Church Cathedral clergy Kathy Biles and Betty Turner. Also present was the Chaplain-in-Chief of the Royal Air Force, John Ellis, and Forces padre Alice McDermott.

A new Rector will be sought for the Falkland Islands shortly after its previous Rector, Nicholas Mercer, returned to the UK in December to take up a new role in Bolton Abbey later this year.

South Africa has credit rating reduced to 'junk' while British leaders watch as finance and industry plummet

April will be coming around soon and governments around the world are starting to present their budgets for the 2019-20 financial year. The South African Finance Minister presented his budget this week and it was not a happy occasion. After Jacob Zuma's chaotic reign as the President of the Republic of South Africa the new president is trying to restore some kind of order but there is a long way to go and several power centres in South Africa will strongly resist the strong and sour medicine which needs to be taken before real improvements can be gained.

The Magnificent Seven Economic Indicators

1. South Africa's economic growth rate has been revised downwards to 1.5%

2. State Owned Enterprises such as Eskom (national power utility), South African Airways, South African Express Airways, the South African Post Office and the South African Broadcasting Corporation all rely on government cash injections to stay in business. Some of them have the begging bowl out for more government cash.

3. South Africans of working age total 38 million. 16.4 million are employed, 6.2 million are unemployed and 15.4 million are "not economically active".

4. The Social Services budget soaks up 60% of all government expenditure and State wages take up another large slice of government expenditure.

5. Savings in expenditure are forecast but may not happen as failing state businesses ask for more money. No tax increases in the budget apart from a below-inflation increase in fuel levies and an increase in sugar tax equal to inflation.

6. Government debt is forecast to increase over the next few years, (it has doubled since 2008) but international money markets are signalled not to lend money to South Africa as the credit rating agencies reduce the status of South African Government Bonds to 'junk'.

7. £1 billion is to be spent on land reform – helping landless South Africans buy land and settle restitution claims. A further £75 million will be spent buying farm equipment for "re-settled farmers".

Meanwhile back in Britain, where the government debt has also more than doubled since 2008, Honda have decided to close its Swindon factory, Nissan have decided not to build its new X-Trail model at its prestige factory in Sunderland and Jaguar-Land Rover are losing money hand over fist. The next

bad news for Britain's car industry is due to come from Ford. Banks and financial firms are leaving London's financial centre at the rate of £185 billion a day and new investment is at its worst level since the 2008 financial crisis. Productivity and unemployment are falling while wages are rising; exports have fallen sharply.

Westminster politics is in crisis and will probably remain so long after the dust raised over Brexit has settled. The political party system is fracturing (there have been signs of it happening for years) and, of course, no-one with the power to do something has a clue what to try to replace it with.

Supreme Court Sentencing

“Her life has had its real hardships and problems and what you did played a significant part in that”

Cyril Graham, better known as 'Caesar', pleaded guilty when brought before the Supreme Court to answer a charge of indecent assault of a child. The offence was committed 50 years ago and took place on Ascension. When sentencing Graham Judge Thomas addressed the length of time between the committing of the crime and being charged before the Court, “It can take and frequently does take many many years for a child to be able to talk publicly about what has happened to her, her in this case, him in others, so long ago which has had such an effect on her life. I have already stressed my understanding of the way in which your victim expressed herself in the victim impact statement that I have considered. It is a frank and open and honest document. She does not say that what you did is the cause of all her unhappiness, she does say and I entirely agree with her what you did must have had a significant part in the problems that she has had in later life.”

The Judge continued, “One of the matters I have had to consider is whether the level of sentence in this case is increased by an element of severe psychological harm. This is a particularly cold thing to say but it has to be said, the guidelines are based on the understanding that activities like yours result in psychological harm but there is nothing here that indicates that the words that there are appropriate in the context of this case and therefore for the equivalent offence which is an offence of sexual penetration of a person under the age of 13 I am satisfied that the right category range is 3B which gives a starting point of 4 years custody and a range of 2 to 6 years custody for the court to consider. “

Judge Thomas added, “There is a lot to be said about you and what has happened since but I am going to start with what you did. You were a friend of this little girl's, as she then was, family. On your account which is the basis upon which I sentence you, you went to the cinema with her and other children and whilst you were in the cinema you put your hand under her knickers and there was a small but obviously crucial degree of penetration of her private parts with one of your fingers. That is what you have admitted and although the account that she gave in circumstances is very different the difference is not such that it would require anybody, least of all her, to give evidence, the effect of the offending is exactly the same. Her life has had its real hardships and problems and what you did played a significant part in that.”

The incident did not come to light until 2016 and Graham was arrested in 2017. Judge Thomas said, “There has been significant delay since, agreed not to have been caused by you. As I make it plain that frankly would have little weight in the sentencing exercise that I am conducting, were it not for the fact that upon your arrest you immediately made an admission to what you had done and that therefore I accept that you are genuinely remorseful and that the effect of waiting upon you has been highly significant. There is remorse and delay and you have 50 years of good character to place before the Court. I am unimpressed by the suggestion that you were in drink when you committed this offence; drink is usu-

ally an aggravating rather than a mitigating feature of any offending. The fact that you were at the time an alcoholic is I think possible but I do not regard that in the context of this case as any great level of mitigating effect.”

Judge Thomas then sentenced Graham, “That brings me to a sentence of two years, which is one capable of being suspended. I will put you out of what must be your intense anxiety. My view is that this is a case where suspension is a proper step to take. You are now elderly, you are physically weak and you have a number of medical problems that I know about. In all the circumstances it seems to me that all of the matters that I have discussed entirely justify the suspension of the sentence that I pass and therefore the sentence upon you is one of 2 years imprisonment suspended for a period of 18 months, I reduce the total period of suspension because of the delay and that has significantly affected you which has not been your fault. If in the next 18 months you reoffend then you will entirely deserve to and you will serve this sentence. If you do not you will not. In addition I have already directed that you be subject to reporting conditions for 10 years and it is a criminal offence to break that order. I have considered as I have been invited to consider the possibility of imposing a Sexual Offences Prevention Order upon you but such an Order can only be made if it is necessary to prevent further offending of the same kind and nobody looking at this case could think that is necessary.”

“He is he judge with the human touch, who regularly walks to court, will have a chat in the street, and is a passionate believer in the jury system”

Judge Patrick Thomas who replaced Judge Ekins as the Supreme Court Judge for the Benjamin trial could normally be found within the precincts of Birmingham Crown Court. He has recently retired from a life in the legal profession but any and all matters of a legal nature have an enduring interest for him. “My father was a solicitor, my grand fathers were solicitors and I am married to a solicitor. You could say the legal profession is in my blood,” he told the Birmingham Mail newspaper when he was interviewed after his retirement.

The interview took place in his office at Birmingham Crown Court where he was trying a murder case. Now aged 69, Judge Patrick Thomas appears to be approaching retirement very gradually.

Judge Thomas has experience of many different judicial systems around the world. Now he is adding the St Helena judicial system to his long list.




