

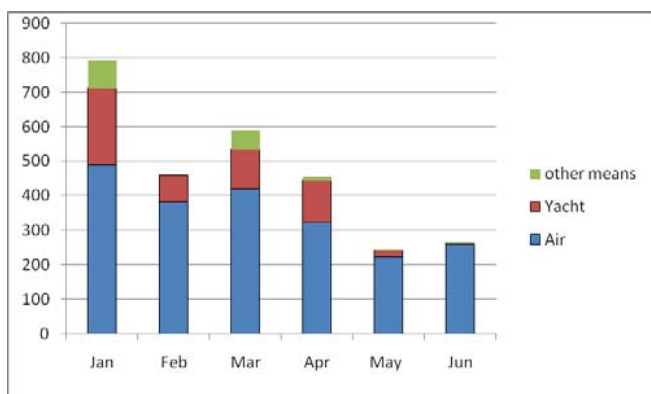

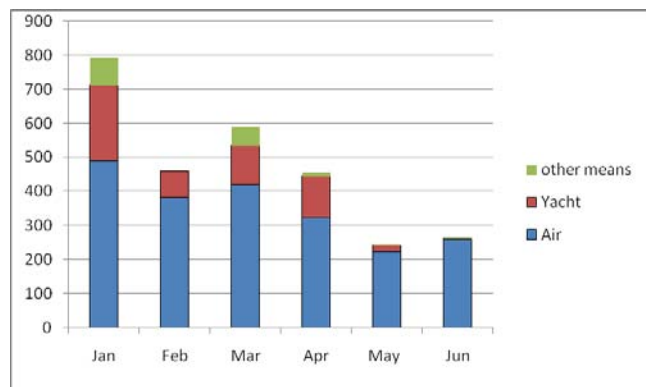

## The latest figures on visitor numbers

This series of graphs gives a snapshot of who comes to St Helena, why and from where. Some graphs and figures give totals for each month of this year while others compare the first six months for the last six years. Overall the figures are stubbornly resisting an upward trend. Cruise ship passengers are not included in any of the totals.

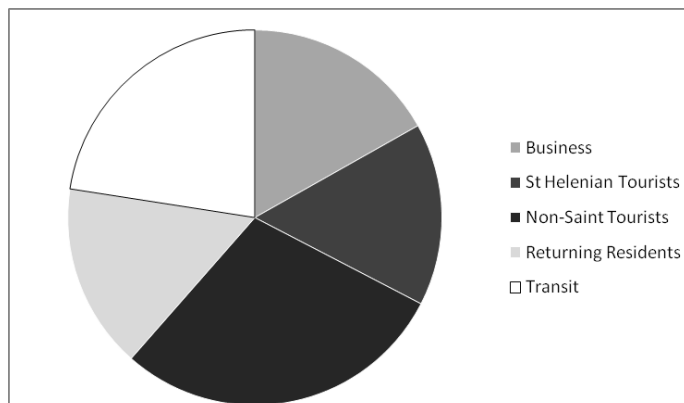
### Total Passenger Arrivals – 2019 so far

'Other means' refers to arrivals from ships other than yachts and the RMS – where the RMS passenger arrival figures apply.

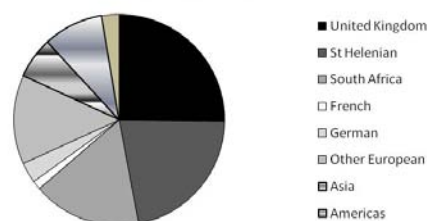
### Passenger Arrivals – Purpose of Visit- 2019 so far



This graph shows the how big the slice of the pie is for different parts of the travel market. The darker grey slices are Saint and Non-Saint tourists who represent 45% of all the 2,807 arrivals so far this year. 'Transit' includes most yacht crews, ship crew flying in for a crew change on a ship in James Bay and people flying in to pick up a cruise ship calling here. Many of these visitors could be classified as tourists; if the Transit number is included with Saint and Non-Saint Tourists the tourist share of the total increases to 67%.

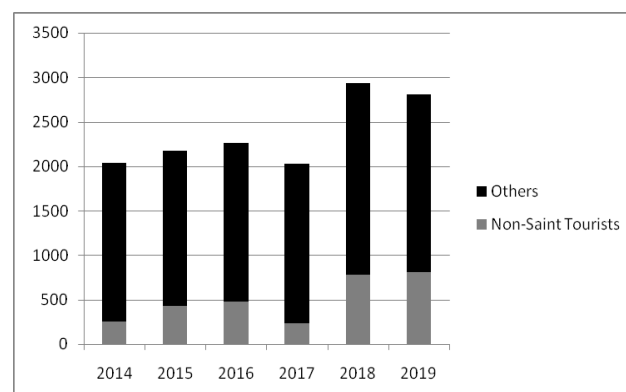

The UK continues to be the largest source for visitors to St Helena. These figures include all arrivals, not only tourists. There are more visitors this year from Europe than South Africa. Europe and the UK account for 39% of all arrivals while South Africa makes 13% of the total. St Helenians make up 32% of the total.

This graph shows how many of the total number of arrivals who have come to be known as 'genuine' tourists. However the yachts and yacht crews arriving are included in 'Others' as they are included in the Transit classification. There is no noticeable difference between the arrivals for 2018 and 2019.

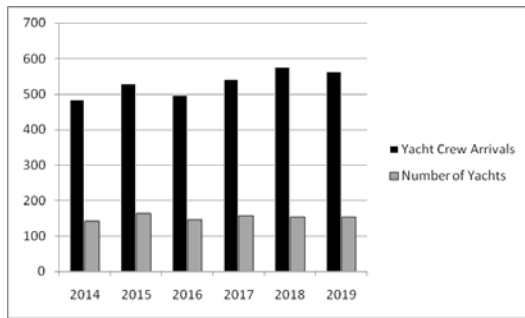

Cruise ship passengers can only be here for a few hours, after taking an island tour they have been known to return to their ship for lunch without even buying a cup of coffee while here. The figures for cruise ship passengers are not included in any of the other arrivals figures but shown separately here.

The three yacht races which arrived in January brought in very nearly all the 63 yachts and 224 yachties arriving in that month. However the total number of yachties arriving in the same six months of 2018 was slightly more. The number of yachts arriving was exactly the same.

Official statistics includes **St Helenians resident overseas** as tourists when returning to visit family and friends. **Non-Saint tourists** are those who have become known as genuine tourists; the ones who book accommodation, eat their meals in coffee shops and restaurants and book tours around the Island and on boats. **Transit** includes just about all yachties the opinion is gathering strength that yachties are an important part of the tourist market. They sometimes book hotels, normally re-stock their galleys with food bought here, frequently eat meals out, regularly enjoy a beer or a bottle of wine and often use local laundries.

If these three categories are grouped together as part of the St Helena tourism market they make up a little more than two-thirds of all arrivals. People on business and returning residents make up the other third. On these figures 1,886 people have arrived here this year for a limited period of time and spent money while they were here. Where did they spend it and how much did they spend? Complaints about "no tourists" come from all sides. The numbers are still small but who is getting the meagre picking from what is available?

## St Helena shut out of Cape to Rio Yacht Race



Last January James Bay and the wharf were busy as yachts from the Cape to St Helena Race, and then the Oyster Rally, followed by the World Arc Rally gave the St Helena Yacht Club members probably the busiest month they have ever known. This coming January St Helena was to be on the international yacht race calendar once more when the crews of cruising class yachts in the Cape to Rio Yacht Race were scheduled for the first time to make a call here before continuing to Rio de Janeiro. The St Helena stopover has now been taken out of the race schedule, all yachts, both racing and cruising yachts, will sail directly to Rio.

The Royal Cape Yacht Club (RCYC) organise the Cape to Rio race as well as the Cape to St Helena race. RCYC made the Cape to St Helena one of the qualifying races for the longer Cape to Rio Race. St Helena was included in next January's Cape to Rio race schedule as a new feature of the race. However the Race Rules were revised last month and the St Helena stopover was taken out.

Hilary Ackerman, the Sailing Events Manager at RCYC told the *Independent* "The Cape2Rio Committee discussed in length the mandatory stopover for the cruising class in St Helena" and went on to explain the reasons why the Race Rules were changed. There are at present just six entries for the Cape2Rio2020 and of those six, two are in the cruiser class and would have been scheduled to stop at St Helena. Some yacht crews interested in joining the race are not keen in having a stopover at St Helena; there were requests for the

Race Committee to re-think the idea of introducing a St Helena stopover. The stopover would also mean cruiser class yachts would not arrive at Rio in time for the prize giving. In the end it was decided the idea of introducing a stopover at St Helena for cruiser class yacht entries was not popular. The Race Rules were revised and the stopover taken out.

The first Cape to Rio yacht race was in 1971 when 58 yachts competed. It is the longest ocean yacht race in the southern hemisphere.

### Cape to St Helena 2020 race shaping up to be the biggest yet

The better news from RCYC is that at least 40 crews have shown interest in the Cape to St Helena race which will leave Cape Town in December 2020 and give or own yacht club a busy time once more when the yachts arrive here in early January 2021. The RCYC see the 2018 Cape to St Helena race as a huge success. They believe the race has its own identity and has more appeal to ocean racing yacht crews. Hilary Ackerman, the RCYC Sailing Events Manager told the *Independent* "I will be working closely with Dale (the Race Committee chairman) on the Race and I have to tell you I am so excited about it... Already planning my trip to you guys..."

This particular Shakespeare play (Richard II) was written in 1597, 95 years after St Helena was discovered but I doubt Shakespeare knew of this island's existence so we must excuse his error when writing "this England" instead of "this St Helena"

Later in the same speech Shakespeare puts these words on the tongue of his character,

Hath made a shameful conquest of itself.*

## ESH given an A Grade by their funders

The detailed results of the most recent annual review of Enterprise St Helena by DFID will be published soon. For the moment what we know is that DFID have checked out how ESH have progressed in certain specific areas of their activities and awarded an A Grade for most of them. Some areas of activity have been given an A Plus Grade.

As with the Utilities Regulatory Authority and Connect St Helena, ESH are reviewed annually by DFID and checked against targets. Every year the targets are revised, meaning the bar is raised and ESH has a more testing challenge to meet during the next twelve months. Dr Dawn Cranswick, ESH's Chief Executive, explained during a *Saint FM* radio interview there were four overall objectives where ESH were required to show they had met or exceeded the standards set for them by DFID. The objectives involved investment, business support, the health of businesses supported and the volume and quality of specific work. Soon, DFID will set ESH targets for the next twelve months in different areas of work or maybe higher targets in the same areas. Other aspects of the work DFID looked at included the number of overseas tour operators actively selling St Helena as a holiday destination. Building up these kinds of numbers is seen as laying building blocks for the future. The latest ESH annual report listed 13 tour operators in the UK, 6 in the rest of Europe, 7 in South Africa, 2 in North America and 1 in Japan. Dr Dawn Cranswick made a point of saying the success really lies with the businesses rather than ESH. Support and advice can be offered by ESH but the results are down to the businesses involved. The targets are based on practical and measureable achievements where the result is simply pass or fail. Dawn also said she had twice been out and about talking to business owners and senior management to learn first-hand what her customers thought of ESH's offering. Sometimes the opinions she invited fell a bit hard on her ears but she emphasised it was important she sought these opinions by face-to-face conversations with business people. The CEO also announced there will be a new grants policy com-



ing soon, probably by the end of this month.

SHG Chief Secretary Susan O'Bey also attended the *Saint FM* interview. She outlined changes to the way SHG seek new investors both locally and overseas. Some processes used have been enhanced and simplified and key people from SHG, ESH, Bank of St Helena and Information Technology get together as required to work through issues as they arise. Lawson Henry told *Saint FM* listeners there is a need to graduate to another level in efforts to attract more private sector investment and work on this should start this year. However he pointed out results will not be achieved overnight. Lawson complained about the high cost of air fares to get to St Helena and said the repair to Wideawake runway should be treated as a matter of urgency. When Wideawake is open again Lawson thinks it will make a big difference for Saints and visitors. For the moment it is money from the DFID funded Capital Investment Programme which will bring a transfusion of cash into the economy and turn around the current dip in employment figures.

The DFID review of ESH is not yet ready for publication. Dawn Cranswick said when it is published there will be several points in it worthy of further discussion in another *Saint FM* radio interview.

## GOVERNOR RUSHBROOK RETURNS FROM ASCENSION VISIT

His Excellency Governor Dr. Philip Rushbrook has now returned to St Helena following his first visit to Ascension Island since his appointment as Governor in May 2019.

The Governor arrived to Ascension on Monday, 8 July, and enjoyed a full programme of events, meeting many of the Ascension Island community, before departing for St Helena on Sunday, 14 July 2019.

As well as hosting a Town Hall Meeting and drinks reception for members of the public, Governor Rushbrook met with heads of employing organisations on-Island, the Ascension Island Council, representatives of voluntary organisations, and attended a meeting of the Safeguarding Children Board.

The Governor gained a better understanding of some of the practical challenges faced in operating services on Ascension and how these are tackled, as well as plans for the future, during a critical infrastructure tour.

He also attended the Two Boats School End of Year Awards Ceremony, where he made several presentations.

Towards the end of the visit, Governor Rushbrook got to observe some of the natural and manmade heritage that Ascension Island offers during a trip on the Queen Atlantis boat. He also found time to complete one of the Island's letterbox walks.



HE the Governor said:

"I was delighted to be able to visit Ascension so early in my tenure as Governor. I was impressed with the resilience demonstrated by the population there in the face of the ongoing suspension of the airbridge and the real sense of community exhibited.

"Although only there for a week, I was pleased to be able to speak with lots of people and hear about their hopes and concerns for the future.

"I'm already looking forward to returning to Ascension and, having been there for myself, am now even more proud to be Governor of such a wonderful and unique Island."

# Maths Matters (Study Summary)

Mathematics can be defined as the science of numbers, measure, mechanics and space categorised as abstract concepts (pure maths) or applied maths. Mathematicians look for patterns in various settings and create models that allow predictions. In addition, Mathematical foundations are used to build smarter technology.

It is not surprising that maths appears in many disciplines such as physics, engineering, biology, chemistry, economics, computing & software, logistics, etc. In our everyday life we often forget or take for granted the maths being used behind the scenes in things like weather forecasts, financial trading, mobile phones, GPS, etc.

In August 2016 I departed St Helena to undertake a 3-year BSc (Hons) Mathematics degree at the University of Portsmouth. On the 15<sup>th</sup> July 2019 I graduated with First Class Honours. There were six units in each year at Level 4 (1<sup>st</sup> Year), Level 5 (2<sup>nd</sup> year) & Level 6 (3<sup>rd</sup> year) with many assessments such as coursework's and exams throughout. The degree delivered a stunning overview of many areas such as analysis, applied maths, calculus, finance, statistics & supply chain management. Below I summarise some key elements of the degree content:

Differential Equations abbreviated DEs are equations that describe change of 'something' over time or rate of change (*mathematicians often give the 'something' mentioned a shorter/easier name like  $x$  or  $y$  or  $z$  or a letter from the Greek alphabet - call it what you wish in algebra, just remember what the abbreviation means*). Calculus in the 1<sup>st</sup> year highlighted Ordinary Differential Equations or ODEs, since I had already met this type of equation at A-Level, these were 'easily' recapped. Intermediate Calculus (2<sup>nd</sup> year) focused on exact methods to solve DEs in 1, 2 & 3 dimensions. Partial Differential equations or PDEs (3<sup>rd</sup> year) focused particularly on equations with physical applications in heat diffusion, waves (such as light & other electromagnetic waves) and traffic flow modelling. Due to the character of these problems an exact solution cannot always be found so we adopt numerical methods to find an 'approximate' solution which is commonly done in real-life contexts.

Applied maths (2<sup>nd</sup> year) and Nonlinear Dynamics (3<sup>rd</sup> year) included mechanics; the study of dynamical systems that could be described by DEs. Several dynamical systems were discussed such as the simple pendulum; the double pendulum; pattern formations (e.g. patterns on tigers & zebras); logistic, population growth and chemical models. Moving from applied maths in the 2<sup>nd</sup> year to final year meant increasing the number of dimensions whilst simultaneously switching from linear problems to nonlinear & here the difficulty of study grew exponentially. Chaos theory featured at the end of this unit which is a branch of maths focusing on the behaviour of systems that are extremely sensitive to initial conditions; the weather & climate are interesting examples of chaotic dynamical systems.

Cryptography (1<sup>st</sup> year) explained how mathematical ciphers used to keep data transmissions secure e.g. in internet banking, (on which the RSA encryption is the basis) involves modular arithmetic & prime numbers.

Real & Complex analysis (2<sup>nd</sup> year) outlined theory behind many of the components of maths in real and complex num-



bers such as series, sequences, functions, differentiation & integration. Real numbers are those we use to count; they extend to both positive & negative infinity (although infinity is not a real number itself, just a concept). In contrast, Complex numbers are those that consist of a real part and an imaginary part, where an imaginary number has the defining property  $\sqrt{-1} = i$ . Mathematicians agree that the name 'imaginary numbers' is misleading; Complex numbers are used in many calculations and are vital in Quantum Physics/Mechanics. A skilled mathematician will find differentiation and integration just as important (but not as easy) as other operations like addition, etc.

Out of the 90 students who had made it to the final year, 3 students (including me) choose Advanced Analysis (3<sup>rd</sup> year) which examined metric and topological spaces. For this unit I was honoured to be taught by Professor Andrew Osbaldestin, Head of the School of Mathematics & Physics. Each week the three of us came to his office to learn new definitions, theories and corresponding proofs that used logic (in relation to concepts like continuity, convergence, etc). Although this was a Pure maths unit, this 'notion of distance' or metric is applied in various applications, e.g. measuring a distance with a tape measure uses the Euclidean metric in real numbers (regardless of your chosen units); however much more intricate metrics exist e.g. in facial recognition & fingerprint matching, metrics for the cosmos, etc.

Introduction to General Relativity & Cosmology (3<sup>rd</sup> year) was another challenge. This was the only unit where I was required to work in 4-dimensions referred to as spacetime. Initially, in 1905 Albert Einstein submitted The Theory of Special Relativity or SR where the equation  $E = mc^2$  became famous. SR is restricted to flat spacetime (Euclidean geometry) or Minkowski space. To explain gravitational effects due

to curved spacetime, Einstein submitted The Theory of General Relativity in 1915 abbreviated GR, it extended work of Isaac Newton on gravitation and generalised SR. *(I can remember in one of the first lectures of this unit whereby we were told in curved spacetime angles in triangles no longer add to 180 degrees, meaning Pythagoras Theorem is restricted to flat space or Euclidean geometry).* In this unit we developed skills like index notation, tensor calculus & calculus of curvature to derive The Einstein (field) Equation:

$G_{\mu\nu} = 8\pi T_{\mu\nu} - 4\Lambda$  basically this version using Einstein summation convention is a set of sixteen nonlinear PDEs linking curvature to matter & energy *(note the appearance of the eminent  $\pi$  (Pi), and the cosmological constant  $\Lambda$ ).* We also focused on the Schwarzschild solution to these equa-

tions, as well as Black holes, Gravitational waves and other related phenomena within the universe. Physicist John Wheeler described the theory of GR in a nutshell by saying: "Spacetime tells matter how to move; matter tells spacetime how to curve." I found the Maths degree (particularly the final year) challenging, but enjoyable. It was a pleasure learning from professionals in the maths field at University of Portsmouth which now has a ranking of 9<sup>th</sup> place for Mathematics in the University league tables 2020. In general, exposure of the UK has been outstanding, that said I am in no hurry to return for lectures/work in the winter season.

I exceedingly congratulate those who graduated alongside of me. I extend thanks to the PAS Post School Scholarship, family & friends (including the late Brian Frederick, & family) as well as previous teachers, lecturers & employers. I now look forward to my immediate future on St Helena.

## EXCO REPORT – TUESDAY 16 JULY 2019

Executive Council met today to discuss, debate and make a decision on two items on the Open Agenda.

A few members of the public were present in the gallery to observe the discussions.

### Climate Change Policy

Executive Council was asked to consider and advise whether the Climate Change Policy, July 2019, should be endorsed. Councillor Yon presented this paper and officials from the Infrastructure & Transport and Environment, Natural Resources & Planning Directorates joined the meeting to participate in this discussion.

Members identified that having such a Policy showed that the Island recognises its responsibility to climate change and furthermore felt it could enhance the Island's external funding prospects. Staff who had put a lot of effort into developing this most welcoming Policy were commended.

Members were happy to endorse the Policy, subject to some minor amendments.

### Civil Aviation (Investigation of Air Accidents and Incidents) Regulation 2019

Executive Council was asked to consider and advise whether the draft Civil Aviation (Investigation of Air Accidents and Incidents) Regulation 2019 for implementation under the Civil Aviation Act 1982 (Overseas Territories) Order 2001 be approved.

This paper was presented by the Acting Attorney General. Members noted that there is an international obligation for this regulation to be in place.

Council approved that draft Regulation subject to slight amendments being made to the wording.

Council also noted at the meeting that the new Building Regulations will come into effect on 16 August 2019.

The meeting ended at 11.50am.

## Unique St Helena stamp collection displayed at the museum

In January Barry Burns and Bernard Mabbett made their fifth visit to St Helena to take on the job of cataloguing the collection stamps which dates back to 1876 and continues up to the present day. The stamps have now been mounted after being sorted and arranged for display. The stamps were stored with the Post Office archives in the cellar at the Castle. Barry and Bernard brought them out in 2013 and started to restore them. The six week visit in January this year was to prepare some stamps for display and make the rest ready for safe storage in the museum's climate-controlled store room. The January visit was funded by a grant from the Heritage Society. There are more than one thousand stamps in the collection.

## The Devil is in the Detail

Time is racing along; I cannot believe that I have now been here for almost three full weeks. I continue to see new faces and have new and interesting conversations on my travels each week. Thank you to those people who have taken the time to stop and natter to me.

I would like to share thoughts which have come out of these conversations with islanders.

An interesting chain of events in the last week, and on Saturday, I was fortunate to be on the other end of the airport welcoming, visitors and returning Saints. Isn't it wonderful how one can now hop onto a flight and be here within six hours from the mainland or even less from Ascension Island?

What I noticed during my time at the airport were the investors (potential and current) coming back and forth and I also got to meet one or two. Interesting.....

It is hoped St Helena is not allowed to become like the many other islands which have been overrun with tourists and ruthless investors who care nothing for the heritage of the island. It is hoped St Helena's heritage is not changed to suit the outside world but rather the outside world continues to enjoy the heritage that is the island.

It would be nice to see legislation change so that properties in Jamestown in a poor state of repair see gentrification for example.

St Helenians are a unique and very proud band of people. It is hoped that investors do not come to this island looking to create a second class citizen – St Helenians. Some may argue that this has been happening since the colonial days, I believe it is our duty as islanders to take a very keen interest

in what is happening with a lot of these initiatives and ensure that we are not 'sold down the river' to the highest bidder. **You do have a say folks, even if we are led to believe that we don't.**

Appreciatively, bills have to be paid; debt has to be limited. That does not mean that we hand over large parts of the island without definitive details as to how this investment is going to benefit the islanders first and foremost.

Note particularly Heads of Terms (details of lease including use, maintenance, liability, insurances etc) and more importantly Landlord / Government control during the period of leasing. The other element to consider is labour. Once these developments are underway:

- What labour workforces will be called in to assist during, on completion and afterwards?
- Will our islanders be given first refusal for most works where they can manage the task within a given time frame?
- What sort of impact will the influx of trades have on the island and its inhabitants?
- How are we going to cope with the vetting of incoming labour?

I suppose just like Basil Read (BR), the workers will come in under a very stringent contract policy which does not put an even further strain on the island resources for the local people? (Medicine, Policing etc.) It is suggested that the BR era was quite a prosperous one for the island?

The devil is in the detail folks. **Pay very close attention to the small print.** Think long-term effects rather than quick wins. Think monopolistic. Isn't it better for all to have some than for some to have all? What political influence will a company owning huge amounts of land have going forward?

I am not adverse, as I am sure most Saints are not, to progress and development but we Saint Helenians want some control / say over how this happens. **We must have an informed say over how this happens.** I appreciate that the money jar is not bottomless and incoming funds is a catalyst for outgoing funds and development. On Tuesday, I was fortunate to attend Exco's discussion on Climate Change and Aviation Legislation. I found the time well spent. It was an eye opener for me having never attended such a meeting on the island before. I'm a huge advocate for Climate Change and Sustainability.

Let us **all** look to refresh our knowledge of policies on this island and how we can all work together to provide a united front in these trying times.

**Don't be left behind as the island progresses.** Believe in yourselves and all that you can accomplish.

A bi-election is coming up, what a wonderful opportunity to have our voices heard? I can immediately think of wonderful candidates currently residing on this island. People who are up to date with the various age groups and have fires raging in them to support progress vs. people.

To the folks who currently sit at the head of our Government – Unless you are prepared to encourage and nurture new members of Government to a higher management plain, you will never get people to stay with long term challenges in view. # ST HELENA WATER LEVELS

## UPDATE

- **Reservoir levels remain dangerously low at just 28 days**
- **No significant rainfall is forecast for the next week**
- **This is an Island-wide issue and until the situation improves we must all restrict our water usage to essential use only**

Daily consumption levels on St Helena remains at just over one million litres of water, but no substantial rainfall means Island water stocks remain dangerously low, with just 28 days of storage water remaining.

It is not forecast for St Helena to experience any significant rainfall over the next week, which means that there will be no surface water run-off going into the Island's reservoirs.

To preserve our precious resource it is important that we continue to cut down our water use to essential use only. Remember that we are currently under a hosepipe ban after Connect Saint Helena (CSH) enforced Island-wide water restrictions on Monday, 24 June 2019.

In the meantime, CSH have continued to pump water from Bore Hole 5 into Hutt's Gate Reservoir – this is why this reservoir seemingly has an elevated level of water stock –



and are then transferring water from Hutt's Gate to Red Hill, via Grapevine Gut.

It is everyone's responsibility to take great care in using our water and consumers are continually urged to reduce consumption wherever possible. St Helena residents, businesses and people who use water for agricultural purposes are also urged to exercise great care and restraint when using water.

As mentioned in the last update, it will also be worthwhile for consumers to regularly check their water meters and monitor water usage to ensure there are no leaks in their system. CSH have issued a guide on how to do this (attached).

Regular updates on reservoir levels will be issued to the public.

If you see anyone using water irresponsibly or notice a burst pipe or leak then please inform CSH immediately.

## HAND, FOOT AND MOUTH DISEASE ON ST HELENA

The Health Directorate is aware of a very small number of Hand, Foot and Mouth Disease cases. As a precautionary measure, the following information is being released:

**Hand, Foot and Mouth Disease is a viral infection that can affect young children.** It does not usually pose a serious threat to a child's health but can be an unpleasant condition particularly if it affects younger children.

Typical symptoms of Hand, Foot and Mouth Disease include:

- Cold-like symptoms, such as loss of appetite, cough and a moderately high temperature of around 38-39°C (100.4-102.2°F)
- A non-itchy red rash, made up of spots or small fluid-filled sacs (vesicles), which usually develop on the hands and feet, but may also occur on the knees, elbows, groin and buttocks – sometimes the rash can develop into painful blisters
- Painful mouth ulcers

Hand, Foot and Mouth Disease is a self-limiting condition, which means **it will get better on its own without treatment. The symptoms will usually pass within seven days.**

However, the symptoms can be uncomfortable so possible treatment options include:

- Using **paracetamol**, **ibuprofen** and **mouth gels** to relieve the pain of mouth ulcers
- Drinking plenty of **fluids** to help relieve a high temperature

These items can all be obtained from the **Pharmacy** or from **local stores**. **There is no need to see a Doctor for this condition.**

**But you should contact your Doctor if your child is not drinking any fluid or their symptoms last longer than seven days.**

A person with Hand, Foot and Mouth Disease is **highly contagious** until about a week after the symptoms begin. Because of the way the infection is spread, outbreaks of the disease can occur in places where groups of children need to have their nappies changed or use a potty, such as nurseries or childcare centres.

You should keep your child away from school or nursery while they are unwell.

However, there is no need to wait until the last blister has gone before your child can return to school or nursery, providing they are otherwise well.

The Health Directorate cannot issue sick certificates for parents whose children are unwell. Please contact your HR department for guidance on Parental or Emergency leave.

## READING YOUR WATER METER

In last week's newspapers, Connect Saint Helena Ltd suggested that households check their water meter on a weekly basis to determine if you are using more water than you are aware of, and if so this might mean that you have a water leak on your property.

How many of us though know how to read our water meter, to see how much water we're using in a week? For those who do not, we hope you find the below instructions helpful.



Step 1: Make note of the numbers in black on your water meter.

Step 2: After a week, record your water meter reading again.

Step 3: Minus your first reading from the last reading. The answer will be the number of units used in that week.

Note: One unit equates to one cubic metre. If you want to convert this to litres, then times the number of units by 1,000.

Continue to do this exercise for at least a month to see if there are any abnormalities in your water usage.

You can also try setting a goal for you and your household to reduce your water usage each week by using our water saving tips.

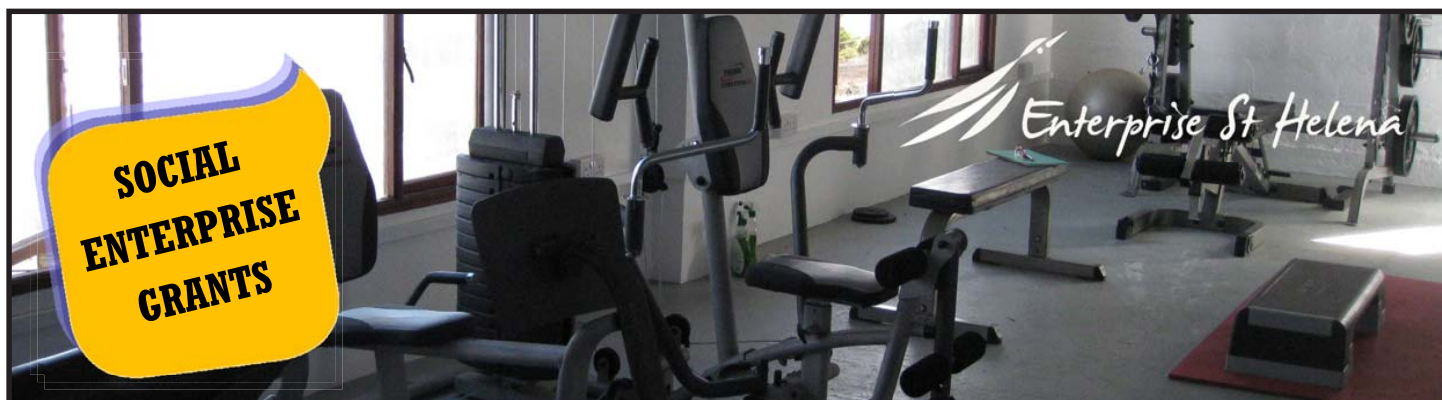

# Keeping Up with Saints Abroad!

*This week the spotlight is on: Paige Augustus*

Paige Augustus is a 23 year old Saint Helenian who grew up here on the Island, in Half Tree Hollow where she lived with her Nan, Prudence Augustus. She attended Prince Andrew School up until 2009 when she was 13 years old and then left for the UK to continue her schooling.

Paige told the Independent, "My parents lived abroad and my Nan brought me up until I was thirteen, I decided to move to the UK to continue my schooling as my mum didn't want me to stress Nan any more with teenage tantrums." She stayed in the UK until she was 18 years old.

Thereafter Paige moved to Abu Dhabi in the United Emirates, where she worked as a teacher at an American style university campus. "During my time in the middle east I was fortunate to travel a lot including Oman, parts of Asia and Thailand. I once made a journey to Sri Lanka all on my own, which was an adventure for 10 days," she said.

Apart from the UK and Abu Dhabi, Paige has also travelled to Cape Town, Ascension and Dubai. Out of all the places she has travelled she said, "Abu Dhabi and Dubai are my favourite places to live and visit, the stress free life style and living in a multicultural city was a great experience. It's also one of the top safest cities to live in the world."

Paige previously studied at Bath College, but also did some additional studies in the Middle East. She is currently working for Carnival Cruise Lines, having been with them for the last 4 months in the Entertainment Department onboard the cruise ship 'Carnival Valor' where she shares a cabin with a friend from England, whom she said is also "on the same journey in life" as herself. The ship is home to over 1180 crew members and carries 3000 passengers; it has a gross tonnage of 110,000 and is 955 feet long. Paige added "Living on a ship is very different to anywhere else I have lived; no two days are alike, especially when living with mixed nationalities and almost every day stopping over at a new port."

Furthermore, Paige explained that her normal journey begins in New Orleans, USA, then sailing down the Mississippi River to the Gulf of Mexico, where the ship makes port calls daily. Her occupation and role, working with a busy team of people, is to make sure children of any age up to teenagers, (and sometimes numbering 1000), are kept entertained and out of trouble whilst onboard. However, Paige said she is able to



use the passenger deck facilities and can take a break from ship-life when in port, to travel on excursions ashore.

She explained that she was inspired by the "great opportunity to go west which is something I've always wanted to do". After applying for the job whilst she was living in Abu Dhabi, and a consequent successful interview, she was selected to board her first ship in Galveston, Texas in March this year. She added that she enjoys meeting new people, travelling, (which is her passion) and experiencing the cultures and heritages of people living in different parts of the world.

Since leaving St. Helena she said that she has gained many life experiences and great memories. She believes that she has changed, as she is more independent and more appreciative of the little things on St. Helena, especially when she compares our way of life with that of other countries. Paige admits to missing a lot about St. Helena, including friends, family and "some of the things that I took for granted when I lived there". She is planning on coming back to the island, however "hoping my parents are going to surprise me with a free air ticket first (hint hint)".

Paige describes herself as outgoing, adventurous and a people's person and enjoys swimming, listening to music, retail therapy and also getting her nails done during her free time. She also likes to catch up with friends that she has met from around the globe.

As a child she dreamed of being an actress, like Mary-Kate and Ashley Olsen and even though she has a role model she keeps it a secret and states "they will get a big head". However "my close family inspires me, although they worry about me, they have never discouraged me from doing anything that I enjoy. My family have continued to motivate me and have given me some great opportunities."

In conclusion she is grateful for the opportunity to share her story with others and states that "even though it might not be the most exciting, some might be inspired by it".

Her advice to other young people who would like to venture off the island is, "if you have a passion to travel and see new places, please take any opportunity that comes along, as it will give you great life experiences and it will be a stepping stone for your next travel adventure."

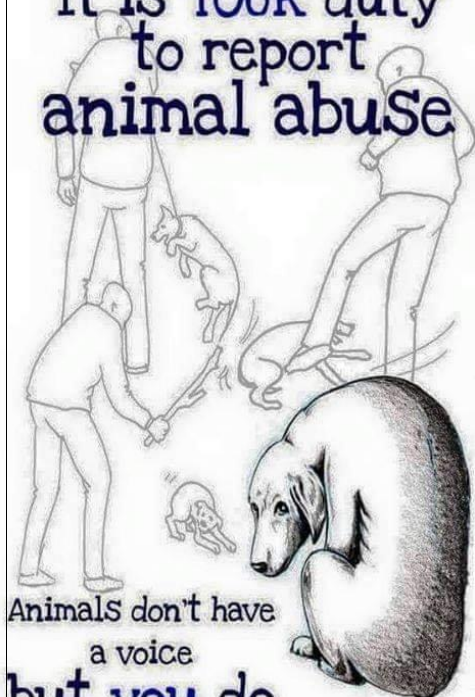

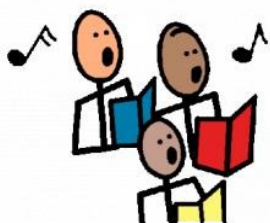
