Dr Earle identified Ascension Island's offshore waters as a 'Hope Spot' – an ideal location for a large scale marine protected area – and her visit, along with RSPB, was to raise awareness of the unique marine biodiversity found in Ascension's waters.

Here on Ascension Island we feel privileged to have known Kate and our thoughts and prayers are with her family at this incredibly sad time.

In memory of Kate Downes – 8 July 1988 to 7 June 2020

On a bitterly cold November evening in 2017, the Blue Marine team gathered at a coffee warehouse in East London. One of the sponsors of the London to Monaco cycle ride was hosting an event at which Kate Downes was to speak about her tuna tagging work around Ascension. I was secretly anxious that the talk would be too dryly scientific for the audience which consisted of sporty cyclists.

I needn't have worried. As soon as Kate started to speak, her humour, enthusiasm and love for her work, combined with her huge knowledge, had the audience enrapt. Everyone wanted to know more about this extraordinary island in the middle of the Atlantic. Everyone started to grasp how we might better manage our seas. Everyone would consider where their tuna came from – rather than just saying 'from a can'.

Kate's unfair and untimely death from a brain tumour at the age of only 31 has left the BLUE team shocked and saddened. We are struggling to believe that a talented scientist a warm-hearted person should be taken so young. We are determined that her pioneering work should be completed. Luckily, we were able to tell Kate before she died that we had secured funding so that Dr Sam Weber at Exeter University could finish her PhD.

Kate's PhD, based on years of tuna tagging work on Ascension, shows that yellowfin tuna there are slower-growing and longer-lived than was previously estimated. It demonstrates the importance of Ascension's marine protected area – currently the largest no-take zone in the Atlantic – for providing a sanctuary for fish whose stocks have been in continuous decline since the 1950s. When the PhD is published, we hope that it will add to other work which shows what an exceptional place Ascension is, and how many more marine biologists

should base their studies on these pristine and unique waters.

Kate's last email to us at BLUE was typically generous and thoughtful: she asked that her underwater camera equipment be donated to the marine team on St Helena. She said: 'I am donating the camera, housing and strobe to Blue Ma-

'I am donating the camera, housing and strobe to Blue Marine Foundation to be used for whale shark ID photos on St Helena or whatever the team thinks it should be used for. Ascension and St Helena are so very important to me and I'm glad I can leave a legacy that shows that.

It has been a pleasure to work with you all.

We at BLUE will do what we can to ensure that Kate's memory endures, through her work, through the work of the St Helena National Trust marine team, through Ascension's world-leading marine protected area and through the IUCN Category VI marine protected area on St Helena. Some News Bits from the Week

Hong Kong and the Chagos Islands

Here's an extract from the statement made by the UK Foreign Secretary on Wednesday 1st July after the Chinese Government finally decided to ignore the 1984 Treaty between Britain and China on the handover of Hong Kong and send in their Heavy Mob.

"We want a positive relationship with China, but we will not look the other way when it comes to Hong Kong and we will not duck our historic responsibilities to its people. We will continue to bring together our international partners, to stand up for the people of Hong Kong, to call out the violations of their freedoms, and to hold China to its international obligations, freely assumed under international law."

On 25th February 2019 the situation was very different. The International Court of Justice (ICJ) gave an advisory opinion (not a ruling) that "the United Kingdom's continued administration of the Chagos Archipelago constitutes a wrongful act." And "It is an unlawful act of a continuing character which arose as a result of the separation of the Chagos Archipelago from Mauritius." The United Nations General Assembly supported the ICJ decision by 116 votes to 6.

On 30th April 2019 the UK Government made its official response; "we have no doubt about our sovereignty over the Chagos Archipelago, which has been under continuous British sovereignty since 1814. Mauritius has never held sovereignty over the Archipelago and we do not recognise its claim. We have, however, made a long-standing commitment since 1965 to cede sovereignty of the territory to Mauritius when it is no longer required for defence purposes. We stand by that commitment."

While the United States uses Diego Garcia, the biggest of the Chagos Islands as an air force and naval base the Chagossians who were forcibly evicted from their homeland to make way for the US military remain divorced from their culture and the land of their birth. While the Foreign Secretary takes the moral high ground to stand up for the people of Hong Kong he remains with his back turned to the plight of the Chagossians.

Boris Johnson spurns legacy of the St Helena Act 1833

One provision in the St Helena Act 1833 was to recruit civil servants through open competition and not by nomination. This was the first move to stop favouritism and nepotism in a 'jobs for the boys' culture in civil service recruitment where if 'Bob was your uncle' you could sit back and have a comfortable and well paid job for life. Other civil service reforms followed and it was not until 20 years later that open recruitment became established as the only way to start a career in the British civil service.

Now Prime Minister Johnson, his minsters and advisors have started to turn the clock back more than 150 years. In April Sir Philip Rutnam, the most senior civil servant at the Home Office started legal proceedings against the UK Government claiming he was forced from office by the bullying treatment and actions of Priti Patel the Home Secretary. Johnson gave Patel his whole-hearted support.

Next for the chop was the most senior, senior civil servant of them all. Johnson forced out Sir Mark Sedwill, the senior civil servant who works with the prime minister. A political appointee was drafted in to take over part of Sedwill's job but essentially the post is expected to remain vacant for a few months. The political appointee has no experience of that part of Sedwill's job he has been given. Bringing in political appointees to civil service jobs is a definite move back by a 150 year jump.

Next to go was Sir Simon MacDonald, the senior civil servant at the Foreign and Commonwealth Office, Head of the Diplomatic Service and a recent visitor to St Helena. MacDonald resigned soon after Sedwill was forced out.

The UK Government is now seen as being run by the prime minister, one of his favourite ministers and the prime minister's favourite and eccentric (I make the rules then break them) personal advisor. The long-standing and hard won tradition of aspiring to have a 'loyal and neutral' civil service looks to be under attack. As one UK newspaper headline put it, "Johnson wants to build Britain up again - but all he knows is how to break it". Once more, the worst of how things are done in the United States is being imported to Britain.

A Water Resources Strategy is needed Followed by a Water Resources Management Plan

A Water Resources Strategy has been published this month in draft form and is due to start the usual round of public consultation. The overall aims of the strategy are:

- i. Ensure that sufficient quality and quantity of water is available to support healthy living
- ii. Ensure that sufficient quality and quantity of water is available to sustain economic activity
- iii. Ensure that sufficient quality and quantity of water is available to sustain food security

There will probably not be too many people to argue with that; except there is no overall aim that recognises the need for Value for Money. There is probably no need to worry on that score because, "Ensure that water resources and associated infrastructure assets are managed efficiently to minimise the cost of water to all consumers" is one of the seven principles. Next there are the Objectives, four of them; Water security, Drinking water quality, Water affordability and Water sustainability.

Further into the small print we move on to a30 year Water Resources Management Plan which highlights water leakage reduction programmes and water efficiency incentive schemes. The water efficiency refers customers usage not collection and distribution so the incentive may well be to pay higher rates if you use more. There are 44 pages of facts, figures and information in the strategy document which deals with the future of our most valued resource.

Tomorrow's 4th July. Lots of things happened on 4th July – in different years. In 1837 the world's first long distance railway opened between Birmingham and Liverpool – 98 miles was a long distance 180 years ago. In 1829 the first bus service, the Shillibeer Omnibus was routed through Central London. On the same day in 1810 French troops occupied Amsterdam. In 1779 the French Navy occupied Grenada. In 1807 Guiseppe Garibaldi, famous for unifying Italy (and baking biscuits) was born on this day. What definitely did not happen on 4th July was the signing of the Declaration of Independence by the United States. The resolution to break

away from Britain was passed on 7th June then a 'working group' was deployed to write the Declaration. The Continental Congress approved the working group's version on 2nd July. The actual signing of the document took a long time as it had to be sent all around the country to get signatures. Tomorrow Trump is due to hold an hour-long press conference where he will ramble on for at least an hour telling anyone who will listen that "the whole independence thing" is a fraud and a fake – and it's all the fault of CNN and the New York Times.

Finally, a little more on the Equiano Cable; more information trickling in suggests there should be no significant delay due to Covid 19 and perhaps no delay at all. The French company making the cable did close down because of the coronavirus but is now working flat out producing long lengths of cable. The main concern here is to get the cable landing station in Rupert's completed on time, and to budget. There have been no postponed deadlines for finishing that job.

My View on New Tobacco Legislation

It did not go unnoticed that our dear Councillors passed new tobacco legislation in their formal meeting this week. Once again, there will be more restrictions on the sale of tobacco, how it is sold and where you can smoke. One of the most controversial parts of the new legislation is that you cannot sell individual cigarettes, they can only be purchased in whole packets of 20. How this would benefit anything is beyond me. Some people can only afford to buy a few cigarettes and why can't they continue to be allowed to do what they enjoy? It has been said that this is to stop children and youngsters from start smoking. This is absolute nonsense, they will buy their cigarettes from friend or somebody else in the street instead. The sellers in the street do not apply any age restrictions to their customers.

It seems like the tobacco smokers and alcohol drinkers should be penalised for habits which is actually subsidising the Island. Nobody can say that drinking and smoking is good for you (my liver can tell you) but these habits are most definitely not a financial burden on our society. Look at some simple figures from this year's budget.

SHG has a budget of about £49.1 million this financial year, of this £34.3 million comes from UK and only £14.1 is raised locally. This means that 28.6% of all the money SHG is spending come from St Helena tax payers.

If we look at the Public Health Directorate, they have a budget of £5.6 million for this financial year. If we apply the same calculation to Health as for the entire SHG we come to an

astonishing result. Alcohol drinkers and tobacco smokers contribute more to the Health budget than the Directorate spends from local sources. Of the £5.6 million spent on Health, 28.6%, or £1.6 million comes from the local tax payer and the rest from UK. As the budget book for this year tells us that the specific duty on alcohol and tobacco is almost £2.1 million (2.07million), drinkers and smokers pay for the entire local funding of the Public Health Directorate and almost half a million more than that – is that fair?-obviously not. Drinkers and smokers are subsidising the rest of the society with large amounts of money and still the authorities want to penalise us further in all ways they can.

Why should a packet of cigarettes be twice as expensive in St Helena as in UK? In UK you can buy a packet of cigarettes for 1 hours work on a normal wage, in St Helena you have to work 2 hours for a packet of cigarettes.

We are constantly complaining about an aging population on the Island and the costs associated with looking after old people. If smokers and drinkers die a bit younger because of their habit it will save even more money in institutional care, benefits and pension payments. Drinkers and smokers are the economic pillars of our society, cherish then, don't penalise them.

I think that the biggest political problem in Council is that we have more pot smokers than tobacko smokers in the seats. *Mike*

WORKSHOP TO DISCUSS ST HELENA TUNA FISHERY STATUS & MANAGEMENT ADVICE REPORT

Fisheries stakeholders, the Environment, Natural Resources & Planning Directorate's (ENR&P) marine and fisheries team and a number of Elected Members yesterday afternoon attended a workshop led by the Blue Belt team to discuss the St Helena Tuna Fishery Status and Management Advice report recently released by the Centre for Environment, Fisheries and Aquaculture Science (Cefas) as part of the UK Government's Blue Belt programme. The production of the report follows a five-year period of tuna tagging across multiple programmes, collates data from historic local landings, local knowledge and at sea observer data from biological sampling.

A presentation of the key components of the Report was provided by Cefas and there was opportunity for all involved to ask questions, seek clarification where necessary and generally to comment on the contents of the Report. The St Helena Government and Blue Belt teams are hopeful that stakeholders were able to be further informed on the Report and its use to inform fisheries management going forward.

Stakeholders also have the added opportunity of providing written comments to the Blue Belt team by Friday afternoon

for their consideration before the Report is finalised. $\ensuremath{\mathsf{SHG}}$



Dear Editor,

We understand the necessity for container handling and warehousing in Ruperts. However the current plans are concentrated in an area below Hay Town House and the walls of the fort. This area has a number of other interests and demands including provision for dealing with passengers from cruise ships unable to land at the wharf at Jamestown ((which will also involves improving Rupert's road); restricted access to the beach important to Islanders for leisure; historic aspects of the fort and the Boers; fisheries development; liberated African depot; to name most. The public understood that an area larger than that in the plan and without these interests and demands was identified at the upper part of Rupert's Valley previously levelled and used for concreting sections of the breakwater.

What is of particular concern in the plans is that it includes the only building left standing connected with the liberated African depot. That building, locally called the hospital and No 1 building in the records, is a monument to commemorate the horrors of the transatlantic slave trade and the role St Helena played in its abolition. It is of great international importance. Though the building was erected when transporting slaves across the Atlantic was being stopped, it is of such a permanent structure and fine stone masonry that it shows

the island was preparing and committed to its role in the transatlantic slave trade for a longer period of time. About 26,000 slaves were brought to St Helena to be freed. Many in the region of 8,000 died on or shortly after arrival. The majority are buried in Ruperts. Records show that most of the people employed at the depot were Islanders. They were constantly at risk from diseases in caring for the slaves. There are plans to build a memorial to the 325 slave remains uncovered in excavating for the It is understood that the haul road. building now standing will be used as an information centre. It will stand as a monument to all transatlantic slaves who died on the island and the role St Helena and its people played in caring for those who survived. The building as a monument will tell their story and keep alive these memories. It has to be in a setting that shows respect for the many slaves who died and are buried in the various graves in Ruperts Valley. A monument of such global importance should be given the respect it deserves and not be within a wire-fenced, container compound.



Tourism Recovery Strategy discussion attracts 70 people

St Helena Tourism organised a meeting on Tuesday evening for private sector tourism businesses to discuss different ways to attract tourists to St Helena when the Covid pandemic has passed.

Earlier this month the SHG Economic Development Committee discussed a revised Tourism Marketing Strategy which is being drafted by the Director of Tourism for consultation with Elected Members and other stakeholders. The seventy people attending on Tuesday evening presumably did so in order to make their views known on what the strategy should be. As it turned out, it was not as simple as what might be presumed

Tourism Director Helena Bennett opened the discussion explaining that St Helena Tourism wanted the views of everyone attending without being first guided by tourism officials on the direction the strategy should go. Discussion would start with a blank sheet of paper. Helena then went on to say that the main target for visitors to St Helena is the UK and Europe and that the air service would restart from Johannesburg with additional flights from Cape Town in the peak season - whenever the next peak season may be. She continued to fill in some of the blanks by pointing out that a focus on marine activities as the most successful commercial attraction for visitors to St Helena was a preferred option, supported by the attractions the Island offers to walkers and hikers. The seventy people where then organised into seven discussion groups and asked to come back in half-an-hour with some suggestions on what St Helena Tourism should focus on in the immediate to short term and in the medium to long term. Views were also sought on what are the barriers to tourism growth and ways to avoid those barriers.

The groups discussed a range of things during the thirty minutes and tried to do so strategically. There was a common belief that the air service should be a direct flight from the UK instead of connecting to the international air transport hub at OR Tambo airport. It was, after all, recognised that the UK and Europe was the main tourist market for St Helena and it is likely a direct flight from the UK would be the best way to attract tourists in numbers when the Covid pandemic recedes. It was also pointed out by some discussion groups that when air travel resumes, dealing with the UK instead of South Africa appears to be the preferred option.

Different ways of marketing and promoting St Helena were suggested, including continued emphasis on the recently adopted use of a wider range of digital platforms to promote






St Helena to tour operators and booking agents in the UK. This new development, in association with the Brighter Group, St Helena Tourism's UK PR agency, is to be extended to France and Germany. A better stream of information to stakeholders about what the Brighter Group is doing on behalf of St Helena was also requested.

While marine activities can be central in promotion campaigns which highlight the attractions of St Helena it was generally thought the other attractions should not be forgotten and the range of attractions should be widened if possible. It was pointed out that a hiker or walker is often a star gazer too and someone who likes to swim with whale sharks may also have an interest in one of the many aspects of history which can be experienced first-hand in St Helena. Our endemic land bird and sea bird should not be forgotten.

Tourism services providers have been surviving, almost, without any tourists for three months now. It was pointed out in Helena Bennett's introduction that the financial support to tourism services finished the same day as this meeting on the future of St Helena Tourism. Further support for tourism services until the tourists start to return did not figure prominently in the immediate or short term list of subjects St Helena Tourism should focus on.

Should St Helena be so dependent on South Africa? This was one of several questions raised at Tuesday's tourism meeting.

Improving services offered to tourists was also included in the Strategy. This is a continuing theme which was first introduced by the first Tourism Director, Mike Dean. A common reaction from people attending the meeting as they left when it was all over was that most of the topics for discussion were a reworking of old themes.

Google is developing networks of balloons which fly in the stratosphere; their purpose is to connect remote locations where internet accessibility is non-existent or sub-standard. They are a low cost solution for connecting low populated and remote areas compared to the traditional towers built on the ground. Balloons can cover a wider communication area than towers and are operationally more flexible. They are controlled remotely from the ground and 'piloted' by increasing and decreasing height to find the best wind to propel them where they need to go. It has been found possible to guide the balloon into a figure 8 manoeuvre to keep them above a specific area. However, the balloons do crash to the ground from time to time.

There have been reports that balloons have drifted off course and get lost. One or two have been tracked flying close to St Helena. Unfortunately this has no advantage for us. The signals from the balloons need to connect with a ground station in the same way the high speed data from submarine cables needs to be landed for onward transmission to earthbound users via a ground station. With no ground station on St Helena, yet, there is no way the balloons can be used to improve our internet speed.

The balloon communications network is being developed by a company called Google Loon which was formed as a wholly owned subsidiary of Google in 2018 to take over the project work previously under the direct control of Google. Kenya, Sri Lanka and Puerto Rico are in the list of countries benefit-


The Equiano Cable

St Helena awaits the arrival of the Equiano Cable which in precoronavirus days was scheduled for next year. More recent estimates now set completion at early 2022 but it is recognised the full effects of the pandemic have not been officially announced by Google; who are most likely still assessing what the full effect will be. It is anticipated there will be a clearer indication by the end of the year of what the revised schedule for the Equiano Cable will be.

JAMESTOWN WHARF ACCESS RESTRICTIONS

Port Control would like to advise that access to the Jamestown Wharf will be restricted to members of the public from Monday, 6 July 2020, for approximately two weeks.

The restrictions will be in place between 7am to 11.30am and 12.30pm to 4.30pm, weekdays only (Monday to Friday).



These access restrictions are to allow CAN France to complete all the parts of the rockfall protection measures on the wall along Sisters Walk.

- Pedestrian access will be via a shuttle bus from the first security barrier (outside the Customs & Port Control building) to the End Steps, running approximately every 20 minutes.

The Budget Speech - Give Me the Good News

It has become a feature in recent years for the Financial Secretary to list some of the achievements and good news of the last financial year. This is normally done early in the speech, before giving the not so good news for the year ahead. Looking back over the last 15 months the Financial Secretary reminded us:

- To date, we have successfully kept the Island COVID 19 free. New coronavirus testing services were developed, supplies were received and the quarantine, isolation and medical facilities at Bradleys' were developed in an incredible 6 weeks, all significant achievements given the limited resources available
- Standard and Poor's (S&P) awarded St Helena an investment grade credit rating of BBB- this year.
- SHG received the second tranche of EDF 11 funding from the EU amounting to €.5 million which will be used to fund the St Helena branch on the Equiano cable project.
- The Gibraltar International Bank is offering international bank accounts to local residents and businesses.
- The UK Government approved a new economic development capital investment programme of £30 million over 6 years.
- SHG rolled out a new Labour Market Strategy which focuses on developing our working age population both now and in the future.
- v The launch of the St Helena Research institute oc-

curred in November 2019 with the aim to attract visiting researchers.

- The New Earth Station licensing policy was agreed, laying the groundwork for a new revenue stream made possible through the fibre optic cable.
- We have been exploring other new revenue streams such as through ship registry and company registry
- There has been refurbishment of 6 Government Landlord Housing, this coupled with some reorganisation has seen the housing register waiting list reduced by 20%.
- We now have planning permission for the Comprehensive Development Area (CDA) at Bottom Woods.
- The Investment Prospectus was endorsed and launched in October 2019 and has stimulated interest in developing a number of SHG's strategic assets into business premises.
- 15 staff in the Education Directorate have achieved success in their studies with 100% pass rate.
- 24 Orthopaedic operations were undertaken on Island during the last year avoiding costs associated with overseas referrals and ensuring patients could recover in the comfort of familiar surroundings.
- 43% of the cohort achieved 5 or more GCSE's at Grade C and above
- We have 9 students studying degrees overseas through the scholarship programme who will return bringing new skills with a long term view of filling key roles across the Island.

Birthday Numbers

Wednesday this week, 1 July, the *Inside St Helena* app celebrated its first full year of operation.

Registered users with the app at time of writing this (Tue 30 June) was 2,514 with 567 of those users here on St Helena. The UK registers the most users at 1,016 and South Africa, 281.

'Live' monthly page views average 62,372 (when the app user is online). Our highest single-day 'live' activity was 21 May, 2020, for our St Helena Day event celebration, registering 9,940 page views in 24 hours.

Note: The app is also designed to work offline; when this occurs the usage stats are not recorded.

Across the world, digital-based economic activity has shown a certain resilience against the impacts of Coronavirus. So it is pleasing to know we have demonstrated the viability of app technology here on St Helena.


Taking Risks & Making It Work

Although complete newbies to app design, we have been able to draw on our extensive experience in website design, photography, journalism, marketing and design, which combined to help make this first year of *Inside St Helena* work so well.

We have always seen ourselves as home-grown, private investors in St Helena's economy. The risk is usually higher with ventures involving innovation, a reason why the project took two years to carefully plan and launch. But now, with a full year of experience and insight into the capabilities of this technology it's been exciting to realise there is even more potential for *Inside St Helena* to facilitate business development across almost every sector. Likewise, we can now see how a similar approach with this technology could offer viable solutions to known problems within other areas of the economy.

The Ups and Downs

or making an appointment at the hair salon.

Inside St Helena makes it very easy and extremely affordable for even the smallest businesses, to instantly establish an effective digital presence and attract customers. The app is promoted by its own website and social media channels, as well as the digital platforms of What The Saints Did Next, plus those of other members and supporters.

As part of the *Inside St Helena* service we have also designed and delivered training courses on how businesses can use social media for their own marketing.

Highlight of year one has to be the incredibly successful 'Engage 2020,' the island's first private-sector business conference organised exclusively for *Inside St Helena* members. Networking and bringing people together to learn, problemsolve and share ideas.

Covid-19 is the latest challenge to tackle as we head into year two. But already we have been active with new strategies to adapt to the uncertain climate ahead.

The New Normal

Please excuse me dear friends for having been 'absent' for a while now. I trust you are all faring well?

A lot has happened, hasn't it? It seems like only yesterday that I got back in time to Blighty from my travels. Yet, over three months has elapsed, where has time gone? A friend was telling me that it took his friends two months to get home from Malaysia. I was extremely fortunate in my situation.

Liverpool has been very kind to me. I am glad that I have experienced the City in lockdown. It is a far cry from two nights ago when hundreds of people celebrated the LFC win on the docks. I walked on the periphery of the celebrations. I took some memorable photos. Unfortunately, those who condemn LFC fans will no doubt have also seen the thousands protesting and the beaches packed with sun seekers. I would prefer not to condemn but simply observe that we all could do better with our irrational behaviour. Any football club having just won the premiership would have celebrated. Fact. LFC has a most passionate following and the celebration unfortunately bears testament to this. I do however think Liverpool could do better with its litter daily, when I go out for my runs, I sometimes have to clear the path on the Museum steps of litter.

Since giving up drinking on 23rd March, I have managed to abstain and am thoroughly enjoying the life of sobriety. It's only when one takes the step to change and maintains this commitment that one realises foolery of the life left behind. So whilst I observed the LFC celebrations, I also observed the vomiting, the urinating in street corners, the sleeping on benches, the anti-social behaviour and I felt happier that I wasn't party to this.

There are four reasons which helped me to give up drinking: I saw the effect it had on others dear to me

I realised the limited life I was living with my binge sessions I started to research the damage to a person's body and brain especially from a certain age and beyond a certain age from substance abuse

I knew it was holding me back from emotional healing

I did not have the social pressure to continue. I did not have friends who weren't supportive. I wanted more from life than the blurry days of alcohol. Moderation was not possible for me, it is for some. I could perhaps take the risk but I've grown to love the taste of tea and no longer need the taste of alcohol. It's all psychological, not physical. It's dealing with the triggers as opposed to the action.

It has been a blessing to communicate with people during this period although I have kept myself very busy. This time alone has been a gift. I have never spent this amount of time on my own and whilst some days, I found things very tough, I embraced the feelings of adversity and went through it, rather than around it. What I've realised is that I no longer need all the external trimmings that I thought I needed. I've read a lot. I have learnt so much. I spent the last 40 years living a lie. Living a life which was so far from authentic. The freedom from convention has allowed me to reassess everything. Praise God.



I ceased to use Social Media. I still have an instagram account but only to reference posts for my writing, not to post anything anymore or review any profiles. When we look at the world today, it seems foolhardy to ignore warnings around social media addiction. I think the internet is a wonderful tool for learning, I just don't agree with the third party marketing and advertising. There is a reason why people like Jaron Lanier advocate against social media tricks to get people addicted. I still communicate with my family and friends abroad and I am not using platforms, so it works. I don't need them. When we watch the lives of others so incessantly it can detract from the efforts for our own lives. I want to still enjoy intimate, social contact.

It was very sad to hear that Dfid is being merged with FCO. I have been reading a lot about crisis pre and post WW2 and I hope that Britain continues to support the overseas territories. Whilst WW2 may have been won, Britain turned its back (as did the US) on countries which had been part of its empire, "wiping its feet on the way out". I am very uncomfortable with the gap between poverty and the rich. Boris Johnson may tell Brits that there will not be long periods of austerity, 'someone' always draws the short straw. I pray that St Helena will not suffer because Governments have continued to mismanage situations. We look at our history and very often, we are selective about it. Having finished Churchill's biography, I have very mixed feelings about his internal vs. external battles. One thing is for sure, his ego (like many other leaders) could also be very damaging.

I respect the roles that Government play but when did we lose so much trust in our Governments? We do have to work together to achieve results. We cannot continue to tarnish people based on the past, but I think populations need to start believing that Governments *truly* want to achieve a better humanitarian balance. It seems to be the financial institutions and the very wealthy who's wealth floats about in the 'clouds' that are immune to these tough times. That in my eyes is not fair. I never understand why one group of people has to have so much money. I could never sleep in my bed at night with so much surplus whilst others languish with so little.

Here's a book that I recommend called "Manifesto for a Moral

The New Normal

Revolution" by Jacqueline Novogratz. Its a wonderful collaboration of stories and thoughts around micro-financing in third world countries. It got me thinking about how St Helenians can ensure we are tapping into every market possible around sustainability. So much has already been done. I see the island as a beacon in a world where consumption and destruction of natural resources has become so understated. It was one of the more uncomfortable topics of discussion for me in Canada.

Trump and his administration, I hope, will be a thing of the past come November. The damage that he and his like-minded followers have caused to the US cannot go on for a second term. In speaking to my cousin in Portland OR, she mentioned that they have returned to physical ballots because of the corruption around electronic balloting. The increased activity of right-wing groups disturbed me and not enough condemnation of them came from the government. Everything that Trump represents contradicts the good old Declaration of Independence. How can LGBT employees have to fight for their rights to peaceful and compassionate employment in the 21st century? It simply reminds me (like Dr King advocated) that the world can never rest on its laurels when it comes to the fight for equality and freedom.

We should not fear each other. We should not fear change. We should always try to be part of it with peaceful, constructive negotiations.



The one thing I am trying to do more of these days is to listen and understand why, before I jump two feet in. Have a lovely weekend my fellow Islanders - *Addie*

FLIGHTS TO AND FROM ST HELENA ISLAND

On 1 June 2020 South Africa relaxed their lockdown restrictions to level 3 which allows for restricted domestic flights (within South Africa). Scheduled international flights are not expected to be permitted to resume until the country moves to at least level 1. It is not currently known when South Africa will move to level 1 but this is not expected within the next three months. Globally many other states still have travel bans and restrictions in place.

Based on those registering interest with the St Helena Tourist Office, St Helena Government (SHG) has identified the need for a second repatriation charter flight to the UK or Europe. Planning for this flight is in progress with a target to operate within the next eight weeks.

Availability of both inbound and outbound seats on this flight will be assigned on a priority basis as per the previous repatriation flights. The passenger capacity of this flight is not yet known and will be dependent on the aircraft and route chosen. The number of passengers arriving to St Helena will also be limited by the capacity at Bradley's Camp for the mandatory 14-day quarantine.

FAQS

Below are common questions received and answers provided on future travel arrangements to and from St Helena:

Travel requests

Who can travel on the repatriation flight?

Travel requests will be prioritised against essential travel criteria (for example, persons needing to return to their country of normal residence or persons needing to travel on medical grounds).

I am normally resident on St Helena, can I travel off-Island for leave/temporary break?

It is likely that those wishing to depart St Helena on a temporary basis for non-essential purposes will not be given high priority for seat allocation.

Those considering travelling must take into consideration that quarantine measures remain mandatory in some countries. In addition, it is not known when another flight will be operated to and from St Helena to enable return to the Island. Finally, in order to comply with the current legislation, upon return all persons arriving to St Helena will be subject to 14 days quarantine at Bradley's Camp.

Who is the point of contact for registering interest to travel to and from St Helena Island?

All persons interested in returning to or leaving St Helena should register their name with the Tourist Office by contacting christina.plato@tourism.co.sh or calling +(290) 22158.

You will be asked to provide your full name, address, date of birth, nationality, passport details, contact details, the country you wish to travel to, and reason for travel.

If you are travelling as part of a group, please provide these details for each person in the group. You should also identify which member of the group will serve as the point of contact.

Once registered on the list, persons will be kept updated via the contact details provided.

It is important that the Tourist Office is advised of any change in status or requirements.

The Tourist Office is not able to engage with airlines, insurance companies or booking agents on behalf of persons wishing to travel.

What is the cost of a ticket on the repatriation charter flight?

Until the details of the flight are finalised the cost of a ticket cannot be determined. Once information on ticket cost is available it will be released to those who have registered with the Tourist Office.

Is there a cost for quarantine on St Helena for incoming passengers? If so, what is the cost?

Persons may be required to contribute towards the cost of their stay in quarantine. Fees and charges will be published by SHG as they become available.

How many people have expressed an interest to travel?

Work continues to collate a list of travel requests. Requests received are for both travel inbound and outbound with a number of different origins and destinations, all of which may not be catered for with one flight route.

Who makes the decision on who is prioritised to have a seat on the repatriation flight?

The criteria used for prioritisation will be agreed by a working group including at least one Elected Member.

Once the prioritisation exercise is complete, all persons who have registered with the Tourist Office will be contacted to advise them of the outcome.

If I am offered a seat on the repatriation charter flight what can I expect?

A flight information pack will be issued prior to the travel date to those offered seats. This will detail the payment process, what to expect at the outbound and inbound airport, what to expect on the aircraft and quarantine arrangements.

What are the options if I am not offered a seat on the repatriation charter flight?

Following the prioritisation exercise, persons who are not offered a seat on the flight will have the option of remaining on the list in order to be kept updated should further travel options become available.

I am not normally resident on St Helena and the repatriation flight is still some weeks away. What should I do?

If you have not already done so, please contact the St Helena Immigration Office who will, if necessary, facilitate an extension to your St Helena entry visa. The Immigration Office can be contacted on tel:

If you have concerns about your ongoing stay on St Helena, you should also contact your embassy in London and insurance provider as appropriate.

Travel options

Am I able to travel to and from St Helena via Ascension Island from the UK or Falkland Islands?

The only option of travel to and from Ascension Island from the UK or the Falkland Islands is via the Ministry of Defence (MoD) flights. Special permissions are required for civilians to travel on these flights and such requests must be supported by SHG and the FCO.

Travel between Ascension and St Helena is possible on the MV Helena which visits Ascension four times per year.

Travel to Ascension by yacht or other private vessel is also possible. The Ascension Island Government (AIG) should be contacted for entry and guarantine requirements.

Is it possible to travel by sea to and from South Africa?

The MV Helena travels from South Africa to St Helena and returns approximately every six weeks and from St Helena to Ascension Island and returns approximately four times per year. The MV Helena is primarily a cargo vessel with only one passenger cabin available consisting of four berths and is available for passengers to book either as a whole or sharing. Passage to and from South Africa is currently possible but restrictions apply.

Will there be repatriation charter flights from and to South Africa?

Based on those who have registered interest with the Tourist Office, the need for a repatriation charter flight to the UK or Europe has been identified. There is not currently a requirement to operate a repatriation flight originating in South Africa. Persons needing to travel between South Africa and St Helena can take advantage of the limited passenger berths aboard the MV Helena.

Is CAN France organising a charter flight to repatriate their employees? Is it possible to obtain a seat on this flight?

As per a recent Public Announcement, CAN France is not planning to organise their own charter flight to repatriate employees.

Longer-term plans

Are further repatriation charter flights being planned?

Planning for the next repatriation charter flight is in progress with a target to operate within the next eight weeks. Beyond this, there are no plans to organise further repatriation charter flights at this time.

When will the Airlink normal scheduled service between South Africa, St Helena and Ascension resume?

South African authorities are not permitting scheduled international flights to resume until the country moves to at least lockdown level 1. It is not currently known when South Africa will move to level 1 but this is not expected within the next three months. Therefore Airlink are only permitted to operate limited

Airlink will not be permitted to operate scheduled international flights to and from St Helena Island until South Africa moves to level 1.

What should I expect on the Airlink flight? Will I have to wear a mask?

Passengers should therefore familiarise themselves with the procedures nearer to the date of their planned travel.

I am planning on travelling to St Helena towards the end of 2020. Will the quarantine arrangements still be in place?

This is being kept under constant review and updates will follow. Measures will only be relaxed following risk-based assessments.

At present any foreign national is allowed to enter St Helena, subject to the established immigration rules, quarantine regulations and testing requirements. The current 14-day quarantine arrangements at Bradley's Camp remain the same for air arrivals for the time being.

Going forward, will there be regular direct flights between the UK and St Helena?

A charter flight was operated between the UK and St Helena Island in April 2020 as part of the Island's Covid-19 preparedness response. The primary purpose of this flight was to bring essential freight and personnel to St Helena. The next flight is primarily for repatriation purposes.

There are many factors to consider with operating a direct flight between the UK and St Helena; these include regulatory, technical, economic and political.

St Helena Airport remains open to new private commercial operations should they meet all the required technical and regulatory approvals.

Other Queries

Will there be an opportunity for personal freight to be carried on the repatriation charter flight?

We cannot answer this question until the flight details are confirmed. If there is a possibility of private freight to be carried this will be communicated in future updates.


The cast were pleased with the way that the performances ran and I am hugely grateful for their total commitment, hard work and talents.
