Brighton Surgeon Operated with a Swiss Army Knife

An unnamed surgeon at the Royal Sussex County Hospital in Brighton used a Swiss Army penknife to open up the chest of a patient because he claimed he could not find a sterile scalpel. The official line from the hospital is the operation was an emergency, but the surgeon's actions were "outside normal procedures and should not have been necessary".

Police are separately looking into at least 105 cases of alleged medical negligence at the University Hospitals Sussex Trust and considering manslaughter charges. An expert witness on clinical negligence and a former consultant surgeon, said: "It surprises me and appals me. Firstly, a penknife is not sterile. Secondly it is not an operating instrument. And thirdly all the kit required must have been there." Instead, the surgeon used a Swiss Army knife which he normally used to cut fruit for his lunch. The same surgeon carried out three supposedly low-risk operations in two months where all three patients died soon after.

The hours before print deadline turned out to be quite hectic yesterday. I thought it appropriate to write a piece based on a report published on the BBC News website about Diego Garcia and the 60 Sri Lankan Tamils who have been detained on Diego Garcia, by the US military, for three years. In fact, the third anniversary of their detention was yesterday. As I was working out how I was going to write the second half of the story, news popped up on my computer screen about the UK government agreeing to handover the Chagos Islands to Mauritius. That was indeed a coincidence and I immediately wondered how I could include that in what I was writing. I couldn't, the best thing was two stories on the Chagos Islands. When the agreement finally becomes a signed treaty, we will be one British Overseas Territory less.

Ten hours later, Falkland Islands Governor Alison Blake finds it necessary to resort to social media to assure Falklanders that the UK government is not thinking of coming to a similar kind of agreement with Argentina and hand the Falkland Islands over to them. The governor explained the legal and historical context of the two territories is very different. The UK commitment to the South Atlantic territory's sovereignty is "unwavering" and "remains undiminished", she said in her statement posted to social media.

And, the Argentine president offered the opinion as recently as last May that gaining the sovereignty of the Falkland Islands could take decades. He is only interested in using diplomatic means. His vice-president is a different kettle of fish. She comes from a military family and is extremely nationalistic. More about her inside this week's edition of the Independent.

It is, how can I say? Depressing, how far and wide the Independent has to look for news at the moment. There is definitely not the regular drumbeat of action and excitement, or even news of general interest, in this neck of the woods. The best I can come up with is – and this certainly is not written disrespectfully to St Helena Cricket - Saturday 5th October, tomorrow! is a big decision day for the cricket squad. Fourteen of the 17 now in the squad will be chosen to go to Nigeria. Coach Nadeem is back again. On Saturday he will have been here working out with the cricket squad for two weeks, less the number of days the plane was late, and is ready to advise on squad selection. We wish the cricket team the very best of luck, and that includes with the weather. Don't forget to buy raffle tickets. First prize, a return ticket to Cape Town.

I don't feel like moaning but I suppose duty calls. Another little whisper that floated to my ear today reminds me I have heard too many stories over the years about an employee who has not been paid. Nothing sensible is said about the situation by the employer. This leaves the employee with the decision when to leave. This no doubt based on a bal-

ance of probabilities. Am I likely to get paid this week or will I get deeper in debt if I stay another week. In many of these situations the employer either says nothing or lies a lot. There is no reliable advice given that the business is on its last legs. There is no notification that this week is the last week there will be enough money to pay wages. It seems in some cases the employee is strung along for as long as possible, working for no pay. Is this another area where there is a need for updated legislation?

How easy is it to take an employer to court because wages have not been paid and nothing said about the financial state of the business? In a small community recourse to law is best avoided. Access to law can also be problematic. Should there be another form of informal arbitration available to help sort out these local difficulties. It sounds like I have come around to a familiar old question. Is there a system available which fits the St Helena situation, or are we having to struggle with ways of doing things that have been imported from somewhere else and are not always appropriate for St Helena. Who's gonna sort that one out then? And when?

Let's finish with a good news story. Well, it will be good news to those who know blue fin tuna has been fished almost literally to death in the North Atlantic. One keen observer on the south coast of England says, I've been watching one of the greatest natural spectacles on Earth, here in south Devon. At a certain station of the tide, within a few metres of the coast, the sea erupts with monsters. They can travel at 45mph. They grow to 2.5 metres (8ft 2in) in length and 600kg in weight. They herd smaller fish - saury and garfish in this case against the surface, then accelerate into the shoal so fast that they overshoot sometimes 2 or 3 metres into the air. Bluefin tuna. They are here, on our southern coasts, right now. After that, the keen observer reminisced romantically with the turbo flat on the floor. We have forgotten that our coastal waters (that's the English Channel, remember) were once among the richest on Earth. Bluefin and longfin tuna were common here. So were several species of whale, including sperm, fin, humpback and Atlantic grey, and a wide range of large sharks. Halibut the size of barn doors hunted the coastal shallows. Cod reached almost 2 metres in length, haddock nearly a metre, turbot were the size of tabletops, oysters as big as dinner plates, shoals of herring and mackerel were miles long.

Are these fisherman's tales? No. There's a wealth of evidence, historical and archaeological, of marine ecosystems built on an entirely different scale to our poor scraps, much of it beautifully documented.

Isn't that great? Since it's a good news story I will not add the bit about big British fishing fleets wanting to pull all the blue fin out of the water immediately they start to re-establish themselves. **Vince**

The Solihull Project -Worth a Closer Look

SHG issued a press release on 3rd October about the Solihull Project. On Monday this week they emailed an advert - nothing else - about the project, probably to the same email addresses as the earlier press release. The Solihull Project is an online DIY tool designed to help people understand demanding and stressful situations. Why these situations occur and how to deal with them and how to avoid them in the first place. It looks very good. It is easy to follow, supported by healthcare professionals there is plenty of information on a wide range of issues where extra demands and stress can affect emotional and mental health. It's worth taking a look on-line to find out more.

The Solihull Project describes itself on the opening page, "Across the UK and internationally, the Solihull Approach supports mental health and wellbeing in parents, children, schools, older adults and high stress workplaces through an evidence-based model in trainings, online courses and resources."

There is information and advice on situations which many of us, and sometimes all of us have to deal with. Dealing with the changes before and after giving birth, with a child who is turning into an adult or the loss of a loved one and worries about money. That is just in the section dealing with the family; there are many more. All of it helps to make difficult times run a bit more smoothly; and helps to make the right decisions during times of stress.

There are courses that can be followed, of varying length and time. Even courses where qualifications are available to run courses. Some courses have to be paid for, but that is not a problem. SHG has made arrangements with the Solihull Project so free access is available. Just use the code STHELENA when it is asked for.

What SHG Wants Us to Know About

What SHG Tells Us Most About

Between 1st January this year and the end of September, 381 press releases have been received from SHG. The year started as it intended to carry on with the closure of the yacht moorings at West Rocks. The chain-links had worn away due to lack of maintenance. Press releases about closures are a regular information stream from SHG. Road closures, parking spaces temporarily blocked off, government offices closing for the day and Port Control closing James Bay and / or Rupert's Bay (and beach) because a ship has arrived. There was also one clinic closure which, from memory, is less than usual. In all, closures for some reason or other make up almost 20% of the press releases received.

All press releases were slotted into a category. All except for 57 of them, or 15%, which did not fit a recurring category. If categories were made for all 57, there would be another 55 categories. Top of the list of categories is Tourism. Many of the tourism press releases contained an advert, and only an advert, nothing else. There is no hint that SHG will pay if the advert is published; perhaps media is expected to publish and live off fresh air. Listed separately was the Tourism Showcase. Some may remember a well organised event when overseas tour operators visited St Helena to meet hospitality providers to discuss face-to-face what they offered and gain other useful information. The tour operators were also shown around the island; obtaining valuable first-hand knowledge for use when selling a tour package to St Helena. For the Tourism Showcase package there is just one press release. There was no follow-up received to indicate whether this mammoth effort of organisation which seemed to go so well had resulted in gaining benefits for St Helena's tourism development. Not providing follow-up information is a common thing. We therefore have to wonder if SHG do measure the effectiveness of their efforts in the many areas they are active and find ways to improve and refine what they do.

What Else Do They Tell Us?

The next most frequent press release was Port Control. Most of these press releases announced the closure of Jamestown wharf and Rupert's wharf and were bundled up in the closures category. It's fair to say there were few more road/parking space closures than port closures.

Next on the list is Statistics, which totalled 23 press releases, or 6%, and were mainly about the population going down or prices going up. After that, announcements about another Exco, Legco or Scrutiny committee and constituency meetings totalled 22 press releases. All were announcements that there will be a meeting but no reports on what decisions were made or the feedback there may have been from the constituency meetings. In recent memory, only Ronald Coleman has supplied that information for the Independent to publish.

Reports are availbale when Exco is tasked to make the final decision on certain development applications. Exco meetings are now private discussions among ministers with the governor; more like the usual cabinet meetings ministers have

elsewhere. That does not have to prevent a public version of most of the main issues of what was discussed being made available but its in the DNA of SHG to keep as much as possible about the day-to-day government of this Island safely tucked away in the 'private' category.

Health and Education at the Bottom of the List

Next on the list of categories are Health Related information and Education Related information. Education information was often about open days, award ceremonies and similar events, with one or two referring to a review of the school provision for primary education. There were some about the closure of education portfolio offices. Health related press releases are more informative overall; including new equipment now in use and information on frontline services. Other categories with roughly the same number of press releases were Invitations to Tender and Police Related announcements. These were closely followed by Weather Warnings (12) and EDIP Funded Projects (11). Also with the same number of press releases were Public Consultations and Overseas Visits

At the lower end of the list were announcements on Public Transport, the Postal Service, Cruise Ships and Airport Related announcements. The non-bye-election had five announcements and a new issue of SHG's own printed news, 'The Ambassador', was announced four times.

What Does This Tell Us?

First and foremost, either SHG thinks the information in their press releases is what the we all want to know, or they are telling us only what they think we ought to know. Most of it concerns the most basic nuts and bolts, day-to-day stuff of government administration – very rarely is it more than that. Yes, we need to know when a road is closed but there is so much more than that kind of information which SHG can share out of simple public interest.

The St Helena Government does not make information about what is happening in government easily accessible; in fact, it is incredibly hard to get access to information on the most important things going on (or not) in government. We get to know when Legco meets, we can forget about Exco now it seems. We can download the Order Paper from the SHG website. But how many can sit all day listening to what is too often a bad quality radio broadcast of Legco Live. Much of a live Legco broadcast is 'down time'. Little or no information of relevance is broadcast for extended periods. Why has no-one thought of editing the hours of broadcast down to 40 minutes of real information which is relevant or interesting to the public. The alternative is to wait months, at least, for the Proceedings of a Legislative Council meeting, download it from the SHG website and then do a word search to find what is wanted. Information from SHG on what they are doing in government, on our behalf, is inaccessible. Even the search engine on the government website is very poor. Often emails enquiring about current issues receive no response, other than the press office saying they will try again to get the information from someone.

What SHG Wants Us to Know About What SHG Tells Us Most About

Much is made of the so-called Communications Hub that SHG have set up. When it was introduced, it showed connectivity between all the various communication platforms. Searching now on the SHG website for information to the Communications Hub brings up nothing. The recollection is the emailed press release messages were merely repeated on other communication platforms. Repetition does not make them better.

SHG's Facebook and Twitter pages repeat some press release content. Also included is the lightweight and inconsequential style of all social media platforms. This is what social media is designed to do. It is no place to get a meaningful message across about important and often complicated issues that touch all our lives.

The best reach is through radio. Why do not some ministers have a session on radio after an Exco or Legco meeting to discuss the main points from their meetings? It would be a giant step forward if they did that. But verbal communication is momentary, and that is a weakness. It's in one ear and often out the other. This results in different recollections of what was said. Like social media the wrong end of the stick is often gripped. For proper consideration of major and often complex issues, the printed media is the best we have. The printed word does not disappear until it is thrown away. Important points can be referred back to; when reading for the first time different bits can be re-read if necessary. Can TV be used more effectively to communicate what SHG is doing?

Public consultation has to move with the times. It is reasonable to estimate that no more than 2% of the population bother to download a new government policy document AND read it carefully from cover to cover. Less people than that go to public consultations and constituency meetings. This is the age when people expect to get all the information they want while sitting in their own armchair. SHG communication management should be to make sure the armchair sitter (and those leaning against the bar) get the correct

information first. An SHG press release will try to get across a few of the major points in a new policy proposal and follow this up with a series of public consultation meetings. By the time the meetings take place, SHG are on the back foot because the little bit of simplified information given has been misinterpreted and travelled through the grapevine spawning a number of versions.

Pressing the send button for an emailed press release is not the end of the job, it is just the start. Follow ups with a radio discussion with councillors used to be more regular than now. Social media is no place to explain new policies. The launch of new polices or important initiatives should include detailed conversations with people from print media. The infrequent press conferences only get half way to getting any message across satisfactorily.

There's another general election next year. There will be exhortations about all of us voting. This is your chance to get involved – you decide, is what they will say. If we are not involved now, why should we get involved then?



News from the St Helena Cloud Forest Project




Welcome to another 'news bite' from the St Helena Cloud Forest Project!

Today we remind you to check out 'live' weather and climate data for St Helena thanks to advancements in the weather monitoring network on the Island

Funding from the St Helena Cloud Forest Project and Darwin Plus (DPLUS103) enabled the installation of the island's first automatic weather station network, utilising mobile data to telemeter information to Bottom Woods Met Station in real-time.

This allows anyone to check out 'live' weather and climate readings for different locations around the island at any time, including information on temperature, wind speed & direction, rainfall, & humidity. Simply check out https://wow.metoffice.gov.uk/ and pan to St Helena.



Additionally, thanks to an incredible piece of work by Steve Palmer - an expert Meteorologist supporting the St Helena Cloud Forest Project - historical meteorological data for St Helena has been archived here: https://data.ceda.ac.uk/badc/corral/ images/metobs/atlantic/ST_HELENA. These readings date back to the late 1800's and were all meticulously compiled using UK colonial registers and Royal Navy logbook images.

Brilliant job by our partners in the Bottom Woods Met Station, our Water Resources Monitoring Technician, and of course to Steve Palmer - who will be giving an exciting public talk on the evolution of weather observations on St Helena at the Museum on 10 October, starting 6.30pm!

Just pay up says Post Office scandal victim

Sir Alan leads the Justice for Sub-postmasters Alliance, campaigning for financial redress for the 555 victims who took part in the landmark group legal action against the Post Office that culminated in 2019.

Their compensation was, however, swallowed up by the huge legal costs involved in bringing their case.

The government went on to set up a specific compensation fund to give these sub-postmasters the redress like others affected, but Sir Alan has said the deadline is needed as three years have passed since.

Last month, Sir Alan questioned whether the government was dragging the "issue out to exhaust victims until their deaths" and if the scheme has become a "gravy train" for its lawyers.

A total of £265m has been spent on lawyers relating to the Post Office scandal from 2014 to 2024.

OCTOBER NIGHT SKY

October finds Mercury and Venus in the evening sky. Mercury is shy and takes some effort to see, but brilliant Venus is not hard to find. Saturn, Neptune, Uranus, and Jupiter rise in that order before midnight. Mars becomes a fine bright object in the predawn sky, standing high in the east. Plus a comet known as C/2023 A3 (Tsuchinshan-ATLAS) may be on show as it passes closest to Earth and springs into the evening sky.

Mercury comes out of superior conjunction early in the month and stays very low above the western horizon due to the shallow angle of the ecliptic. By the 24th it remains difficult to spot, since it sets just about 10 minutes after the Sun

Dominating the evening sky is **Venus**, shining brightly to the West after sunset. Tomorrow night, look for the thin crescent Moon which will be very close to Venus in the Western sky (providing we have clear skies). Venus sets around 8.30 pm now and by month end, after 9 pm - offering a lovely view in deepening twilight. A telescope will reveal Venus being less lit than 91% last month to 77% by the end of October when it has moved a bit closer to Earth.

Already high in the Southeastern sky as twilight falls, **Saturn** is ready for focused attention. By 8 pm this weekend, it stands high among the stars of Aquarius. By the 31st, although it remains visible well into the morning hours, you will notice that it sets over an hour & a half earlier than it does now and by then, the planet will be 842 million miles from Earth

Neptune rises well before sunset and is well placed in the Southeastern sky by full dark, gaining altitude with best views around 9.30 pm. During October, Neptune wanders westwards and by the 14th can be located just below the waxing gibbous Moon if you look in an ENE direction

Uranus rises around 9.15 pm this weekend and almost two hours earlier by the 31st. It can be viewed quite close to the Seven Sisters star cluster all month and for most of the night with the best time to spot it between 1 and 3 am.....but you will need binoculars. With Uranus high in the sky in the pre-dawn hours, it will be a great time to view the planet through a telescope. It reveals little to us earthbound observers, but it is a nice challenge to spot it, maybe for video/photo capture?

Jupiter rises just after 11 pm this weekend and an hour and a half earlier by the 31st. Early morning hours sees the planet in the constellation Taurus and a waning gibbous Moon joins them on 20th and 21st October. Even small telescopes can view detail in Jupiter's turbulent atmosphere and on some nights you might notice the Great Red Spot appearing.

Mars rises around 1 am this weekend and almost an hour earlier by the 31st. The Red Planet tracks eastward across Gemini and then moves into Cancer, brightening as the month wears on. The planet will be 89% lit by the end of October. The Red Planet now reveals some of its surface secrets, hidden from Earth for more than a year.


Extras: Comet Tsuchinshan-ATLAS (if it is bright enough) can be seen crossing into the evening sky in the second week of October and quickly increasing its elongation from the Sun. It can be located setting in the West just after 7

pm on the 12th and then about 15-20 minutes later each evening afterwards. From 18th October you should be able to spot the comet to the Northwest of Venus. The comet comes closest to Earth on 12th October at a distance of 43.7 million miles.

The International Space Station (ISS) will fly over St Helena next on Monday 7th – look NNW at 1943 hrs and it should be visible in that direction for 2 minutes. On Tuesday 8th it will fly over three times in that day, which does not happen too often....the first time will be at 0536 hrs from the SSW, then again at 1855 hrs from the North and lastly at 2033 hrs in the direction of WSW. Astronauts on the ISS do a full circle of Earth every 90 minutes and experience 16 sunsets and sunrises every day.

In the Southern hemisphere the October full moon is known as the Pink Moon. Why? Because the name signifies the arrival of the first spring flowers. The next full moon is due on Thursday 17th October at 1126 hrs. Other names for the October full moon include Egg, Fish, Seed or Waking Moon. Enjoy the view.....

Britain's Disgraced Rule Over Chagos Islands Starts to End

Yesterday, The Mauritian and British governments agreed a deal for the sovereignty of the Chagos Islands to be handed over from Britain to Mauritius.

The opening paragraph of the official statement, published on the UK government website states, "Following two years of negotiation, this is a seminal moment in our relationship and a demonstration of our enduring commitment to the peaceful resolution of disputes and the rule of law. Negotiations have been conducted in a constructive and respectful manner, as equal sovereign States, on the basis of international law, and with the intention of resolving all outstanding issues between the United Kingdom and Mauritius concerning the Chagos Archipelago, including those relating to its former inhabitants."

Chagos Islanders Complain of Being Excluded and Ignored

Chagossian Voices, a community organisation for Chagossians based in the UK and in several other countries, condemned the UK government's lack of consultation with them before Thursday's announcement. In a statement on Twitter, also yesterday, they said, "Chagossian Voices deplore the exclusion of the Chagossian community from the negotiations which have produced this statement of intent concerning the sovereignty of our homeland. Chagossians have learned this outcome from the media and remain powerless and voiceless in determining our own future and the future of our homeland. The views of Chagossians, the Indigenous inhabitants of the islands, have been consistently and deliberately ignored and we demand full inclusion in the drafting of the treaty."

What Has Been Agreed?

The agreement published yesterday sets out the main points in a treaty which is still to be finally drafted and confirmed through the legislative process. Both sides stated the treaty will be finalised as soon as possible.

The agreement hands over all sixty or so islands in the Chagos Archipelago to Mauritius; this includes the largest island, Diego Garcia, which accommodates a US military base and has been the source of constant and bitter contention over the last 56 years. However, while Mauritius will officially have the sovereign power, the UK will exercise this power on behalf of Mauritius over a 99-year period. The UK exercising this power is questionable as it is clear the United States have the last say on what happens in Diego Garcia as it is their military base on the island. Chagossians will be allowed to return to any of the Chagos islands except for Diego Garcia, where the existing level of exclusion and complete secrecy is expected to continue.

A resettlement programme for Chagossians wanting to return to their homeland will be organised by Mauritius, helped by funding from Britain. Further funding from the UK is promised; "the UK and Mauritius will cooperate on environmental protection, maritime security, combating illegal fishing, irregular migration and drug and people trafficking within the Chagos Archipelago, with the shared objective of securing and protecting one of the world's most important marine environments. This will include the establishment of a Mauritian Marine Protected Area."

The agreement ends, noting the United States and India are also in agreement.

A Dishonourable Period of History for Britain

The French were the first to claim the Chagos Islands. Britain contested their claim in 1786. After the fall of Napoleon, the French claim to the Chagos Islands also fell. The islands were administered as part of Mauritius. When Mauritius gained independence in 1968, the Brits split off the Chago Islands and retained control. Mauritius has always maintained the Chago islands rightfully belong to them.

In 1966 Britain and the United States agreed that a US military base would be established on Diego Garcia. It was also agreed the Chagos Islands would be depopulated. The ongoing independence negotiations with Mauritius continued with Britain, no doubt secretly, having the agreement with the US as part of those negotiations.

In 1967, the eviction of all residents from the Chagos Islands began. Dogs, including pets, were rounded up and killed. Chagossians have described being herded onto cargo ships and taken to Mauritius or the Seychelles. The uprooting of the 1,000 population of Diego Garcia continued after Mauritius won its independence in March 1968. Some Chagossians were taken to Mauritius, others to the Seychelles. Some were taken temporarily from Diego Garcia to other Chagos islands, including the Peros Banhos atoll. The last Chagossians were taken off the Chagos Islands before the Peros Banhos plantation was closed on 26th May 1973.

There have been almost continuous legal battles ever since between Chagossian community organisations in Britain and the British government. During an arduous legal process, the Chagossians have won some landmark rulings in British courts.



In February 2022 a group of Chagossians sailed to Peros Banhos, one of the Chagos islands, to reclaim it. Chagossians born on Peros Banhos together with the Mauritian ambassador to the United Nations, a legal representative from Britain and a journalist from the UK Guardian newspaper gained wide publicity for the Chagossian cause. In the group was Louis Olivier Bancoult, a longstanding leader for the right to return to the islands of their birth.

In a moving video, the group visited the ruins of what used to be their church. Bancoult turned to camera as he explained he had been baptised in that church. His mother was married there and his grandfather's funeral was held there. Why, he asked, did they uproot us from our beautiful island when they have done nothing here except let everything go to ruin. That question is one which historians will attempt to answer for some years yet.

Brits 'Take Us for Fools' Says Argentine Vice President

At the recent United Nations General Assembly, British foreign secretary, David Lammy, discussed the Falklands with the Argentine foreign minister during a break in the speeches. Some measures were agreed to "improve the bilateral relationship".

The agreement reached meant monthly flights from the Falklands to São Paulo in Brazil stopping at Córdoba, Argentina will go ahead. Co-operation on the conservation of fisheries was also agreed. Also included is a trip to the Falklands for relatives of Argentine soldiers who died in the 1982 war and are buried in the Falklands.

But the Argentine vice president later criticised the agreements because they were "contrary to the interests of our nation." She continued, "Do they take us for fools? They are getting material, concrete and immediate benefits, while they are offering us crumbs as emotional consolation and weakening our ability to negotiate." Victoria Villarruel is a fiercely conservative politician who comes from a military family.

Just Pay Up Says Post Office Scandal Victim

A Post Office scandal victim, Jo Hamilton, has hit out at delays to compensation for sub-postmasters, saying the government should "just pay" adding "the whole process is just nonsense". The scandal involves the several hundred subpostmasters being charged with fraud due to errors in the computer system they were required to use.

Hamilton's criticism comes after Post Office minister Gareth Thomas said not all payments would be made by March next

year. Former sub-postmaster Sir Alan Bates had called for a March 2025 deadline to compensate all involved in the initial legal action against the Post Office. Thomas agreed with Sir Alan that faster progress was needed, but said it would be "difficult" to achieve that deadline. Sub-postmasters have

Two Years in Prison for Throwing Soup

"Phoebe Plummer and Anna Holland, were sentenced to two years and 20 months, respectively, for throwing tomato soup at the glass protecting Van Gogh's Sunflowers. No prison terms have been handed to the people whose companies deliver climate breakdown, causing the deaths of many thousands and destruction valued not at the £10,000 estimated by the court in damage to the painting's frame but trillions." This week a discontented UK reporter wrote this, and more, about the injustice of the sentencing in this case.

Two 'Just Stop Oil' protesters caused temperaments to rise when they threw soup (tomato soup) at Van Gogh's Sunflowers painting. The painting is protected by glass and was not damaged. It was a gesture without serious consequences in protest at the increasing damage and disruption caused by climate change through the continued emission of greenhouse gases.

The judge, Christopher Hehir, presiding over the Just Stop Oil / Sunflower case was also criticised. "Everywhere we see a farcical disproportion. The same judge, Christopher Hehir, presided over the trial of the two sons of one of the richest men in Britain, George and Costas Panayiotou. On a night out, they viciously beat up two off-duty police officers, apparently for the hell of it. One of the officers required major surgery, including the insertion of titanium plates in his cheek and eye socket. One of the brothers, Costas, already had three similar assault convictions. But Hehir gave them both suspended sentences. He also decided that a police officer

who had sex in his car with a drunk woman he had "offered to take home" should receive only a suspended sentence. Hehir said he wanted "to bring this sad and sorry tale to its end with a final act of mercy". The solicitor general referred the case to the court of appeal for being unduly lenient, and the sentence was raised to 11 months in jail." The journalist added, "Hehir also handed a suspended sentence to a man who rammed his car into the gates of Downing Street and was then found by police to have extreme child abuse images on his phone. By contrast, in July Hehir – the Judge Jeffreys of our time – gave five climate protesters who blocked the M25 jail terms of four and five years. It looks to me as if justice itself is suspended in Southwark crown court."

The journalist does have grounds to complain bitterly. The previous UK government introduced new laws which makes non-violent protest a more serious crime than many forms of violent crime. The new UK government has decided to defend the imbalance created by the previous government.



Last May, two High Court Judges ruled the Home Secretary acted unlawfully when she made it easier for police to criminalise peaceful protest. The judges ruled she acted outside her powers. The previous government appealed the High Court decision and the new government has decided to continue the appeal. It is reported the previous government tried to criminalise peaceful protest by presenting the Public Order Bill to parliament. The House of Lords objected to the criminalisation of protest and struck out the offending clauses from the Bill, which eventually became law without the contentious clauses.

The Home Secretary at the time, used an ancient and rarely used statutory instrument to make the clauses struck out by the House of Lords active again. This action did not require the usual democratic scrutiny and agreement. It can more accurately be described as dictatorial.

Is it any wonder the UK prisons are full to overflowing when protesters who chains themselves to railings can expect a two-year prison sentence. Peaceful protesters are herded into prisons and convicts who have served less than half their sentence are given early release to make way for them. At the moment, there are too many signs the new government will be as crazy as the previous one.

English Football

Arsenal and Manchester City are among the clubs competing to sign Florian Wirtz from Bayer Leverkusen, Eddie Howe and Graham Potter are the leading candidates to replace Manchester United manager Erik ten Hag and Southampton boss Russell Martin coming under increasing pressure.

Arsenal, Bayern Munich, Manchester City and Real Madrid are in the running to sign Germany midfielder Florian Wirtz from Bayer Leverkusen next summer, with the Bundesliga club wanting €50m (£125m) for the 21-year-old.

Barcelona are hoping to strike a deal with Brazil forward Neymar, 32, in January when he is free to talk with clubs before his contract with **Al-Hilal** expires in June 2025.

Newcastle United boss Eddie Howe and ex-Chelsea manager Graham Potter are two of the leading candidates to replace Erik ten Hag if he leaves Manchester United, while former England manager Gareth Southgate and Inter Milan boss Simone Inzaghi are also in the frame.

But, reports from Italy suggests that former Juventus manager Massimiliano Allegri is favoured by Sir Alex Ferguson to become the next **Manchester United** manager.

Southampton manager Russell Martin is at increasing risk of losing his job following his side's poor start to the season.

Former **Chelsea** manager Frank Lampard has hinted his interest in the England manager role, which is currently held by interim manager Lee Carsley.

Real Sociedad's Spain midfielder Martin Zubimendi, 25, says he has no regrets after turning down a move to **Liverpool** in the summer transfer window.

Arsenal are set to face competition from AC Milan, Inter Milan and Juventus for 24 year-old Lille and Canada forward Jonathan David.

Borussia Dortmund's 22-year-old winger Karim Adeyemi is a target for

Liverpool. The Merseyside club want the Germany forward to replace Mohamed Salah in the summer.

Everton are not concerned about a January transfer window approach from rivals **Liverpool** for 22-year-old English centre-back Jarrad Branthwaite.

Everton could reignite their interest in Paraguay forward Miguel Almiron, 30, who is likely to leave **Newcastle United** in January.

Manchester United could opt to trigger a one-year extension to 31-year-old England defender Harry Maguire's deal, which comes to an end at the end of the 2024-25 campaign, as they want to avoid him leaving for free.

The Former RMS is Up For Sale Again

The specialist shipping and maritime news website, TradeWinds, reported recently the former RMS St Helena is for sale once more. Leading UK shipbroker Paul Willcox, told TradeWinds his firm is exclusively handling a deal for the 3,100-dwt passenger and cargo vessel. Willcox also handled the sale of the RMS when she retired from serving St Helena.

RMS on Voyage to Glamour and Attention

In October 2018 the former RMS was bought by Extreme E, the motor racing organisation promoting the environmentally sustainable electric powered SUV racing series. After major refits and upgrades, the former RMS became the "floating hotel, hospitality and cargo centrepiece" for Extreme E's worldwide racing series. Instead of flying the racing vehicles and all the equipment to racing venues around the world, Extreme E chose to use the former RMS as the form of transport for just about everything. The racing series moved between extreme racing locations in Saudi Arabia, Greenland, Sardinia and South America. "We float not fly" became an Extreme E catchphrase. Despite using 24 tonnes of fuel per day when on the high seas, the former RMS is less environmentally damaging than using cargo planes.

From Electric to Green Hydrogen

The Extreme E racing series is now moving on to Extreme H. The series will help promote, test and develop hydrogen powered road vehicles. Even as the former RMS is in the disposal process, she is still the centre of attention as the stage for launching the new Extreme H series and the Pioneer 25 hydrogen powered racer. Alejandro Agag, the driving force behind Extreme E and Extreme H said, "The launch event aboard the St. Helena along the River Thames (on 5th September) was spectacular as we welcomed a new era for motorsport and the world's first hydrogen racing series. It was a truly special moment."

The former RMS has become a regular sight in Central London, moored on the River Thames alongside HMS Belfast on three or four occasions in recent years.

The Extreme H series starts in April 2025. There will be ten races at five locations. Starting in Saudi Arabia, as Extreme E always did, before races in the UK, Germany and Italy. The final races will be in the United States. Travelling the globe will not be as big an issue when Extreme H gets underway next year. There will only be two long distances between races; Saudi Arabia and Europe and then Europe and United States. This logistical change caused a review of the St Helena as the 'centrepiece' for transportation between races.

Why the St Helena is being Sold

The Independent contacted Julia Wall-Clarke, Director of Impact at Extreme E to confirm the report of the sale of the former RMS and to give the reason for it. Julia informed the Independent, "I can confirm this report is factual. The St Helena has provided Extreme E with a vital freight and hospitality solution to access some of the series' most remote locations

since its launch in 2021, including Greenland, Saudi Arabia, Chile and Uruguay. She has enabled our cars and paddock infrastructure to reach our race destinations in a more environmentally efficient way, whilst providing world-class hospitality facilities for our team, guests and partners in places where options were often limited or not available.

As the series transitions to become Extreme H, the world's first hydrogen series, race locations are expected to have more accessible ports and hospitality options, so our own facilities are no longer critical to the smooth running of the series

St Helena was the perfect vessel to support Extreme E's requirements and will not be replaced but will be forever fondly cherished. We are incredibly proud to have given St Helena a vibrant new lease of life and will be forever proud of the memories she created with us over our past six years of stewardship. We now look forward to seeing the next chapter of her adventure unfold."

The next chapter for the former RMS is likely to be a better experience than the ship's first encounter with a new owner. In April 2018, the TradeWinds website reported, "The RMS St Helena (built 1989), the ship that operated the UK's last deepsea passenger and cargo liner service, is reported as having been sold to London-based maritime security provider MNG Maritime. According to the St Helena Independent, a newspaper on the remote island for which the St. Helena served as a lifeline for 27 years, it is due to be handed over to MNG shortly and renamed MNG Tahiti." It was anticipated 'our ship' would endure a second life in the Middle East transporting arms and armoury in support of a war effort. To add insult to injury, the ship would also bear the very inappropriate name of 'Tahiti'. Later the same year, the former RMS was sold again. This time to Extreme E. Our ship then only had to tolerate champagne being spilt on its deck. Thankfully, Extreme E changed the name, back once more to St Helena. September proved for all concerned with the former RMS to be a memorable month. As luck will have it, the London Gazette announced on 10th September that MNG Maritime was being wound up and liquidators were appointed. Maybe the directors had decided to retire to Tahiti?

Extreme E have significantly upgraded the former RMS in many ways. From the hull, the engine room and all facets of catering to the accommodation being mainly VIP standard. In January this year connectivity was upgraded further in partnership with Eutelsat/OneWeb. Typically, Extreme E put the St Helena at the forefront of communications technology. They reported, "The St. Helena is one of the first to have installed a Kymeta Peregrine maritime user terminal and installation and connectivity services are being managed by OmniAccess." Kymeta Peregrine is proclaimed to be a sleek, easy-to-install terminal and ensures hassle-free connection anywhere on water.

Hopefully the former RMS will proceed gracefully to another life as a high-end explorer/cruise ship or something similar.
