Crown Supermarket – Now the 9th Sales Outlet for Rose & Crown, with 10th on the Way

The Rose & Crown added number nine to their 'family of shops' with a grand opening of the Crown Supermarket on Sunday. It is a big addition to their retail food offering. Both the original Rose & Crown shop in Market Street and The Arch shop by the sea front are small food outlets with a limited range of produce compared to the Crown supermarket.

Many customers turned up for the Sunday opening and found the many shelves well stocked, often with items not normally available elsewhere. Also, the word soon got around that there was flour available, for bread and cakes. Shop assistants could be seen restocking the shelves with flour at frequent intervals.

Outside, the main car park in front of the supermarket soon filled, and there not one 'no parking' cone to be seen. Best of all, the whole area is flat, wide and long – just as a car park should be. There were also many cars parked in the smaller parking area on the upper level, behind the supermarket.

Tara Wortley welcomed customers immediately before the supermarket opened. She thanked many people and businesses involved with converting the building to a supermarket. The work started on 2nd June and was completed four months later. It is a fantastic achievement, especially as conversions seem always to involve unexpected additional work.



The guest of honour for the opening ceremony was Shirley Henry. Shirley worked for more than 30 years for Harry Corker (Lyn Thomas's father) and was the lead supervisor. Shirley is Martin Henry's grandmother. Martin has many memories of working in Harry Corker's shop, weighing everything on the scales.

A Conservation Engineer for St Helena

Some of St Helena's most important historic monuments need urgent repair and protection. We are fundraising to send a conservation-accredited structural engineer to St Helena to assess and devise the most appropriate means of stabilising and repairing the monuments before more historic fabric is lost to the elements and the sea.

Which monuments are we talking about?

High Knoll Fort

It is the largest, most prominent and most complete of the forts and military installations on the island. It is a Grade I listed building and potentially a major tourist attraction, but it is in a sadly deteriorating condition.

Bank's Battery

Built between 1700 and 1740, and modified during Napoleon's incarceration, this battery occupies a strategic position relative to ships arriving at Jamestown. Approaching ships needed to identify themselves satisfactorily or risk coming under fire. Unhappily, the site was significantly damaged by storms in 2010 and its deterioration is continuing. It is in urgent need of protection and stabilisation.

Munden's Battery

First existed as just two guns in 1673, but was considerably expanded in 1708-10. The battery protected the harbour of Jamestown. Its surviving structures are in a dangerous, crumbling state and have suffered from inappropriate repair in the past.

These monuments are an important part of St Helena's history and, indeed, world history.

We have a highly qualified and experienced engineer in the UK who is willing to work largely pro bono if we can raise the cost of their flights and subsistence. Our fundraising target is £3,000. This is a great opportunity to move forward on preserving these important heritage sites. If we can raise the funds in time, the investigative work will be done in January 2026 in partnership with the National Trust of St Helena and the Commonwealth Heritage Forum.

What is the St Helena Built Heritage Grant Scheme?

The scheme is funded by the Tourism Development Programme, the aim is to provide financial assistance towards the conservation of buildings in the Jamestown Conservation area. Grant awards give particular attention to buildings of historic and architectural merit and applications where urgent and important conservation work is judged to be necessary, emphasis is placed on increasing the visual appeal of buildings.

Who is eligible and how much can you apply for?

Applications for funding are welcome from owners of heritage property in the Jamestown Conservation Area; this usually means, but is not limited to, listed buildings as catalogued in the Crallan Report.

The funding pot is limited at £50,000, so the grants are capped at £5,000 per application and must be match funded.

How to apply?

If you are unsure of your eligibility or whether your project will meet our criteria for funding then you can still contact us for a consultation.

Applications will close on the 1st of November.



Immigration Ordinance v2

Following the recent revocation of the Immigration Ordinance commencement date of 01 October 2025, the St Helena Government (SHG) is pleased to report that priority work has begun on refining the legislation. The revision to the Ordinance will ensure closer alignment with the policy intent whilst also adequately protecting the community's needs.

It is expected that the revised draft of the legislation will be presented at Legislative Council towards the end of this year for approval. In parallel, with the legislative process, the new immigration digital platform will be adjusted to meet the requirements of the updated legislation. SHG is focused on ensuring the system is as streamlined and user-friendly as possible for all users.

More Change at the Top

Connect Saint Helena Ltd announced that Chief Executive Officer, Janet Lawrence will be stepping down upon the completion of her fixed-term contract. Janet's final working day with the company will be Friday, 17 October.

Ancient Fossils Found

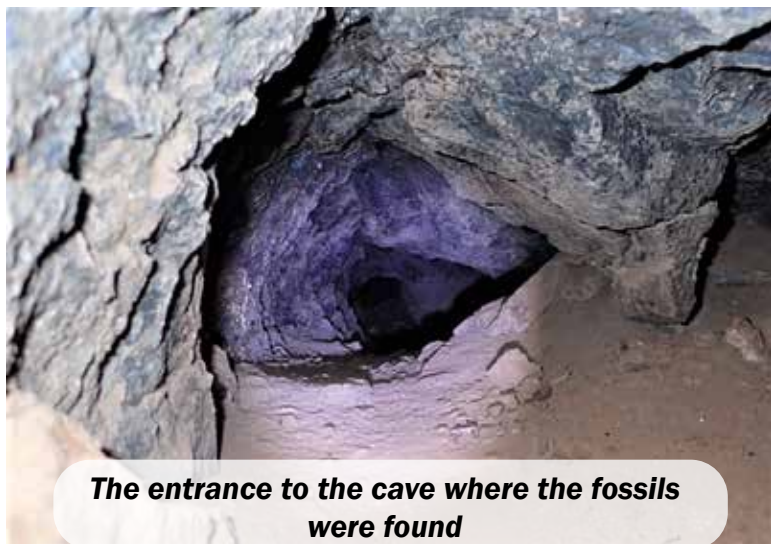
Whilst searching for fossil bird bones in a cave in Sharks Valley, a team comprising researchers from the Université de Lyon (France), the Natural History Museum of London (UK), alongside the St Helena National Trust and the St Helena Research Institute unearthed a new fossil site. This location yielded numerous bones from extinct endemic seabirds and a large number of insect remains, including evidence of the island's famous lost invertebrate: the St Helena Giant Earwig (*Labidura herculeana*).

The Giant Earwig, once the largest in the world, was tragically declared extinct in 2014 after the last living specimen was seen in 1967. The new finds include:

- A total of four large male forceps of the Giant Earwig, including one of the largest ever measured, reaching 3.1 cm.
- Two female forceps.



- Remains of the supposedly extinct St Helena Giant Ground Beetle.

All recovered insect remains, including the Giant Earwig fossils, have been handed over to the St Helena National Trust. These remains mark the foundational pieces for the Trust's new insect reference collection, which will be vital for future research, conservation, and education about the island's unique invertebrates.

The international team, working under the "AtlantAves" project (funded by the French National Research Agency), completed its third excavation campaign in August this year. Whilst the species remains officially extinct, the research team hopes this discovery could mean the island's extensive eastern habitats still hold isolated, undiscovered populations of this, or similar, unique endemic fauna.

Air Freight Arrangements

SHG has been receiving a number of complaints from freight forwarders and importers regarding delayed air freight via the Airlink service from Johannesburg. Best efforts are made to ensure air freight arrives on time without delay. But there are a number of factors limiting the airfreight service.

Due to contractual commitments, Airlink must prioritise the loading of goods and passengers, designed to ensure the island's needs are properly met. Goods and passengers are loaded in the following order:

1. Passengers travelling for medical purposes;

2. Mail;

3. Medicines;

4. Fuel Samples;

5. Other passengers;

6. Other cargo and

7. Pets.

As a result, it can often be the case that general cargo will be held back to make space for prioritised goods. Airlink and cargo handlers may also exercise discretion on the ground for live animals, fresh produce and human remains where the ability to store them at the airport in Johannesburg is limited.

SHG to Face Another Judicial Review on Civil Litigation Costs Legislation

Last week the Independent reported the St Helena Equality and Human Rights Commission is launching a legal challenge to the Civil Litigation (Costs) Ordinance. Catherine Turner, CEO and Commissioner of EHRC said, "The new rules make it virtually impossible for ordinary residents to secure adequate legal representation, undermining their ability to pursue or defend their rights in court." As far as is known, no date has yet been set for a judicial review to hear this legal challenge.

An interesting new development is that Hugh James Solicitors have also begun proceedings in the Supreme Court of St Helena with a legal challenge for the same purpose. Hugh James is the law firm that is representing around 140 people with claims having suffered injury following surgery from the former Dr Sergio.

No one in the clinical negligence team at Hugh James has been available for comment.

A Week of Classical Music Magic on St Helena

Last week, unique opportunities for music lovers arose on St Helena when the exceptional Italian pianist Filippo Gorini visited the island for 1 week and performed a series of recitals free of charge for everyone who wanted to experience classical piano.

Although Filippo is only 30 years old, he has already performed in many of the world's most prestigious concert halls — from Amsterdam to Tokyo, London to Rome, Vienna to New York. And last week, it was St Helena's turn.



He began on Sunday evening with a concert in the Catholic Church, where he played Schubert and Beethoven on our small Yamaha digital piano instead of the big Steinway Grands that he usually plays. Before each piece, Filippo explained that the music would take listeners from their deepest sadness to their highest joy. And indeed, that is exactly what happened — at times the audience felt tears welling up, and moments later, the music filled them with happiness. Later in the week, on Wednesday, he gave another moving performance at Plantation House, which touched all who attended and they showed their appreciation with a standing ovation and an encore of music by Bach and Brahms.

Filippo collected donated monies for his music charity which supports exceptionally talented young players from disadvantaged backgrounds. He also made a local charity donation of £200 to SHAPE. The Governor, deeply impressed, presented Filippo with an official St Helena Recognition of Excellence medal, a prestigious award of which only 10 have been given.

Throughout the rest of the week, the young pianist played for groups of year 5 and 6s from all 3 primary schools, and also for clients at the CCC.

On Friday, he delivered a fascinating presentation on the history and evolution of classical music at the Anglican Church in Jamestown.

It was an exceptionally successful week, organised and supported by Teeny Lucy, who also accompanied Filippo on tours around the island's highlights and arranged several meals to sample St Helena's excellent cuisine. He very much enjoyed his hikes with Rockmount Tours, snorkelling in the bay, Aaron's adventure tour and an amazing boat trip on Egalité surrounded by scores of dolphins and humpback whale with calf.

When departing for Italy on Saturday, Filippo was surrounded by familiar faces at the airport — he had met so many people during his stay that he was busy chatting with almost everyone. He promised to consider returning, either alone or with a group of musicians, perhaps for a Chamber Music Festival. We all hope his visit will give a lasting boost to musical life on St Helena, reminding us that diverse cultural activities are as essential as food, medicine, friendship, and family.





"My son wants to leave the island the moment he finishes school," Sarah told me last Tuesday at the Canister. "He says there's nothing here for him."

It's a conversation many parents on St. Helena are having quietly, often over tea or in passing at Thorpe's. The question isn't new, but it feels more urgent now: are we truly developing our young people, or are we inadvertently preparing them for lives elsewhere?

Walk through Jamestown on a Saturday afternoon, and you'll notice something telling. Where are the teenagers? Some are at home, glued to screens showing lives from London, Cape Town, or Manchester. Others are working part-time jobs that, while building responsibility, rarely spark genuine passion or ambition. A handful are engaged in sports or the Scouts, but ask them about their futures and you'll hear a familiar refrain: *"I'll probably have to leave."*

"It's not that we don't love St. Helena," explains Marcus, father of two teenagers. "But what opportunities can I honestly point to for my daughter who loves science? Or my son who wants to work in technology?"

He raises a fair point, yet here's where the conversation takes an unexpected turn. During a recent meeting at one of the island schools, a group of parents discussed this very challenge. What emerged wasn't a list of government failures or infrastructure complaints. Instead, it was a realisation: we, as parents, hold more power than we think. "I realised I'd been waiting for someone else to create opportunities," admits Jennifer, whose daughter recently started a small baking business. "Then I thought, why can't I be that someone? Why can't we?"

This shift in perspective matters because development isn't solely about buildings or programs. It's about mindset. When young Saints see their parents engaged, creating, problem-solving, and building, they learn that opportunities aren't just found but made. They understand that St. Helena isn't a place to escape from, but a canvas to paint on. Consider the parents who've started mentoring in their trades, the mothers forming reading clubs, the fathers teaching navigation and fishing as valued skills rather than mere tradition. These aren't headline initiatives, but they're planting seeds. Every parent who takes their child to a council meeting, who discusses island challenges at dinner as problems to solve rather than merely complain

about, is developing a young mind. Yet we could do more. Much more.

Our young people need us to stop being passive observers of their exodus and become active architects of their future here. This means having honest conversations about entrepreneurship at home, not just employment elsewhere. It means celebrating the young person who starts a social media business as much as the one who gets accepted to university abroad. It means showing our children that innovation, ambition, and success aren't exclusive to places with bigger populations and faster internet.

The truth parents must confront is uncomfortable: if we constantly speak of St. Helena as a place with limitations rather than possibilities, our children will believe us. If we treat every challenge as insurmountable rather than as an opportunity for creative thinking, we teach helplessness. If we ourselves aren't engaged in community development, why should we expect our teenagers to care?



St. Helena's greatest resource isn't the airport, the marine reserve, or even our remarkable history. It's the intelligence, creativity, and energy of our young people. But resources only matter if they're developed, nurtured, and invested in. So here's the challenge, parents: what will you do this month to show your child that St.

Helena is worth building a future on? Will you share your skills with a young person beyond your own? Will you support a teenager's business idea instead of dismissing it? Will you advocate for youth programs with the same vigor you'd use to protect our heritage?

Our young people are watching us. They're listening to what we say about this island when we think they're not paying attention. They're absorbing our attitudes, our engagement, our hope or lack thereof. The question isn't just whether St. Helena is developing its young people. It's whether we, as parents, are prepared to lead that development. Because the honest answer is this: if we won't, who will?

The future of St. Helena isn't being decided in legislative chambers or development offices alone. It's being decided at dinner tables, in workshops, during car rides, and in every conversation where a young person asks, *"Can I build a life here?"* and waits for our answer.

What will yours be?

Obituary

Hudson Janisch



We recently learnt of the passing of Hudson Janisch on 27th July, in Canada, aged 86. Hudson was a direct descendant of Hudson Ralph Janisch – one of only 2 island-born Governors. The Janisch family home was Palm Villa in upper Jamestown - now the residence of Olive Brown. Like many other St Helenian families at that time, they emigrated to South Africa where Hudson was born. After completing his law studies at Rhodes University, he studied at Cambridge University in England and then went on to study a Doctorate at Chicago University, USA.

He and his wife Alice then emigrated to Canada where he became a Professor at the Law Faculty of Toronto University.

He kept his connection with St Helena through visits early in his life participating in fishing trips. In 1997 during his later years, he visited the island with his wife.

It was during this latter visit that he became aware that islanders had lost their British Citizenship Rights under the 1981 UK Nationality Act. Through Hudson's efforts, the Law Faculty of Toronto University agreed to represent the Anglican Church Citizenship Commission in restoring Citizenship Rights for the people of St Helena. The case Professor Hudson Janisch and two other colleagues prepared was based on the Royal Charter of 1673 that gave St Helenians full British Citizenship (English at the time) in Perpetuity including St Helena being a British Island and St Helena's Rights under International Law.

They presented St Helena's case to the UN C24 Committee in New York in 2000. The case was then re-submitted to the UN Human Rights Commission in Geneva the following year by the Anglican Church Citizenship Commission. Eventually, citizenship rights to St Helenians were restored on the 21st May 2002 to coincide with the 500th Anniversary of the discovery of St Helena.

On behalf of the Anglican Church Citizenship Commission and the people of St Helena, I would like to express our condolences to Hudson Janisch's family.

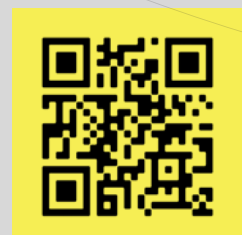
