



Karl Thrower is off To Sint Eustatius – Because They've Got What We Need

Sint Eustatius? It is a Dutch Caribbean Island. It's called Saint Eustace in English. It's about the same size as St Helena and has a population of less than 4,000.

Located just north of St Kitts, you really want to get to Sint Eustatius otherwise you wouldn't bother. Karl Thrower left St Helena last Saturday for a three-day conference that starts next Tuesday. He will need to go to St Kitts or Anguilla for a plane to Sint Eustatius.




Karl Thrower is minister for Environment, Natural Resources & Planning and Economic Development. The reason for going to Sint Eustatius ticks all those boxes. Travelling with Karl is Geoffrey Augustus, the technical manager, (electricity) for Connect St Helena and Paul Cherrett, Head of the SHG Programme Management Office.

What Sint Eustatius has, we have been unsuccessful in achieving. We have had wind generation since 2001 and solar power since 2012. Wind power is withering away. What we don't have is a fully integrated system like Sint Eustatius. They have a system which integrates solar panels, battery storage, and existing diesel generators to provide a clean energy supply for the island. No wind turbines. Probably being in the path of hurricanes has something to do with that. The Island operates on solar power alone for extended periods by switching off the generators during the day and using stored energy at night. Battery storage of renewable energy is the important part of the package that makes it all possible. It was part of the St Helena's aborted PASH Global package in 2018. We are still dithering over it.

The conference Karl, Geoffrey and Paul attend from next Tuesday is organised by a French organisation and funded by the European Union. Let's hope they come back fully charged and switched on.

SMA is to Sint Eustatius what PASH Global was to St Helena, except Sint Eustatius formed a successful partnership, somehow.



Anthony Bowers, the Last Resident of Historic Toby's Cottage

Anthony Bowers was guest of honour on Wednesday as people gathered for an informal event to mark the completed restoration of Toby's Cottage. Anthony lived in the cottage from the time he was born. He was one of a family of seven who moved out of the cottage in the 1950s to a house his father built nearby. Children On Island with Hand, Foot and Mouth Disease

Dr Peter Moss, Chief Medical Officer and Infectious Disease Specialist, has announced there are cases of hand, foot and mouth disease among some children.

Dr Moss want to assure parents especially that: -

"Hand, Foot and Mouth Disease (HFMD) is a common viral infection in children. It causes a rash on the palms, soles, and mouth, hence the name. It is not dangerous, does not cause serious illness, and has nothing to do with the animal disease 'Foot and Mouth'.

HFMD is usually mild, and children recover within 7 to 10 days. Symptoms can include fever, sore throat, mouth ulcers, and small blisters or rashes on the hands, feet, or buttocks."

The illness spreads through coughing, sneezing, close contact, and touching contaminated surfaces. Parents and caregivers can help limit its spread by:

- Keeping children with symptoms at home until they are well;
- Encouraging frequent handwashing with soap and water;
- Teaching children to cover their mouths and noses when coughing or sneezing.

People with signs and symptoms of HFMD do not routinely have to be reviewed by a Health Care professional. Parents should seek medical advice if their child is unable to drink fluids or develops a persistent high fever that does not respond to Paracetamol or Ibuprofen.

The HSC is monitoring the situation closely and will provide updates if needed.

Additional advice on home care includes: -

Home care

Encourage fluids:

Ensure your child drinks plenty of fluids to avoid dehydration, especially if mouth sores make it painful to eat or drink. Oral rehydration solutions can be helpful.

Offer soft foods:

If eating hurts, offer soft foods and avoid tangy or acidic foods like citrus fruits, tomatoes, and lemons that could sting.

Rest:

Make sure your child gets plenty of rest.

Do not pop blisters:

Avoid popping the blisters, as this can increase the risk of infection and spread the virus.

Keep at home:

Keep your child home from day care or school until the blisters have dried up to prevent spreading the virus.

Controversial Chemical Used in Baby Products and Food Packaging

Lack of Firm Regulation Accused of Failing Us Chemical linked to Low Sperm Count, Obesity and Cancer

BPA, is a synthetic chemical used in production of plastics, found in baby products and a wide range of food containers. Concerns over BPA span several years due to the adverse effects it has, or could have, on human health. Sexual development, fertility, obesity and cancer are main concerns.

BPA is used in baby's dummies, baby bottles, food and beverage container liners and water-resistant clothing. The European Union and Canada have banned BPA use in baby bottles but recent tests have identified BPA in baby's dummies made by Dutch, Swiss and French multinational companies.

In 2012, the United States' Food and Drug Administration (FDA) banned the use of BPA in baby bottles intended for children under 12 months. The Natural Resources Defense Council called the move inadequate, saying the FDA needed to ban BPA from all food packaging.

Some evidence suggests that exposure to BPA in the uterus and during childhood is associated with poor behavioural outcomes in humans. Exposure may be associated with higher levels of anxiety, depression, hyperactivity, and aggression in children.

As of 2022, current evidence shows a possible positive correlation between BPA levels, lower sperm quality and an increase in sperm immaturity. There is tentative evidence to support the idea that BPA exposure has negative effects on human fertility. There have also been a limited number of studies to investigate whether recurrent miscarriage is associated with BPA levels.

It has been identified as a chemical that can interfere with the body's hormone system. It is found in urine, blood, the fluid that surrounds and protects an unborn baby, breast milk and umbilical cord and placenta blood.

Comparisons of blood BPA levels between fertile and infertile women between the ages of

20–40, showed significantly higher BPA level in infertile women.

Responses to recent tests from Dutch, Swiss and French multinational companies making baby's dummies include the amount found was insignificant and that re-testing showed no signs of BPA. All three dummies were marketed as either "BPA- free" or "natural rubber".


A consumer protection group commented, "It is illogical that bisphenols (BPA) are banned in baby bottles but not in pacifiers (dummies), which babies use more intensively and in some cases for long years. We are seeing a lack of stringent regulation and it is failing consumers."

Slow-Down in Speed of Price Increases

Some Say It's Because They Were Stopped for a Breathalyser



The inflation rate most often looked for is the figure that gives the year-on-year comparison. For quarter three, ending in September, the overall level of prices had increased by 4.8% compared with the same time last year. This drop in the rate of increase compared with 2024 is because the increase in 2024 prices was 8.2%.

The biggest year on year increase

was household energy as Connect hit us with another price hike on 1st July. Food prices continue to imitate Elon Musk's Starship rocket; they soared skyward by 6.9%. Transport was next highest into the stratosphere with a 6.2% increase compared to the same time last year.

Alcohol and tobacco prices had a below average increase of 3.8% but are poised to cost more than £9 a packet as current stocks run out. The only prices that dropped were for clothing. As we buy clothes much less often than we pay for electricity and food, the price drop for clothing had little effect on the overall rate of price inflation.

The Consumer Price Index rose for the third quarter of this year (July to September) by 1.2% compared with the second quarter of this year - April to June.

Police Fail 40% of the Taxis They Checked

Earlier this month police made roadside checks on 36 taxis on one 'day of action'. Fourteen of them failed road traffic and licencing laws. The faults included bald tyres, expired licences, no licence plates, damage, missing signs and absent driver badges.

Fixed penalty notices and suspension notices were issued to the offending drivers, who were also told WK Milton Key
City Court

what they needed to do to become compliant.

Further days of action were planned for later in the year, the council said.

You can be forgiven if you read this far and think this happened in St Helena. It didn't. These checks were in Milton Keynes on a specific day and for a specific reason. In St Helena it could be any day and for no specific reason.

Napoleon Jewels Stolen

Thieves broke into the famous Louvre Museum in Paris last Sunday morning and stole priceless gems from the Napoleon Collection. A motor-powered extendable ladder mounted on the back of a truck was used to access a balcony. The robbery took place in daylight, just after the museum opened.

Four thieves stole eight heavily jewelled earrings; brooches necklace and a tiara thought to be worth £75 million in an operation that lasted nine minutes.



Who Will Watch the Watchmen?

There are two cliches which come to mind with regards to the present news from St Helena. The first is "Who will watch the watchmen?" Commonly used to refer to the problem of

controlling the actions of people in positions of power.

It is frequently applied to corrupt practices but there is an aspect that is often disregarded where the wrong actions are taken through incompetence which I suggest may sometimes be the case in St Helena.

The second cliché is "There's none so blind as those who will not see', a proverb that at a simple level means ignoring reality or not recognising an issue, possibly through ignorance or design, and not helped by tunnel vision.

Examples of these problems seem to be illustrated by recently enacted legislation on the island such as the Civil (Costs) Ordinance 2025, which is intended to implement changes to the ability for litigants to recover their legal costs. Separately, Jeffrey Ellick recounts an example of a legislative fiasco concerning the Immigration (Amendment) Ordinance 2025.

A recent report states "St Helena's Chief Minister, Dr Rebecca Cairns-Wicks, has informed that the new government - elected last month - remains fully committed to being more open, transparent and communicative and thus, have discussed and agreed on a new approach to communicating....".

This seems to indicate that the Chief Minister has forgotten that there has been a declared policy in place for over a decade to achieve her stated aim but gives no indication why the stated policy has not been applied or how the new approach differs from the original policy with any hope of success.

This does illustrate the problem of a split between authority and responsibility. No one has personal responsibility to ensure compliance with the freedom of information policy and similar actions. Success is claimed by individuals but failure becomes diluted to a corporate responsibility with no consequences.

Deeds need to follow words as the Freedom of Information policy and a commitment to open government has been in place for many years and the present and past Chief Ministers are aware of it but it seems to be empty words and the policy more ignored than observed.

For example, a confused state for the application of the Freedom of Information policy existed several years ago without evident change since then. The administration of the policy was superficial, senior civil servants were not aware of the policy and there were arrangements that were contrary to the policy. An opinion given because of an appeal under the Freedom of Information policy would have very serious consequences as it was reported that one person not giving permission for their individual data to be published prevented aggregated data being published even though not identify that individual.

As an appellant the information collected for the appeal is not made available, no report is published so no clarification of the policy is broadcast and untested precedents are set regarding the policy, such as the need to be approved to carry out research in St Helena to access information already collected by the authorities.

Behind these present issues is a basic problem that individuals are not aware of the limits of their own competence and not being aware of wider issues due to tunnel vision so that politicians and the public are not getting, or ignoring, rigorous advice.

The policy has been in existence for more than a decade yet there is no evidence that the policy is well known or even understood at the highest level, and is not actively considered to educate everyone on this matter as in a democracy knowledge of the activities of government is a fundamental right and necessity. In the spirit of Freedom of Information, I am quite happy for a full disclosure of the documents relating to the events to which I refer, if they are still extant, including the primary documentation, to which I did not have

access, but would illustrate the major changes necessary to achieve the Chief Minister's stated commitment to open government.

Letter to the Editor Openness, Accountability, and Working Together for St Helena's Future

Dear Editor,

During the recent election campaign, I shared a statement outlining four key principles that I believed any prospective Chief Minister should commit to — all aimed at restoring openness and transparency in the Executive Council's (ExCo) operations. These four questions focused on ensuring that:

- 1. Executive Council meetings are open to the public by default, with only sensitive items held in closed session.
- 2. All councillors, whether ministers or not, have access to ExCo agendas, minutes, and decisions.
- 3. Regular public briefings are held after ExCo meetings, so people know what decisions have been made and why; and
- 4. The principle of collective responsibility is used to promote accountability, not to block scrutiny. Although the Chief Minister did not fully commit to all four points at the time, it became clear through early discussions that she shares and is dedicated to the same aspirations to make decision-making more open, transparent, and inclusive.

The way forward regarding openness and transparency was discussed with the Governor at the earliest opportunity, when all newly elected members convened for their initial meetings. From that first moment, even before discussions about who would become the four Ministers began, it was clear to me that the newly elected members intended to move forward together in the right direction — united in purpose and committed to increasing public confidence in how the government and council operates.

Since then, the public should have already begun to notice a positive change in the tone and transparency of recent press releases and public updates from both elected members and the Executive Council. These are early but essential signs that the new Council is serious about communicating more openly and ensuring that islanders are kept informed about key decisions and developments.

A collective movement is underway to improve public engagement. Work has already started to enhance access to ExCo information, to re-establish regular public briefings following meetings, and to ensure that collective responsibility does not impair fair scrutiny.

Furthermore, elected members are working together with a shared goal — to strengthen communication, improve decision-making, and rebuild trust between the public and government. While we may not always agree on every detail, there is a genuine sense of teamwork and respect for the principles of openness and accountability.

Although the path is not quite as I envisioned before the election, the direction of travel is clear. If it continues, the results will be better than I initially thought possible.

I am sorry to say that I will miss the first round of constituency meetings as I will be representing St Helena at the Green Overseas (GO) Workshop on Utility-Scale Renewable Energy for Island Grids, held from 28–31 October 2025 in Sint Eustatius. I will attend alongside Geoffrey Augustus, Technical Manager – Electricity at Connect St Helena, and Paul Cherrett, Head of the Programme Management Office.

This workshop will bring together representatives from across the Overseas Territories to share knowledge and experiences. The workshop aims to strengthen the capacity of small islands to integrate large-scale renewable energy — such as solar and wind — into their power grids. For St Helena, the lessons learned will directly support our goal of achieving 80% renewable energy by 2028, helping to lower the cost of living, reduce reliance on imported fuel, and improve our long-term energy security.

When I return, I look forward to sharing insights from the workshop. Together, we can create a cleaner, fairer, and more self-reliant future for our island.

During the election campaign, Karl Thrower and I outlined our key standards for openness in Government.

Since taking office, the Chief Minister has moved deliberately to strengthen transparency: publishing an Executive Council Report after every meeting, redacting only genuinely confidential items, and using press releases and radio interviews to explain decisions in plain language. These steps reflect the commitment she made on the campaign trail to openness, fairness, and communication, and they demonstrate that our shared aspirations are already translating into action.

Karl's recent letter highlighted the positive change in tone and the early signs of improved public engagement—signs I've witnessed firsthand. Work is well underway to enhance access to ExCo information and re-establish regular briefings. I fully support the practical, stepwise approach the Chief Minister has set out: first understanding existing practices, then identifying which changes need formal Executive Council agreement, and finally ensuring we have the logistical capacity and resources to deliver new measures effectively.

A more open government cannot be achieved overnight, but by advancing these reforms in manageable stages, we build momentum and public confidence. I remain committed to open and honest Government, and I am satisfied that the Chief Minister and my fellow ministers, are united in strengthening accountability.

It's been a busy and fulfilling quarter for MFCS, with key projects and scientific work going well and some highlights along the way:

MFCS Hosts Marine Training to Support Sustainable Tourism



MFCS Recently, delivered accredited marine tour operator training session for members of the St Helena National Trust's marine team and the island's tourism marketing team. The session focused strengthening participants' policies, understanding of the legislation, and best practices that guide sustainable marine tourism on St Helena. highlighted training importance of compliance, awareness, and clear communication in ensuring that visitors experience the island's natural heritage in a way that

both enjoyable and environmentally responsible. By building this knowledge, the teams are now better equipped to promote St Helena's commitment to sustainable marine tourism, ensuring that the island's rich ocean environment remains healthy and wellmanaged for the future.

iRecord St Helena: Supporting Conservation Through Citizen Science



St Helena has recently transitioned to a new online platform that brings together wildlife records from across the island, making it easier than ever to record, manage, and share biodiversity information in one place. Designed to support research and conservation efforts, iRecord St Helena allows users to submit their wildlife sightings, which are then verified by experts and added to a growing database. By joining the iRecord community, individuals can contribute valuable data, explore interactive maps and graphs of their records, and play an active role in protecting St Helena's biodiversity. The website is managed by the St Helena Research Institute, and the initiative aligns with the objectives of the BEST 2.0 Plus programme. This EU funded programme promotes biodiversity conservation and the sustainable use of ecosystem services in Overseas Countries and Territories, helping to advance climate change adaptation and sustainable development goals.

Marine Fisheries and Conservation Section: Laboratory **Facilities**



Marine Fisheries Conservation section houses a fully equipped laboratory with dedicated wet and dry lab spaces, supporting a wide range of scientific and technical tasks. The wet lab features sinks with retractable taps for easy washing, drying racks, and ample bench space for handling samples and equipment. The dry lab is equipped with a fume cupboard, high quality microscopes, a laboratory oven, and controlled storage for specimens and materials, including both fridge and freezer space. Additional outdoor washing facilities are available separately from the main wet and dry lab areas, helping to maintain cleanliness and efficiency within the Both spaces are well organised and designed to support safe and efficient workflows, providing a professional environment for conducting a diverse range of scientific work. These facilities are also available for use by visiting researchers and scientists.

Understanding Community Engagement in Marine Conservation: **Results from Socioeconomic Survey**



As part of the long-term monitoring of St Helena's Marine Protected Area (MPA), a

recent community questionnaire was carried out to better understand how people use the MPA and what value

This survey supports the St Helena Marine Management Plan 2023-27, which sets out how the island's unique marine environment will be conserved and managed for current future generations. responses provide important insights into the social, cultural, and economic importance of the MPA, helping to assess whether the plan is achieving its Encouragingly, the results show an overall increase in public knowledge and awareness of the MPA compared to a similar survey conducted in the past. This is a positive sign that community engagement and outreach are making a difference. A summary of the findings has been compiled in a dedicated report, which will help guide future planning and support continued improvement in marine management.

St Helena Featured in Global Effort to Track and Protect Marine Megafauna



A major international study involving nearly 400 scientists under the MegaMove project has revealed that a

third of the ocean's largest animals, such as sharks, sea turtles, and whales, are at risk of extinction. Using over 12,000 movement records collected over 30 years, the study tracked more than 110 species across nearly 72% of the ocean, making it one of the most comprehensive efforts to understand marine megafauna behaviour. St Helena was one of the locations included in this global study, with its surrounding waters playing an important role for several marine megafauna species. Many of the animals highlighted in the research, including whale sharks, humpback whales, and various species of sharks and turtles, are known to frequent island's waters. The research shows that these animals rely on about two thirds of the ocean for critical behaviours such as migration, feeding, and breeding. However, more than 75% of these key areas overlap with harmful human activities, including fishing, shipping, pollution, and climate change.

Scientists emphasise that alongside marine protected areas, additional actions such as regulating fishing practices, reducing pollution, and improving international cooperation will be key to giving these ocean giants a better chance of survival. Protecting marine megafauna is not just about conservation targets. It is about making informed, practical decisions that reduce harm and help ocean life thrive for generations to come.

Along with Ascension and St Peter and St Paul Rocks, St Helena sits proudly on the Mid Atlantic Ridge, serving as a natural laboratory where scientists study how marine life moves, lives, and evolves in some of the most remote ocean habitats Because of this unique environment, St Helena, together with Ascension and St Paul's Rocks, was chosen to be part of an international study that highlights the important role our

waters play in supporting marine life. Our long period of isolation has helped shape a distinctive marine community around our shores. While Ascension and St Paul's Rocks have their own unique marine life, St Helena supports numerous species, many of which are found nowhere in the world. else makes marine What our environment even more remarkable is how ocean currents and natural factors influence the variety of species that visit and inhabit our waters. Though Atlantic currents generally flow east to west, many fish species travel from the western Atlantic to our islands, creating vital underwater links across distances. Some species may also arrive from the Indian Ocean via southern Africa. Whether species reach us depends on many factors including their size, swimming behaviour, development, and local water conditions such as temperature and habitat. Studying marine life around St Helena, Ascension, and St Peter St Paul Rocks has helped the scientific community better understand how species spread, adapt, and sometimes become unique to specific islands. This knowledge is essential for appreciating our ocean's richness and protecting these precious ecosystems as they face challenges. Our island's marine

The gathering brings together scientists, marine stakeholders, resource managers, and policymakers to advance the use Ecosystem Integrated Assessments (IEAs) across the Atlantic.



Helena contributes International Conservation Forum for UK Overseas Territories 2025



St Helena will be proudly taking part in the upcoming UK Overseas Territories Conservation (UKOTCF) conference, which will be held online from 13th to 16th October 2025. This international event brings together participants from across the UK's Overseas **Territories and Crown Dependencies** to share experiences, ideas, and practical solutions for protecting our unique natural environments. The conference is organised by the UKOTCF, a UK based non-profit organisation that supports conservation in all UK Overseas Territories, including St Helena. With many of these places home to rare and irreplaceable biodiversity, the forum provides an important communities, opportunity for conservationists, government staff,

and organisations to come together work towards shared environmental goals. Key topics at the forum will include how to build capacity in small and remote territories, how to secure long term funding for conservation, and how to make better use of technology and data to monitor and protect wildlife. Sessions will also explore how local conservation efforts contribute to wider international targets. Unlike a traditional conference, this event is designed to be practical and forward looking. Rather than a series of stand-alone presentations, it will focus generating on useful recommendations and actions that can directly support conservation work in the territories. 
