From the Cerys Joshua Ocean Log Book

Cerys Joshua is enjoying life on the ocean waves on "Aurora", as one of the two Open Ocean crew. The Open Ocean is a 'St Helena only scheme' that helps with the costs of the 4,500 mile, 48-day voyage. Wavysail brings people who seek adventure twice a year to St Helena on the REAL Atlantic - not the North Atlantic that "everyone" does. This is the South Atlantic. Massive, desolate and isolated. The return trip is over 4,500 incredible sea miles as Wavysail describe it.

7th November Weather Delay - departure was delayed slightly thanks to a rather uncooperative weather system. As tempting as it is to get going, it simply isn't sensible to set off into a gale when waiting a touch longer means a safer and more comfortable start. Good seamanship usually looks like patience.

The extra days haven't gone to waste, though. The crew have been busy with final preparations — stocking up on food and fresh supplies, stowing gear, checking and rechecking systems — with a little bit of time squeezed in for some sightseeing and a breather before the routine of ocean life begins.

Looking Ahead, skipper Wavy Immelman logged, the forecast is for the wind to drop tomorrow and allow us to head north to Saldanha, where we will overnight, and head on north on Saturday morning early. The sail should take +/- 48 hours to reach Luderitz from Saldanha, and we want to arrive on Monday morning when we will be able to come ashore and clear customs and immigration (Closed on the weekend). Therefore, planning a Saturday morning departure is perfect for our Monday morning arrival.

9th November - Yesterday started out very pleasantly as we left Saldanha. Fair winds, mild swells and light clouds. We spotted a couple of Heavyside's dolphins on the way out, then

passed a Gannett colony that smelled so bad! Most of the day was spent spotting the tons of seals and humpbacks that were playing, splashing and breaching. We had two whales surface right next to the boat to say hi, and shortly after, a very large stingray was also rather curious.

Cerys crewmate, Hannah logged, I went down to catch some shut eye, about 2 hours before my shift I heard the engine cut off and commotion on deck. The wind was back; that's for sure! We were on quite the heel and being bashed around. I started feeling queasy being in the forepeak, so thought screw it, let's go see what's happening on deck. Lexi and Sara were on watch and doing very well beating into the 26-knot wind, in full fog, trying to get as north as possible. Then I took over...Sara did her best to help me get on course, but I got so disoriented with the fog and honestly a little terrified at how steep we were. Next thing I know Wavy runs up wanting to know why I'm taking us back to Cape Town! It was decided to put another reef on the sail - I felt like I was fighting for my life just to stay upright at the wheel, never mind to also keep the yacht on track as Marc climbed the mast. 3rd reef in, we then needed to gybe. We kept beating into the wind until the swell and then wind died at 2am. I can't lie, it was a bit of a relief when the jib came in and the engines came on.

10th November - First Mate Marc logged, Before the moon rose, the sea treated us to one of those moments that makes ocean sailing unforgettable. The water around us came alive with bioluminescence, glowing trails swirling along the hull. Cerys even spotted dolphins swimming through the glowing plankton, lighting up like shooting stars beneath the surface — a light show no photograph could ever capture.

By morning, Hannah and I were on watch as the fog finally began to lift. One shadow in the grey became two... then three... and before long we counted nine whales in total. One of them performed a full breach, its enormous body slamming back into the ocean with a force that sent small fish leaping out of the water, stunned by the impact. A raw, unforgettable display of power.



Sarah looked after us beautifully at lunch, whipping up bacon and French toast. As we finished eating, the sun finally pushed through the last of the fog, allowing us to peel off a few winter layers at last. Tonight, I'll be treating the crew to a proper macaroni and cheese. I'm hoping everyone will enjoy it after the day's adventures — though after bioluminescent dolphins, breaching whales and aerial acrobatics from seabirds, I'm not sure any dish will quite compete.

Statement by UK Ambassador to the UN's Special Political and Decolonisation Fourth Committee

This United Nations committee focuses on a wide range of political issues, primarily decolonisation and self-determination for non-self-governing territories. In the British Overseas Territories, the main focus is on Gibraltar and the Falklands. The same opinions are repeated every time this subject is discussed. This is the speech by Simon Thomas, the UK ambassador to the UN at the most recent meeting

Let me start by reiterating that the United Kingdom has a modern relationship with all its Overseas Territories based on partnership; on shared values; and on the right of the people of each Territory to choose to remain British or not.

The UK Overseas Territories are self-governing, subject only to the UK retaining powers to carry out its obligations under international law.

We have a close bilateral relationship with each Territory, and the UK and Overseas Territory Governments hold a Joint Ministerial Council each year to monitor and drive forward collective priorities for action in the spirit of partnership.

We are committed to supporting the Territories on their priorities, including environmental protection, and carrying out our constitutional responsibilities, including guaranteeing security.

Last week, the Committee heard directly from the Chief Minister of Gibraltar as the elected representative of its people.

We welcome their participation and restate that the UK's longstanding commitment to the people of Gibraltar remains unchanged.

Across the Territories, we provide financial and practical support to build local capacity and resilience, and have projects underway to build new infrastructure, including a new hospital, ports and much more.

I will address specific points relating to two of the UK's Overseas Territories. Firstly...

Statement by UK Ambassador to the UN's Special Political and Decolonisation Fourth Committee

The UK will not enter arrangements under which the people of Gibraltar would pass under the sovereignty of another state against their freely and democratically expressed wishes. The United Kingdom also reaffirms that it will not enter a process of sovereignty negotiations with which Gibraltar is not content.

In December 2020, the UK, with Gibraltar, agreed a Political Framework with Spain for how a future agreement between the UK and the EU in respect of Gibraltar would function in the interests of all parties.

UK-EU negotiations began in October 2021. The UK, working side-by-side with the Government of Gibraltar, reached a political agreement with the EU on the core aspects of a Treaty in June 2025.

All parties are committed to finalising the text of the UK-EU Treaty in respect to Gibraltar as soon as possible.

The second specific issue I wish to address is the Falkland Islands.

The United Kingdom has no doubt about its sovereignty over both the Falkland Islands, and South Georgia and the South Sandwich Islands, and their surrounding maritime areas.

Nor do we have any doubt about the Falkland Islanders' right of self-determination.



Falklands

This is enshrined in the UN Charter and in Article One of both UN covenants on human rights, by virtue of which they are free to determine their political status and pursue their economic, social and cultural development.

In the 2013 referendum, which was conducted in line with international standards and was observed by independent, international observers, 99.8 per cent of those who voted wanted to remain their current status as a British Overseas Territory.

This result sent a clear message of self-determination, and that the people of the Islands do not want dialogue on sovereignty.

These wishes, expressed freely, should be respected.

Tristan Represents St Helena and Ascension at London's Remembrance Ceremony

I was honoured to lay a wreath on behalf of Tristan and our sister islands of St Helena and Ascension, at the Cenotaph on Whitehall in the presence of His Majesty King Charles. The King and Queen, the Prince and Princess of Wales and the Duke and Duchess of Edinburgh led the national act of Remembrance, where a service was conducted by the future Archbishop of Canterbury Dame Sarah Mullally.

Tristan alternates with St Helena to pay tribute on behalf of the whole Territory. It was a special privilege to participate in a year that commemorates the 80th anniversary of the Allied victory in World War Two.

Card Payments of Various Types Now Possible on Tristan

During my time on island, I have used the term "game changing" many times, from high-speed internet to solar energy. The card machines also fall into this category. The ability to take credit card payments from tourists and other visitors means that they aren't limited by the amount of cash they carry, which is often not very much.

A big thank you must go to Chief Finance Officer Paul Mapasure, who has persevered for the best part of two years to get the banks to recognise the need and offer us the facility to take the payments. Thanks too, to FCDO Desk Officer, Charles Wickham, for bringing the two card machines with him when he arrived last week. We only have two machines for now, as we want to test them and make sure they work for us. The early indications are good and we have taken payments from various types of card, both with a PIN and contactless. I even used Apple Pay on my phone (other mobile payment options are available) to buy my lunch on Wednesday, and I heard that one of the visitors made a contactless payment using his watch.



Like most modern payment systems, this comes at a cost to us, hence the 5% service charge which we are passing on to the customer.

At the moment we have the facility only in Tourism and the Post Office but hope to roll it out further once we are happy that it works.

Overseas Territories Joint Ministerial Council

Chief Minister, Dr Rebecca Cairns-Wicks MBE, is due to depart St Helena tomorrow to travel to the UK to attend the annual Overseas Territories Joint Ministerial Council (JMC).

The JMC is the principal forum for reviewing and implementing the shared strategy for promoting the security and good governance of the Territories and their sustainable economic and social development.

The Overseas Territories Joint Ministerial Council brings together political leaders from the Overseas Territories and UK Ministers. It will meet this year in London from 26 - 27 November and will be hosted by FCDO Minister for the Overseas Territories Mark Simmonds MP.

The Chief Minister will also have a number of official engagements before and after the event itself. These engagements will include a bilateral meeting with Stephen Doughty, Minister of State for Europe, North America and Overseas Territories and meetings with other UK Government Ministers, OT leaders and other representatives.

The Chief Minister will be joined by Governor Nigel Philips and SHG UK Representative, Kedell Worboys The Chief Minister is due to arrive back on St Helena on Saturday 6 December. During the Chief Minister absence, Minister Martin Henry has been appointed Deputy Chief Minister.

Rebecca Cairns-Wicks said:

"I am honoured to represent St Helena at my first UK Overseas Territories Joint Ministerial Council. This is an important opportunity for our new Government to raise St Helena's voice directly in the UK, to showcase St Helena's progress and achievements over the last year, highlight our challenges, set out our plans for development and advocate for the support needed to build a more sustainable and resilient future for our island."

Andrew Turner Answers Questions on Education Service

At the heart of every thriving society is a commitment to Education. In the recent Legislative Council session, I had the opportunity to share progress on several key initiatives that are shaping the future of education, training, and employment on St Helena.

In response to a question from Hon. Dr Corinda Essex, I reaffirmed our shared goal of establishing the long-awaited Student Scholarship Trust. With input from the Attorney General's Chambers now under review, we are laying the legal and

structural foundations to make this vision a reality. I have been working with Dr Essex to collaborate further, recognising her longstanding advocacy and expertise in expanding student support. This initiative is about unlocking potential and ensuring that our young people are given the opportunity to succeed.

Hon. Robert Midwinter raised an important question about vocational students receiving below minimum wage for their 35-hour weekly placements. This arrangement is recognised as part of a structured training programme, and as such, does not constitute employment in the conventional sense. However, I acknowledged this issue and highlighted existing support mechanisms, such as the Youth Top-Up scheme through Income Related Benefits. More significantly, I announced a comprehensive review of all post-16 education including vocational training and tertiary pathways. This review will help us understand the system that connects education to employment, ensuring every young person can see a future for themselves on this island.

In response to a question from Hon. Julie Thomas, I confirmed that Phase I of the Primary School Reorganisation is progressing on schedule.

The works have already begun at St Pauls Primary over the school holidays. Planning permissions and approvals are being finalised, and expressions of interest for contractors have been advertised. As Harford Primary building works are due to get underway, the preparations for relocating KS1 and KS2 students are being handled with care and creativity.

Our youngest students, in particular, are at a formative stage of life, they are naturally more vulnerable and need to feel not only physically safe but emotionally secure.

For our students, staff and parents, we are prioritising wellbeing and continuity through:

- Relationship Building Week and Induction Days to ease transitions.
- Wellbeing strategies involving psychologists, therapists, and a new SENDCO.
- · Legacy projects to honour school histories.
- Open communication with families and staff to build trust and reduce uncertainty.

This project is a renewal of our promise to every child on this island, a promise of opportunity, support, and a future worth striving for.

I want to say a big thank you to all the Staff in the portfolio, the parents for bearing with us during this change and of course to all our students whose resilience, adaptability, and enthusiasm have truly inspired us throughout this period of change.

Governor and Chief Minister to Attend Joint Ministerial Council

Chief Minister, Dr Rebecca CairnsWicks MBE, is due to depart St Helena on Saturday 15 November 2025, to travel to the UK to attend the annual Overseas Territories (OTs) Joint Ministerial Council (JMC).

The JMC takes place every year in London and is hosted by the UK Government. It brings together elected leaders and representatives from all the OTs, as well as UK Ministers, and provides the principal forum for political dialogue and consultation between the UK and the OTs.

The JMC is due to begin on 24 November 2025, with the main formal discussion meetings taking place between 26 and 27 November. The Chief Minister will also have a number of official engagements before and after the event itself. These engagements will include a bilateral meeting with Stephen Doughty, Minister of State for Europe, North America and Overseas Territories and meetings with other UK Government Ministers, OT leaders and other representatives.

The Chief Minister will be joined by His Excellency the Governor Nigel Philips CBE and SHG UK Representative, Kedell Worboys MBE.

The Governor and the Chief Minister are due to arrive back on St Helena on Saturday 6 December. Whilst they are offisland, Tasha Harris, Head of the Governor's Office, will be sworn in as Acting Governor and Minister Martin Henry will be appointed Deputy Chief Minister.

In speaking about her attendance at the JMC, the Chief Minister said:

"I am honoured to represent St Helena at my first UK Overseas Territories Joint Ministerial Council. This is the most important annual political event in the calendar for St Helena and all UK Overseas Territories (UKOTs). Bringing together UK Ministers and elected leaders from each Territory to discuss key issues, agree priorities, progress action and strengthen the partnership between the Territories and the UK Government. This is an important opportunity for our new Government to raise St Helena's voice directly in the UK, to showcase St Helena's progress and achievements over the last year, highlight our challenges, set out our plans for development and advocate for the support needed to build a more sustainable and resilient future for our island."
