What a successful St. Helena's 2025 St Helena Agricultural Show Day ! Well done all.

What great community spirit! This was something that was first thought would not be possible, but thanks to the hard work of the organisers and district reps, their immense efforts made it an overwhelming success.

The show was opened with a powerful opening address, delivered by the island's Culture Champion, Councillor Dennis Leo.

Denny framed the event as a tribute to the "hard work that binds us together" and a reminder of the community's deep-rooted connection to the soil.



The speech highlighted the long history of agriculture on the island, tracing it back to the first known inhabitant, Fernando Lopez, who planted fruit trees and tended livestock centuries ago. This legacy was further reflected in the early 1800s by Governor Alexander Walker, who introduced the first agricultural fairs to build "pride and self-reliance."

Denny emphasised that the show celebrates more than just farming. It honours the resilience of the island's identity, which has "weathered drought, storms, and shortages." The event recognises everyone who contributes, from farmers and animal raisers to backyard gardeners, bakers, and artisans.



"It isn't just about food. It's about culture, connection, and community. Each seed we plant carries our history. Each animal we rear carries our hope."

A key message was directed at the island's youth, who were called the "future caretakers of this land." Denny stressed that agriculture is vital to their future, holding opportunities for innovation, conservation, and new creative ideas.

After thanking the organisers, volunteers, sponsors, and exhibitors, the show was officially declared open. The event invites all to celebrate the "love, patience, and community" that defines St. Helena.

The event was not only witnessed by local viewers on the Island but also streamed live on Facebook, thanks to Derek Richards from Island Images.

Derek commentated on the event, mingling amongst the exhibitors and chatting to spectators.

The stream has been viewed by more than 10k viewers in less than 24 hours.









On Sunday 16<sup>th</sup> November, members of the Ascension Community gathered at the islands Air Head Terminal for a fundraising Runway Dash in aid of St Mary's Church.

It was an event dedicated to all ages and abilities, some walked while others run, cycle or enjoy the ride in a stroller.

It was reported to be enjoyed by all and following the walk, all participants were invited back to the Volcano Club for snacks and a medal presentation.





#### **Verdict: from Observers at September's General Election**

Recommendations covering many aspects of general election management were published this week by the delegation from the Commonwealth Parliamentary Association (CPA) who were invited to observe how elections are run in St Helena.

From comments in a 26-page report, there are eleven recommendations. The seven-strong delegation was led by Gary Clueit, A member of Tynwald, the Isle of Man Parliament. In his introduction, Mr Cluett wrote, ""On Election Day, we observed a process that was transparent, well-organised, and professionally managed. The commitment and professionalism of those involved in delivering the election were evident throughout the day. We hope our initial observations and forthcoming report will support the people of St Helena in continuing to strengthen democratic processes on the island." He added, "On a personal note, I would like to say, and I believe that I speak on behalf of all seven members of the Mission, that St Helena has seven new ambassadors for your wonderful island."

#### **The Main Issues**

#### One Constituency but No Choice of Eight Polling Stations

The report points out the whole island is one constituency but voters are restricted to voting in the district where they live. The CPA observers thought this restriction may reduce turnout. The report also includes the recommendation that people queueing outside a polling station at 7pm when polling stations close, should be allowed to vote.

One point not mentioned is that polling stations do not open until 10 am, so there is no opportunity to vote on the way to work and little opportunity to vote during the working day. SHG announced during the run-up to election day that electoral law "requires employers to allow employees a reasonable period of time for voting and that no deduction must be made from an employee's pay or other remuneration when they are given time off for voting". There was also a reminder that if employers refuse to allow their employees the opportunity to vote during working hours "the penalty for such is a fine of £1,000 or imprisonment for 6 months, or both."

Why should an employer give employees time off work when it can be argued there is time to vote after work? Polling stations close at 7pm. Polling stations often open much earlier than 10 am, 7 am is a more usual time.

An earlier opening time would give the opportunity to vote on the way to work and lifting the restriction on where to vote could allow some voters to visit a polling station during lunch time. Let's face it; staff shortages on our depopulated island cause long waits in queues already; the last thing we need is regulations that bring the island to a complete halt.

#### The Right to Vote

The CPA observers consider the eligibility restrictions on the right to vote are "overly broad". The report states, "Universal suffrage is guaranteed for St Helenian-status individuals aged 17 and above, but eligibility restrictions – such as for dual allegiance, mental incapacity, long prison sentences and electoral offences – are overly broad. These provisions conflict with international standards on proportionality and non-discrimination, particularly under the Convention on the Rights of Persons with Disabilities and the International Covenant on Civil and Political Rights (ICCPR)." It is also pointed out, "The Elections Ordinance disqualifies several categories of individuals from voting:

- those who show "allegiance, obedience or adherence" to a foreign power or state;
- are certified as incapable of making decisions due to mental incapacity;
- are serving a prison sentence longer than 12 months;
- were convicted of electoral offences (barred from voting for seven years following their conviction).

These restrictions contravene a number of international standards.

A statutory curtailment of voting rights for anyone with St Helenian status who also holds foreign citizenship lacks clear definition and guidance, thus risking arbitrary application. This may undermine the principles of universal and equal suffrage and runs counter to norms requiring that any limitation on suffrage be based on objective and reasonable criteria, proportionate to a legitimate aim, and not discriminatory in nature."

#### Voter Registration

The CPA observers state, "Registration is active and closed long before election day, limiting late participation and poorly aligning with campaign phases. Only 2,041 voters registered, with youth underrepresented and diaspora largely excluded. Stakeholders call for extended deadlines and reforms to allow St Helenians abroad to vote."

"These timelines, designed to allow for gazetting and legal scrutiny of the Register, are widely regarded as limiting opportunities for voter registration during the campaign period. Many stakeholders expressed a preference for extending registration deadlines, including up to election day. The existing registration deadline also poorly aligns with nomination and campaign phases, curbing candidates' ability to promote voter registration. Voter education efforts were limited, largely confined to notices in local newspapers and were generally considered insufficient."

#### **Other Comments**

Governance reforms have improved accountability but remain slow, with unclear roles and limited transparency; a Governance Commission is engaging the public on further changes.

While the 2009 Constitution Order and associated regulations broadly enable democratic elections, it is outdated and lacks provisions for campaign finance, alternative voting methods and administrative complaints. International treaties such as ICCPR and CEDAW apply, but CRPD has not yet been extended.

Election operations were professional and impartial, voter education remains limited and underresourced, relying mainly on traditional media and minimal digital outreach.

The candidate nomination process was inclusive and efficient, with 23 candidates standing, but the short timeframe – closing only two weeks before polling – limited grievance resolution. Confusion over impartiality rules discourages some civil servants from acting as sponsors or supporters, creating uncertainty.

Campaign finance is entirely unregulated, with no spending limits, disclosure requirements, or auditing. This undermines transparency and accountability and risks foreign influence. Calls for regulations to ensure a level playing field and public trust are growing.

Media coverage was factual and neutral but lacked critical analysis of policies. Reliance on government advertising may constrain editorial independence and limited diversity reduces scrutiny. Digital campaigning is increasing, highlighting the need for clearer online regulations.

Legal and practical barriers persist for participation of persons with disabilities, including disqualification for mental incapacity, inaccessible polling stations and lack of assistive tools. CRPD has not been extended, and assistance rules could compromise ballot secrecy. The Council chamber remains inaccessible, discouraging candidacy.

Women do hold key positions, but representation in the Legislative Council fell to four out of 12 seats. No measures exist to promote women's participation despite international obligations under CEDAW. The count was transparent and broadcast live, but slow and labour-intensive, concluding at 5am. While the process reflected the will of voters, procedural improvements could enhance efficiency without compromising integrity.

Judicial remedies exist through election petitions, but no election specific administrative mechanism is in place. This limits accessible redress and transparency.

#### The Chief Minister's Brief Moment of Fame

Chief Minister, Dr. Rebecca Cairns-Wicks, was interviewed on Tuesday during a broadcast by the BBC World Service in conjunction with the COP30 Climate Change Conference in Brazil.

Rebecca focussed first on the big problems associated with attracting funds for any climate change action plans. She pointed to the Green Overseas (GO) Programme as an example of islands working together and benefitting from it. Ironically, the GO Programme is funded by the European Union, not the UK.

The interviewer asked if the difficulties were compounded because Britain negotiates on St Helena's behalf, leaving St Helen with limited direct influence. The Chief Minister pointed to the 'partnership' British Overseas Territories have with the UK and the Joint Ministerial Council which she will be attending later this month. However, she did say St Helena is 'highly dependent' on obtaining UK funding to mitigate the adverse effects of climate change.

Also being interviewed was Vishal Prasad, Campaign Director at Pacific Islands Students Fighting Climate Change. Speaking after Rebecca, Vishal was asked his view on developed countries pulling back from climate action, citing the UK pulling it's funding for Brazil's flagship plan to protect the Amazon rain forest.



Vishal is from Fiji, one of the Pacific Islands at the front line of destruction through climate change. There is a stark contrast between St Helena and many Pacific Islands. Vishal mentioned low-lying Tuvalu, Kiribati, and the Marshall Islands which are threatened with disappearing completely beneath the waves. He also mentioned forty communities in Fiji that had to be relocated because the advancing ocean displace them. For the Pacific Islands, climate threatens in several ways; including extreme weather events such as floods and cyclones, sinking islands, increased displacement, biodiversity loss, rising sea-levels, economic and food insecurity and the spread of infectious diseases. These issues can sometimes feel overwhelming and seem never-ending.

In 2019 SHG published 'A Climate Change Policy for St Helena'. The policy itself is very short, superficial and incomplete. It is not known if the 2019 Policy has been updated or replaced. There was no-one at SHG to respond to enquiries. Nothing can be found on the SHG website. The 2019 Policy mentions Climate Change Action Plans. The 2019 Policy states Climate Change Action Plans will be developed for sustainable homes, energy generation, waste management, transport system, low carbon economy, lifestyles, planning, agriculture and land use. Again, there is no sign of any of them and no-one available at SHG to provide information.

Not mentioned is the effect of climate change on the marine environment. Not mentioned in the Policy and also ignored in the long list of Action Plans. This does not mean we are unaware of threats to our marine environment but a comprehensive and cohesive plan to identify the number and extent of climate change threats is not visible. Is it that we have a problem getting funding for action against climate change, but if we did get some, we would not know what to spend it on? Apart from what there is in which order. Where are the plans? Where are the priorities? Yesterday, Karl Thrower, Minister for Economic Development, Environment, Natural Resources & Planning spoke on behalf of the island at an Island Voices @ COP30 session. It will be interesting to know what he talked about. The 'more information' link did not have more information on what Karl was doing.

#### A Not So Happy Christmas at Rupert's Cargo Handling



'Can you wait a bit'. That's the message for people who have ordered items from overseas for Christmas and are expected on the recent arrival of the Karoline. The ship arrived on Monday morning and left on Tuesday afternoon for Ascension; expected arrival at Ascension is midday today. During that time, it's reported the consolidated cargo unloaded at Rupert's hasn't moved much. The situation explained by consolidated freight handlers is the process in place for unloading

containers so cargo can be sorted for customers is a cause of delay. There are also more containers on this week's shipment – overall, there are about ten or so more containers than usual.

People expecting to collect items they have ordered are asked to use the pre-payment method for import duty to save time when making collections.

This involves emailing the invoices for the goods listed on the manifest, to Customs at cienquiries@ sainthelena.gov.sh. If the waybill (HM Customs Simplified Declaration) has been provided, email that too. Import duty will be calculated and an Assessment Notice is emailed back showing the required import duty payment. The Assessment Notice together with proof of payment at the Post Office, at the Bank or online can save a lot of time when shown at the time of collection.

For the major importers with full container loads the story is different. The message from feedback is clear. There is much more space to work in. It is a safer working environment because people are not passing by the working area for all sorts of purposes, and the unloading of containers and loading of delivery vehicles is quicker for those reasons. The downside is the time and cost of transporting the cargo to Jamestown. To end on a lighter note, Napoleon Street is said not to present any more problems than it has always done for pedestrians as well as vehicles.

Another not-so-welcome new feature since cargo handling moved to Rupert's is Solomon's Cargo Handling Tariff. In addition to the cost of the imported cargo and cargo collection costs, plus sea freight and handling charges, there is now the Solomon's cargo handling charge at this end. Where this cost disappeared to before is unknown. Now it has a separate line on the invoice. The handling charge is £2.50per cubic metre. This means that moving 40 boxes of printing paper around Rupert's cargo area costs nearly £1 per box. This is almost as much as the haulage charge from Rupert's to the Independent's printing machines. The increases in the cost of doing anything is relentless.

# Are Falkland Islanders somehow more deserving than Saints?

#### Explainer -

The Falklands campaign group Justice4Patients has successfully reached a settlement with the Falkland Islands Government (FIG) and the King Edward VII Memorial Hospital (KEMH) over medical data breaches that occurred in 2019 and 2022.

Two former staff members at the KEMH, the islands' only hospital, accessed the confidential medical records of hundreds of patients without authorisation. The 2022 breach alone affected around 289 patient records.

There are clear similarities between the Falklands unauthorised access to confidential medical records and the St Helena clinical negligence compensation claims.

#### Supreme Court of the Falkland Islands and Justice4patients

On Tuesday, in the Supreme Court of the Falkland Islands, the Chief Justice read the Consent Order in which the Falkland Islands Government accepted they had breached the Constitutional Rights of those members of the Justice4patients group who had their medical records illegally accessed.

The Consent Order includes a commitment by the Falklands government to pay compensation to those affected by the data breaches and the legal costs incurred by the group. There is also a commitment to an independent external review to understand what went wrong including why Government officers responded as they did when these concerns were first brought to their attention 6 years ago.

The Falklands campaign group, Justice4Patients were supported by Waverley Law, an independent law firm based in the Falklands. Justice4Patients state the satisfactory Consent Order marks an important point in their 6-year campaign and the end of their legal case.

#### **Falklands Forge Ahead Without Fibre**

When the 720-mile fibre optic connection was being laid from the Equiano cable to St Helena, the Sure Falklands customers were very envious of the promised benefits we in St Helena expected to enjoy. Falkland Islanders had long voiced frustration with Sure's high prices, restrictive data caps, and limited bandwidth. The telecom service handed down to them was even worse than we had to endure.

In the four years that have passed since then, the situation is reversed. After a tortuous time, the Falklands now have a telecoms service they are happy with while in St Helena we still await the real benefits of fibre-optic connectivity. After an equally tortuous time, St Helen has fallen short at the final stage.

The Falkland Starlink Petition Group recently announced, "the 3rd of November 2025 marks a truly historic and exciting milestone for the Falkland Islands: the official launch of licensed Starlink services, and the reopening of personal VSAT licensing by the Communications Regulator. This achievement represents the



culmination of a determined community effort and the tremendous success of the Starlink petition, which galvanised widespread support across the Islands to secure a more modern, affordable and reliable broadband future."

It all kicked off on the Falklands when the everexpanding network of Starlink communication satellites extended enough to cover the Falklands. In St Helena, Starlink was banned. In the Falklands antennae able to connect with Starlink were already in use. Restrictions applied for 'the public' but some businesses could obtain a licence for the antennae upon payment of an unbelievable several £thousands. The Falkland government regulations allowed the government free use.

While getting a licence for antennae was mostly impossible, getting all the necessary Starlink equipment was not. A major and unofficial switch from Sure to Starlink was underway. Government attempts to turn the tide were met with public anger. Sure Falklands complained bitterly that

their monopoly, high prices, restrictive data caps, and limited bandwidth were being challenged. We are very familiar with all of that.

Only the strong and sustained public protest persuaded the Falkland government it could sit on its backside any longer. They realised they would have to do what they are paid to do – sort out the mess, which was mostly of their own making. Sorting it out meant Sure Falklands lodged a legal challenge because the protections they enjoyed were being shredded. This led to serious negotiations with Falklands government. The result was that appalling antennae restrictions were swept away, Starlink was officially accepted and offered a welcome choice and Sure Falklands announced they will offer Unlimited Broadband For All from 1st December at much cheaper prices.

Meanwhile in St Helena we wait and wait for the big breakthrough.

#### Lloyds Bank interested in operating in the Falkland Islands

The Falkland Islands Government has published a notice in Falklands Penguin News announcing a public meeting where Matt Pendrey from Lloyds Banking (Head of UK Government & British Overseas, Institutional Coverage) would "promote and discuss" Lloyds Bank's institutional desire to be the No.1 Bank for the British Overseas Territories.

Standard Chartered Bank has been present in the Falkland Islands since 1983 and provides an essential service, but does not offer the facility to accept modern payment methods. Debit and credit cards are only possible in partnership with Gibraltar International Bank and Square.

The public meeting led by Matt Pendrey was held two weeks ago. Strangely, no follow up news seems to have been published. The Bank of St Helena and SHG have been in discussion with Lloyds Bank on and off over several years.

# Ascension – Sure South Atlantic Negotiations End with No Agreement

Ascension Island Government (AIG) announced on Tuesday they had come to the end of the road on negotiations with Sure South Atlantic. Sure had already stated it was their intention to pull out of Ascension on 28th February 2026. However, they did submit a revised proposal for a subsidy package.

Sure Issues Notice to Cease Telecommunications Operations on Ascension Island in February 2026

Last week the Island Council met to discuss the latest developments. It was reported the Governor had proposed the revised subsidy arrangements submitted by Sure should not be accepted and that a counter proposal from AIG should not be offered. This would effectively bring negotiations to a close.

The Island Council supported the Governor's proposal. Alternative options will now continue to be explored for the future provision of mobile telecoms on Ascension Island. It is recognised there may be a disruption to service while negotiations are concluded with a potential mobile telecom provider. However, they state it would be in the long-term best interests of Ascension Island. AIG state that further information will be provided as the situation develops.

#### Waste Lubrication Oil from US Base to be Used in AIG Incinerator

Waste lubrication oil from the United States Space Force (USSF) Base will be supplied to AIG and put to further use to enhance the combustion efficiency for solid waste processed through AIG's incinerator.

The AIG announcement states this partnership supports the One Island Vision to identify opportunities for collaboration on joint projects in support of resource efficiency, environmental impact reduction, and strengthening co-operation between island stakeholders.

#### Through the Lens

## Building St. Helena's Future: The Triple Challenge of Skills, People, and Connectivity- Written By *Ed Oyewo*

The path to a self-sustaining skills sector on St. Helena isn't just about training more people. It's about fundamentally transforming how we develop our human capital, connect to the world, and learn from the successes and failures of our fellow British Overseas Territories. With a workforce of just 2,539 people as of 2016, and many Saints continuing to seek employment in Ascension, the Falklands, and the UK, our island faces a challenge that's both urgent and familiar to small island territories across the globe. The question isn't whether we need to act, but how quickly we can move from planning to real transformation.

#### The Human Capital Challenge

The numbers tell a sobering story. According to government statistics, 60% of our economy depends on the public sector, with Public



Administration being our largest industrial sector. While this provides stability, it also means our private sector remains limited and heavily dependent on imports that totalled £30.7 million in 2024/25.

Our situation mirrors challenges faced by other British Overseas Territories, but the comparisons also show what's possible. Take the Cayman Islands, where a 2022 Labour Market Assessment revealed that 46% of future job growth is predicted to be in IT-related fields, yet only 8% of qualified Caymanians showed genuine interest in pursuing these careers. This mismatch between opportunity and interest is something we're beginning to see here too, particularly as our fibre optic connection opens new possibilities in digital services.

The Falkland Islands, with a population similar to ours, has tackled workforce development head-on with a comprehensive strategy that recognises a fundamental truth: *you can't build a skilled workforce without first making your territory an attractive place to stay.* Their approach focuses on housing, connectivity, and career development as an integrated package, not separate initiatives.

#### The Digital Divide We Must Bridge

In October 2023, St. Helena finally connected to the Equiano submarine fibre optic cable, a £21.5 million project funded by the European Union. This should have been transformational. The cable offers 100 Gigabits of bandwidth to Portugal and 10 Gigabits per second of internet capacity, a massive leap from the satellite service that previously gave our entire island an estimated 50 Megabits per second with latency reaching 600 to 700 milliseconds.

But here's where we must learn from painful lessons. The collapse of the Maestro Fibre Optic Project in mid-2024 means that despite having a multi-terabyte undersea cable landed on our shores, we still don't have the terrestrial fibre-to-the-home network to connect businesses and residents properly. It's like having a motorway that stops at the edge of town. Compare this to the Cayman Islands, where 81% of the population had internet access as of late 2025, and where the government has moved quickly to establish workforce development initiatives specifically tied to digital infrastructure. Cayman's experience shows that connectivity alone isn't enough. You need training programmes, digital literacy initiatives, and a clear strategy for how improved internet will actually change your economy.

#### Learning from Our Neighbours

When Montserrat, with a population of just 4,399 (mid-year 2024 estimates) and facing similar challenges to ours, needed to strengthen its nursing workforce, it didn't try to build everything from scratch. Instead, it partnered with Keele University and NHS trusts for a comprehensive three-phase training programme covering everything from online learning to evidence-based practice. This model of strategic partnerships is something St. Helena must embrace more aggressively. The Falkland Islands' Workforce Development Strategy makes another crucial point: you need a Skills Assessment Council to provide oversight and ensure that limited resources are directed toward high-impact actions. With our constrained budget and small population, every pound spent on training needs to deliver measurable returns.

#### The Path Forward

First, we must urgently resolve the terrestrial fibre network situation. Every day without proper internet connectivity is a day we fall further behind. The government's Communications Bill 2025, currently in consultation, needs to create a regulatory framework that actually drives deployment, not just regulates it. Second, we need a comprehensive digital literacy programme. Not just computer skills, but AI literacy, data analysis, cybersecurity basics, and project management. These are the skills that the Cayman Islands, with its stronger economy, has identified as essential. We need them even more.

Third, we must create formal partnerships with institutions in other BOTs and the UK for skills development. Virtual learning means geography matters less than it used to. Our students and workers should have access to the same quality training available in larger territories. Fourth, we need honest conversations about immigration policy and wage levels. The Falklands recognised that attracting skilled workers requires competitive conditions. We can't build a knowledge economy on poverty wages. Finally, we need accountability. A formal Skills Assessment Council, learning from the Falklands model, would ensure that our limited resources go toward training that actually meets economic needs, not just available courses.

#### The Stakes

St. Helena has historically depended on UK financial aid, as do Montserrat and Pitcairn among the BOTs. Our Sustainable Economic Development Plan rightly focuses on reducing this dependency by growing exports and substituting imports. But this won't happen through wishful thinking. The inflation rate hit 6.3% in Q2 2025, meaning the cost of living continues to rise while many incomes remain stagnant. Young people see this and make rational choices about their futures. If we want them to choose St. Helena, we need to offer more than sentiment and scenery. The good news is that we're not alone in facing these challenges, and we don't have to invent solutions from scratch. The Cayman Islands, Bermuda, the Falklands, and Montserrat have all wrestled with workforce development, connectivity, and economic diversification. Some have succeeded, some have struggled, but all offer lessons we can learn from.


All day, people had been preparing. Old clothes were stuffed with wool and hay, carefully shaped into homemade "Guys" that stood proudly beside each fire. Some were funny, some spooky, all stitched together with laughter and imagination. Children dashed about helping to gather flax, old crate boards, and bits of wood anything that would burn bright against the night sky.

As darkness settled, one by one, little flickers of orange began to appear across the island. Fires came to life near fences, gardens, and open spaces, their flames dancing and crackling in the cold air. The scent of

wood smoke carried on the wind, mingling with the distant sound of laughter and chatter. From afar, you could see the volcano silhouetted against the night, tiny pinpoints of fire glowing like scattered stars across its slopes.

Later in the evening, as the fires burned low. some people joined up for barbecues and nibbles. Smoke curled gently into the night sky, carrying the scent of grilled meat and the hum of easy conversation. It was the kind of night that reminded everyone what makes Tristan da Cunha special, a place where even small gatherings feel full of warmth, laughter, and connection.





#### 'Restoring a globally significant Cloud Forest'

#### **News from the St Helena Cloud Forest Project**



Welcome to another 'news bite' from the St Helena Cloud Forest Project!

Our innovative telemetered water monitoring network is expanding thanks to the work of our partners in Connect Saint Helena and the local Met Station.

Previously, surface water levels within our water catchments were read manually on-site via a stage board, however this information can now be accessed remotely in real-time from three monitoring sites, thanks to the expansion of the telemetry network using Hobo MicroRX Stations. This builds on the network that Connect has in place to monitor mist and rainfall within the Cloud Forest.

These stations allow water level data at the catchments to be available via the LI-COR Cloud portal in real-time. While they also have the capability to alert when water levels become critically low so mitigation measures can be put in place more efficiently. Catchments at Harpers, Drummond's Point and Black Bridge have already been upgraded, Wells Gut, Osbornes and Gents Bath are set to be upgraded next.


