


## Other Representatives at the Joint Ministerial Council


## **The Governor's Christmas Card Competition**





# TERRA NOVA

### **RMS Starts Its Fourth Life**

The former RMS starts another new life next year as a cruise ship with Terra Nova Expeditions. After her last voyage bringing passengers and cargo to St Helena, she spent a brief period in Middle East trouble spots supporting military operations. Thankfully, a

more glamourous job was around the corner when the former RMS had a comprehensive refit and served as the floating base for the Extreme E electric racing series. As part of this conversion, it received a range of sustainability upgrades, including hybrid-ready propulsion systems and onboard emissions monitoring technology. These updates modernised the ship's operations. The refit by Extreme E suited the ship for its next employment as an Antarctic cruise ship.

Terra Nova Expeditions, a company launched this year, will begin using St Helena for Antarctic itineraries under a long-term charter from 2026. The former RMS is central to Terra Nova's strategy of offering small-scale, environmentally responsible voyages. She will offer 11-day cruises at a cost of £9,000 to £12,000.

"St Helena represents the kind of thinking we admire: reuse over replace, purpose over polish," said Terra Nova's founder and chief executive, Greg Carter. "It's a rare breed – a vessel capable of reaching the world's most remote places while

carrying both guests and gear with self-sufficiency and grace. With its onboard cranes, robust build and unique mix of cargo and passenger capabilities, the ship is perfectly suited to the expeditionary model we believe in."

To prepare the vessel for commercial service in Antarctica, Terra Nova is carrying out a refit. Passenger accommodations and public areas are being upgraded, while motion-reduction technologies are being installed. Among these are retractable stabilisers to improve guest comfort and the See-LEVEL virtual reality system, a headset-based tool that seeks to mitigate seasickness by presenting stabilised imagery of the horizon.

"There's something special about giving a ship with history and character a renewed sense of purpose," says Carter. "St Helena embodies what Terra Nova is all about – going further with less, and doing it with meaning."

Passenger capacity is a key element of Terra Nova's model. St Helena will carry 98 guests maximum on any Antarctic voyage. This ensures maximum time ashore in line with Antarctic guidelines.

"With all the buzz about sustainable shipping, repurposing an older vessel is up to ten times more efficient than a newbuild in terms of carbon footprint," says Carter. "The ship's journey of reinvention continues under Terra Nova's stewardship, including a dedicated science lab and operational space for real-time research in the Southern Ocean."





## The Royal Navy's View of RFA Tidespring Visit

24 hours in St Helena: Tanker Tidespring's rare visit to South

Atlantic island

Sailors made the most of a 24-hour visit to one of the world's most remote islands when naval tanker RFA Tidespring visited St Helena.

Tidespring – second only in size to the Royal Navy's Queen Elizabeth-class carriers in the UK's Fleet – making her way home to the UK having spent the bulk of the year supporting the Carrier Strike Group. The carrier force returns home 29/30 November, but Tidespring broke away in the Indian Ocean, since when she has continued her deployment, visiting Cape Town in South Africa before making her way up the continent's western seaboard.

About the size of Swindon but home to fewer than 4,500 inhabitants, St Helena could only be reached by sea until an airport opened a decade ago (the nearest land – Angola in West Africa is 1,150 miles away). It's been four years (HMS Protector in 2021) since the Royal Navy last visited the British Territory, and a decade since the Royal Fleet Auxiliary – the navy's crucial support ships – in the form of tanker Gold Rover. Indeed, so isolated is the island that many of its children had never seen a helicopter – until the Merlin from Tidespring appeared.

The helicopter, normally based with 814 Naval Air Squadron at Culdrose in Cornwall, has been attached to the tanker throughout her mission performing a combination of general duties and its dedicated role of hunting submarines.

It flew ahead of the ship to give some of the RFA crew a rare bird's eye view of St Helena, as well as capture some aerial video and stills of the island.

The next morning, the ship arrived, anchoring at first light in James Bay off the capital Jamestown – the small

harbour cannot accommodate a ship of Tidespring's size.

The tanker came to a stop just four cables –  $\frac{3}{4}$ km – from the wreck of RFA Darkdale, which was torpedoed and sunk by a U-boat in 1941.

Commanding Officer Captain James Wingrove RFA laid a wreath at the Cenotaph to commemorate all those perished on the Darkdale prior to proceeding to Plantation House for a reception with the Acting Governor Tasha Harris.

As well as the governor, Plantation House is also home to Jonathan the Giant Seychelles Tortoise, the oldest living creature on Earth (circa 194 years old).

Despite the brevity of the visit, 100 of the 107-strong ship's company managed to get ashore, many opting to have a crack at the infamous Jacob's Ladder (699 steps rising 600ft on a 2:5 incline, linking Jamestown with an historic fort above the town). The record for the ascent (4m 40.75s was never in danger).

Many crew wandered off to visit the tomb of Napoleon (Boney spent his final years exiled on the island after Waterloo; his body was subsequently returned to France and its present home in Paris), bought souvenirs (fridge magnets and the world's rarest and purest honey), and were warmly received by the Jamestown community throughout.



"A brief but fantastic visit, offering the ship's company a rare opportunity to visit of one the most remote islands in the world, and highlights the UKs commitment to its overseas territories," said Captain Wingrove. "The hospitality and the warm welcome was greatly received by all, hopefully ships can visit sooner and more often."

#### Ministers Question Time: Where Are We With Renewables?

Answer: The Government is Still Looking at It

Ministers Question Time on Tuesday put renewable energy under the spotlight and it was not a pretty sight. Yes, it's a more complicated issue than many of us might think, but that's not unusual. Our government should know how to manage complications by now. In response to almost every question, Karl Thrower, the minister for economic development replied, 'that's under review', or 'we have not yet got all the information we need on that' or 'we don't know, there has been a delay'.

Karl Thrower knows more about renewable energy than the rest of us. It was his job before becoming the minister responsible for it. Some sympathy for the position he was in is unavoidable as he explained why not much progress has been made. At times, by the sound of his voice, what he said and what he thought were two different things. Some questions referred to the extent of private sector involvement in the wonderful new world of renewable energy. Part of this involvement is businesses and home owners having their own PV panels on their

roofs and feeding surplus solar energy into the national grid. That's not allowed now, even though the import duty is reduced to 5% to encourage it. Karl Thrower summoned up all his diplomatic skills to say this is 'mixed messages' being given by the government. The strain in his voice when he said it suggested he thought another description came more readily to mind.

One questioner asked if the PV panels on the roof of the old Argos building were still working. Karl Thrower said he had not been told they needed maintenance. He added, he installed the PV panels on that roof himself, six yeas ago and would expect to be told if they need servicing. He now stands back from installing new PV systems because he is a minister and conflict of interest could become an issue. But servicing his previous installations is still allowed, he said.

Detailed and searching questions were asked by Julie Thomas. Her previous experience as chief minister meant she had a lot of insider information on the subject. The answer to most of her questions was 'that's under review', or 'we have not yet got all the information we need on that' or 'we don't know, there has been a delay' – things like that.

Julie Thomas probably knew the answer to her questions before she asked them. With the clear and unwelcome lack of meaningful progress, we have to wonder why more progress what not achieved by the last government. Why don't we know what kind of wind turbines will be used to replace the twelve relics on Deadwood Plain? It's almost six years since the failed PASH Global deal was agreed in May 2020. Why can't our government move on? While they stand still, we all suffer sky-high energy bills and high energy costs is one of a range of discouragements keeping economic development a distant dream.

Karl Thrower informed us the twelve wind turbines on Deadwood Plain are not made any more. He did not call them suitable as donations to the museum, but he could have – easily. It's not possible to get spare parts for them, that's why eleven have stood motionless for longer than any of us can remember. The one that has moving blades is probably doing no more than waving to us.

Connect plan to get some of the turbines running (no time given) by using the working parts from some of them to repair others. Karl Thrower said this is a temporary solution. It is also an additional cost caused by the lack of progress getting new wind turbines on the island, installed and generating electricity. Inevitably, the additional cost of this temporary solution means other services go without.

Connect St Helena, like the government, have been spending the past few years wondering what to do instead of deciding what to do. They did let us know that the required generating capacity was about the same as PASH Global would have put in place and the renewable energy infrastructure was about right, (that means continue with wind and solar, the same as PASH) – that's not exactly groundbreaking stuff.


What is Connect doing on renewables that is different to SHG? Are they doing the same thing? Are they working together? Who makes the decisions? Does anybody make decisions? Once more we are wondering if so little is said because they don't know what to say.

Meanwhile, those with ability, and the energy to use it, survey the scene and decide they will move their personal lives forward faster if they lived far away from here.

#### **Renewables: Where Do We Go From Here?**

Due to be completed before the end of this month is the Energy Modelling and Design Study. This report will give details such as how much renewable energy is preferred from PV panels and how much from wind turbines. Also, what kind of wind turbines are preferable and the best way to increase PV panel energy generation.

As an example, one of the many considerations on wind turbines is, for large wind turbines, a massive crane costing £millions is needed to erect them. The massive crane is need permanently for when turbine maintenance is required. For most of the time the mega-expensive crane will do nothing. That does not make sense. There is



also the need for a fully trained and qualified engineer to be available when the crane needs maintenance. Smaller wind turbines may be operationally less efficient but do not bring with them these massive extra costs.

The completed modelling and design study will make possible decisions like this and many others like it. From that point the project moves on to procurement. That is, calculating as reliable a figure as possible on how much all of this will cost, drafting a contract to be agreed between government and the contractor responsible for installing the new renewable energy infrastructure and going through the lengthy process of choosing a contractor to do the job. Another issue to be decided along the way is whether some form of direct involvement with the private sector would be advantageous. The involvement could include the initial investment and/or the management of renewable energy including the infrastructure and/or energy generation.

The completed modelling and design study should mean the important and final decisions can start to be made. The target deadline is to have renewable energy generating at least 80% of our total energy needs by 2028. That's two years away. With all that still needs to be done that's a big challenge. No-one should be surprised if the target completion date is extended. At the moment, the official line is the target is still achievable but it is going to be tight.

### **New Biodiversity Strategy Gets Wide Welcome**

Coinciding with last week's Joint Ministerial Council was the launch of the UK Overseas Territories Biodiversity Strategy. The opening section lists the global importance of the biodiversity in the Overseas Territories and the equal importance in conserving and restoring it. The black cloud of climate change casts a shadow over the entire publication.

It is explained, "To meet a challenge of this scale, the Territories need more support. Often with small populations and government departments, some Territories have limited skills and capacity for safeguarding nature. Through consultation, collectively they report lacking access to ecologists, botanists, oceanographers, hydrologists, geographers, and people with specialisms in processing and managing data, knowledge sharing and project management. While there are strong and experienced advocates for nature in the Territories, too often, stakeholders are finding that their environment must compete with other priorities in decision-making." The strategy is wide ranging and puts emphasis on doing things differently to get a better result. Six aspects biodiversity protection are listed, not least of these is developing skills and ability, as well as maximising funding, collaboration and partnership opportunities. On funding, the strategy will be,

"Drawing on both public and private investment, new support will be leveraged from broader audiences to unlock long-term, sustainable and mutually beneficial financing solutions. Models of conservation funding for the mutual good of biodiversity and business are already emerging. From the Atlantic Guardians endowment fund in Tristan da Cunha, to a new partnership in the Falkland Islands (see case study), entrepreneurial examples such as these will be supported to thrive."

Ascension Administrator, Rowan Laxton, said, "This new UK Overseas Territories Biodiversity Strategy recognises that local expertise is essential to global biodiversity protection. It strengthens our ability to safeguard Ascension's natural heritage for future generations, and I am immensely proud of the commitment and professionalism our team brings to this effort every day."

The Falkland Islands Government said the Strategy represents the most collaborative approach to biodiversity conservation across the UKOTs to date.

The Gibraltar government called the new strategy a significant milestone in the UK-OT relationship on environmental protection.

## Sophie Evans Conducts Training of Advocates on Ascension Island



Sophie was recently instructed to conduct training for Lay Advocates on Ascension Island. Lay Advocates are highly regarded members of the community who have rights of advocacy, and can advise and represent others in legal matters. They act as non-professional legal representatives in criminal and civil cases in St Helena and on Ascension Island. Sophie was instructed to conduct the training on behalf of the Public Solicitor's Office, which covers both St Helena and Ascension Island. The training focussed on police station attendances, bail applications and mitigation.

Ascension Island is a volcanic island located near the equator in the middle of the Atlantic Ocean, with a population of approximately 800 people. The island is part of the British Overseas Territory of St Helena, Ascension and Tristan da Cunha. The island is also home to an RAF base, and to a United States Space Force base.

## To the People and the Government of Saint Helena


## **Orbituary**



# Joint Ministerial Council "Protect, Grow, Sustain – Together"

The Joint Ministerial Council (JMC), convened in London by the Minister for UK Overseas Territories (OTs) and the elected leaders and representatives of the Overseas Territories, successfully concluded its proceedings on Thursday, 27 November 2025.

The JMC was guided by the unifying theme 'Protect, Grow, Sustain - Together', and reinforced the relationship between the UK and the OTs as members of the British Family, built upon a strong commitment to partnership, mutual respect, and shared responsibility.

The JMC featured comprehensive bilateral meetings, detailed discussions and informative presentations and a business networking lunch held over four days (24-27 November). The wide-ranging agenda fostered an informing and respectful dialogue, setting a clear path for strengthening our collective future through tangible partnerships.

#### **Key Topics Covered**

The agenda addressed critical issues of mutual interest and cooperation, including:

- Relationship Strengthening: Exploring how to move forward collectively, notably through the development of Partnership Compacts. These would be practical frameworks for advancing shared priorities between the UK and those Overseas Territories that wishes it.
- Technology and Security: Demonstrating the advances of and discussions
  on the use of Artificial Intelligence (AI) in healthcare in the OTs to help solve
  healthcare challenges and cybersecurity. Exploring the benefits of risk
  management and how we can improve cyber security and risk governance, as
  well as addressing security and irregular migration.

- Nature, Climate and Environment: With two key foci, shared nature
  priorities and perspectives and climate resilience and finance, understanding
  the opportunities for climate finance and the adaptation and resilience
  priorities of UK and OT Governments and the crucial role of the OTs in these
  areas.
- Economic Matters: Addressing issues related to illicit finance; supporting
  economic growth through UK Export Finance (loan-based support) and UK
  Free Trade Agreements and the future of Official Development Assistance
  (ODA).
- Business Engagement: Supporting opportunities for strengthening UK
  Government support for deeper economic ties with the OTs; economic
  diversification and facilitation of dialogue between UK businesses and OTs.

  extending the discussion on business engagement.
- **Sport and Culture:** Exploring opportunities through the Commonwealth Games and sport and an opportunity for the OTs to demonstrate the value and benefit to support for their communities as well as the outstanding sports men and women from the OTs competing at international level, supporting UK sportsmanship.

The formal outcomes and agreed actions are detailed in the **UK and Overseas Territories Joint Ministerial Council 2025: Communiqué**, which has been officially published and is available <a href="here">here</a>.

#### JMC Reception and UK Overseas Biodiversity Strategy Launch

The conclusion of the JMC was marked by a reception hosted by Minister Stephen Doughty, MP Minister of State (Overseas Territories), at No 1 George Street, London. The event provided a valuable opportunity for delegations, UK and Overseas Government representatives, and invited guests to network and celebrate the successful Council.

Key addresses were delivered by Minister Doughty, the Honourable Dr Natalio D. Wheatley, MP, Premier of the British Virgin Islands and President of the Political Council of UK Overseas Territories Association and Minister Creagh CBE, MP Parliamentary Under-Secretary (Department for Environment, Food and Rural Affairs) and the Chief Executive of the Joint Nature Conservation Committee (JNCC) Dr Gemma Harper OBE.

In her address, Minister Creagh officially launched the UK Overseas Biodiversity Strategy.
