

Historic SHG Announcement

We are used to an apology in SHG announcements, but only when there is disruption because of some work they are doing. "Port Control would like to thank the public for their understanding and apologises for any inconvenience caused" is one of many examples. The same familiar words are used every time and, as we know, familiarity breeds contempt. There was one variation in October this year when the road was resurfaced at the top of Ladder Hill, the announcement read, "The public are thanked for their cooperation and apologise for any inconvenience caused." Who is apologising? The public? Groundbreaking change

Last Friday, a groundbreaking and hopefully earth moving change happened when someone in the Castle clicked 'send' for the announcement printed below. "The errors were made by the Public Service" it was admitted. That has got to be a first. This was soon followed by "I would like to apologise to all of those concerned". Hopefully this announcement heralds a cultural shift in the way SHG communicate. This announcement is about an issue whipped up to a storm in a tea cup by warring factions in our so-called 'fishing industry' but the importance of the announcement lies elsewhere. The change in style in the announcement, the openness, directness, honesty and the absence of neurotic defensive, makes this announcement the first of its kind. Hopefully a historic first with plenty more open, direct and honest announcements to follow.

But that's not all. This newspaper has complained repeatedly about anonymity and lack of accountability because all announcements and press releases are signed off as 'SHG'. Even within government there are those who are uncertain what or who SHG may be. This historic announcement was written in the first-person singular and signed off by the person writing it – Ian Todd, Chief Secretary and Head of the Public Service. SHG Statement on St Albatros Operations

In response to complaints raised with SHG regarding the operations of the fishing vessel St Albatros, we committed to providing a public response.

Following an investigation conducted by Crown Counsel, the St Albatros and its operations have been found to be compliant with our international fishing commitments with the exception of the following two errors by SHG:

- Notification to the International Commission for the Conservation of Atlantic Tunas (ICCAT) that Ruperts Port was being utilised to land catches made by an internationally flagged vessel; and
- An appropriate access agreement being in place between SHG and South Africa, given that the vessel was sailing under a South African flag.

These errors are now considered historic, given that St Albatros is currently operating under the St Helena flag. The errors were made by the Public Service and arise from the ambiguities between local Ordinance and ICCAT rules. However, we have been advised that the errors are considered to

be minor, administrative issues.

Nonetheless, they should not have happened and I would like to apologise to all of those concerned, whether directly, indirectly or as islanders who simply expect the highest standards from their Public Service. We are reporting these errors to ICCAT to ensure accountability in our fishing sector and will learn from these errors to ensure that they do not happen again.

We are now committed to supporting the comprehensive fishing sector review announced by Minister Thrower, and consider this matter closed.

ART COMPETITION: 'INTERCONNECTEDNESS'

An art competition has been announced this month. The aim is to identify a work or works produced here on the island that can be considered for submission to the Royal Academy for inclusion in its 2026 Summer Exhibition, the theme for which is 'Interconnectedness'.

Works can be in any medium, ranging from painting and drawing to sculpture and wood carving, or any mix of these. Works should be submitted to the Museum in Jamestown by 31 December, where they will be exhibited and judged between 1 January and 7 January. The short notice is due to the 2026 theme only recently having been announced by the Royal Academy. and registration of entries for consideration for the 2026 Exhibition commencing on 7 January.

Competition is fierce and registration of submissions is capped at 18,000 entries, after which no further entries can be considered for short-listing. Works that are shortlisted have to be physically delivered to the Royal Academy (R.A.) in May, either by the artist in person or a representative. Any work selected here will be sponsored for registration, which carries a fee, and will be taken to London by David Jeremiah if shortlisted. With that in mind, works should be capable of fitting inside a suitcase, no more than about 24" x 18". Ideally, works should not only reflect the R.A. theme but also show something about Saint Helena.

To enter the local competition, either with an existing work or one that you are able to produce over the holiday period, please deliver it as above with your name, contact details and age if under 21 as of 7 January (there will be two categories, of under and over 21, with no lower age limit) together with a title and brief explanation of how the work meets the theme and what inspired you to create it.

Professional artists in the U.K., Andy Parker and Sophie Gresswell, both of whom are Saints by descent, have agreed to act remotely as judges, together with a local panel chaired by David Jeremiah, who is organising the competition. Readers of the Saint Helena Independent will recall our report that Andy had a work published at this year's R.A. Summer Exhibition.





Governor Phillips Returns to Where He Started – Durham University

The Student Newspaper Interviews Him





"You can only lose your honour once": Governor Nigel Phillips CBE on leadership, life in the South Atlantic, and lessons from Durham

When Nigel Phillips CBE reflects on his extraordinary career — spanning from the Royal Air Force to senior diplomatic service, and now as Governor of St Helena, Ascension Island and Tristan da Cunha — he does so with

characteristic modesty. "When you look back on all these things, you don't really think about where you might end up," he says thoughtfully. "It's one of those life-type journeys... it's taken some unexpected, wonderful turns." Phillips' story begins, somewhat unexpectedly, at Durham. Having joined the RAF in 1984 as an engineering officer, he later enrolled on an MBA at Durham University Business School, studying by distance learning while serving full-time. "I was already in the Royal Air Force, trying to work out what I was going to do to give myself more tools in the toolbox," he recalls. "The military gives you an incredible amount of training and education, but it was very much focused down a leadership and engineering channel. I wanted to open that up."

At the time, Durham offered what was then one of the UK's leading distance-learning MBAs — a major attraction for Phillips. "It was a really good fit," he says. "The amount of work was considerable on top of my day job, but I felt it was doable. Four years was a long time to commit, and it did become a bit of a marathon, but it was worth it." Looking back, he says the experience reshaped how he thought about leadership and problem-solving. "It gave me a real appreciation of evidence-based decision-making," he reflects. "There's not just one way to address an issue — the MBA introduced me to a different suite of options that you can use. It helped me to break out of groupthink, to approach things differently."

He recalls with amusement the moment he found himself interviewing his commanding officer — an air marshal — for his dissertation. "He said, 'I've never been put through this before,'" Phillips laughs. "It struck me how powerful the MBA was in letting you ask questions in a different way, so that the person at the top says, 'That's a really good question — I hadn't thought about it that way."

The experience, he adds, taught him to value diversity of thought and global collaboration — lessons that would prove essential later. "The cohort was so multinational," he says. "When we met up for summer school, I realised there were people from all over the world. That was enriching — and, oddly enough, working in multicultural environments has been a real feature of my career since."

For today's Durham students, Phillips' advice is reassuringly candid. "Don't stress if you don't know what you want to do yet," he says. "I still don't know what I want to do when I grow up." He laughs. "Some people are very fortunate — they have a clear idea and drive towards it all their lives. But for most of us, it's about what's right for you at that moment. Focus therefore on creating opportunities"

Public service, he insists, offers something rare: "You're never going to be in the top hundred of wealthy people as a public servant," he admits, "but what it brings is extraordinary opportunity. You can directly affect millions of people's lives by what you do. You can influence policy. And you work with people who put service before self — those are the kind of people I like."

He recounts the story of how he first joined the RAF — not from ambition, but from a rainstorm. "I was walking down Leicester High Street when the heavens opened," he laughs. "The nearest place to shelter was a careers office. That's how I joined the RAF." A sharp recruiting officer, he recalls, challenged him to name three front-line fighter jets. "I couldn't. He said, 'You clearly don't know enough about this.' So I went off to study — and when I came back, he had me talking to the boss. He saw something in me — I like challenge, I always have. That's how it started." Phillips' career has since taken him from the defence world to diplomacy and governance — transitions he describes as natural. "I've always focused on two things: team and leadership," he explains. "A leader is part of the team as well as leading it. If you operate with your values and principles intact — those are sacrosanct — you can adapt to anything. You can only lose your honour once."

His time as a military diplomat, serving in Sweden, Poland and Brussels, smoothed his later move to the Foreign Office. "The FCO is different from the military," he says, "but the passion is the same — the same desire to get out there, do remarkable things. The same slightly bonkers people who volunteer to go to the more difficult parts of the

world. I like that."

Asked about his leadership philosophy, Phillips pauses before replying: "It's about people. Always about people. The more you make people feel that you care about them, the more likely they are to work with you to deliver the goal. And to do that, you have to listen. You've got two ears and one mouth — use them in that ratio."

Many assume a Governor's life is largely ceremonial — Phillips smiles at the idea. "I'd like to think it's all gin and tonic and Ferrero Rocher," he laughs. "I do like Ferrero Rocher, actually. But no — the reality is that the role is very legal. You're there to uphold the Constitution, so you have to understand how the law works, and how to interpret it. That's where judgement and experience come in."

Beyond the constitutional duties, he sees a vital civic role: "You are there to recognise and celebrate people for their achievements, or for the work they've done to develop their communities. When you make people feel good about themselves, they tend to go and do other good things. It's a virtuous circle."

Before his current posting, Phillips served as Governor of the Falkland Islands — a tenure marked by the extraordinary challenge of COVID-19. "We managed to get through the pandemic without a single community outbreak or a single death," he says with quiet pride. "That's difficult to beat."

He credits the Falkland government and local community for that success. "By year two and a half of my appointment, we knew the strengths and weaknesses of the team — and collectively, we found a way forward. We had incredible support from the UK government, but at the end of the day, it was: let's make it work."

He also held the concurrent post of Commissioner for South Georgia and the South Sandwich Islands — an experience he describes as "the most extraordinary in the world." Responsible for a marine protected area of 1.24 million square kilometres, he calls it "David Attenborough's favourite place on Earth — a stunningly austere environment, blessed with the highest concentration of marine mammals on earth. To have had a leadership role in helping to protect that was really special."

After years across vastly different postings, Phillips says the most important leadership lesson he's learned is authenticity. "You see people trying too hard — trying to be something they're not because they think they should be. Everyone can see through that," he says. "Authentic leadership is about being yourself. Work hard to improve, perfect your art — but don't put on an act, because you can't keep that up for years."

That sense of humility underpins his work across St Helena, Ascension and Tristan da Cunha. "You don't govern — the elected representatives do that. You're there to make the machinery of government work, to uphold the Constitution. It's not about you. You've given an oath of office to the law — that's where it all starts."

Life on St Helena, he explains, is far from predictable. "There's no typical day," he says. "I'm resident on St Helena, but I have Administrators on Ascension and Tristan who act as my representatives. They have a lot of autonomy — and that's how it should be. I wouldn't want someone sitting on top of me, so I don't sit on top of them."

Asked what sustains a team spread across thousands of miles, Phillips doesn't hesitate: "Purpose. If you don't have purpose, it's hard to do anything — you lose hope. So it's about understanding the purpose, working with elected leaders, and keeping that sense of direction."

Each territory, he says, faces unique challenges. "For us, it's not crime or instability like in some regions — it's about environmental protection and sustainable growth. The Falklands is relatively wealthy; St Helena is relatively poor and dependent on development aid. The challenge is how to deliver services people rely on, but also to make things better, to move forward. When you can see that happening — that's the reward."

He believes the UK public often underestimates the value of its overseas territories. "I think there's a lack of understanding of just how much they enrich the UK," he says. "Nearly all the territories are islands with marine protected areas — they make a huge contribution to the blue-green agenda. St Helena, for example, is a terrestrial biodiversity hotspot. Looking after the oceans and the land benefits everyone."

But it's not just environmental. "It's British values spread around the world," he says. "In the Atlantic, the Pacific, and elsewhere — there are these little pockets of Britishness. It counts for something. When you look at what's going on globally, it's good that that system of government operates where it does."

After four decades in public service, Phillips remains strikingly grounded. Asked what he hopes his legacy will be, he answers simply: "No Governor should take credit for anything. You are there to serve. If people thought that I cared — that would be enough for me."

And what advice would he give his younger self, back at Durham? He smiles. "Believe in yourself," he says after a pause. "And remember the Benjamin Franklin quote — I am a great believer in luck, and I find the harder I work the more I have of it."

A Bird Like No Other

A Flagship Species for St Helena and the World



The Wirebird is a small, elegant plover distinguished by its long, slender legs and delicate features. Its common name was originally the veerbird due to it running to the side, but this name was eventually changed to the Wirebird due to its characteristic thin legs, which help it navigate the rocky and grassy landscapes of its island home. Historically, St Helena was home to several endemic bird species, but habitat destruction and introduced predators have driven all but the Wirebird to extinction. Its survival, therefore, carries profound ecological and cultural significance for the island and its people.

A Conservation Challenge

Despite its iconic status, the Wirebird is classified as Vulnerable by the IUCN due to its small and fluctuating population. Historically, surveys have recorded a decline in numbers, with the population falling by over 40% between 2001 and 2005. Though recent conservation efforts have stabilised the population at around 545 adults, threats such as habitat degradation, invasive species, and infrastructure development continue to place immense pressure on the species.

One of the main threats to the Wirebird is habitat loss due to changes in land use. The bird thrives in open, short-grass habitats with patches of bare ground for nesting. However, an increase in non-native vegetation, reduced grazing, and infrastructure developments have altered these landscapes and made survival for the Wirebird more challenging.

The Role of Habitat Management

The Wirebird's conservation is closely linked to effective habitat management. Grazing plays a vital role in maintaining the short grasslands the bird prefers. The St Helena National Trust (SHNT) and

local graziers have collaborated to implement sustainable grazing practices that balance agricultural needs with conservation goals. By carefully managing invasive plant species and ensuring that pasturelands remain suitable for Wirebird nesting, conservationists hope to reverse the species' decline.

Predation is another major concern. Invasive exotic species such as feral cats, rats, and common mynas are known to prey on Wirebird eggs and chicks. Camera-trap studies have revealed that cats are responsible for over 60% of nest predation events. Efforts to control these predators through targeted management programs are crucial to improving breeding success rates and increasing chick survival.

A Call to Action

The launch of the UK Overseas Territories Biodiversity Strategy underscores the importance of supporting conservation efforts across the UKOTs. For St Helena, safeguarding the Wirebird is not just about protecting a single species, it's about preserving the island's natural heritage and ensuring that future generations can continue to experience its unique biodiversity.

The Wirebird's story is one of resilience and hope. While challenges remain, the dedicated efforts of conservationists, local communities, and policymakers provide a pathway toward a stable and thriving population. By working together, we can ensure that St Helena's national bird remains a proud emblem of the island's rich natural legacy.

Food Products Made for Animals are More Complete than Human Food

Marta López Alonso, Professor of Animal Pathology

While comparing kids to pets might seem a bit much, dogs will never turn down their specially formulated feed, complete with all the vitamins and minerals they need to thrive. This does reflect a serious truth. Nutritionally, food products made for animals are more complete than those made for humans.

Microminerals or trace elements – such as iron, zinc, copper, selenium, iodine, and manganese – are essential. Although we need them in tiny amounts, they play a role in hundreds of metabolic reactions. Iron transports oxygen in the blood, zinc and copper are part of the enzymes that protect against damage to cells, tissues, and DNA, iodine is essential for thyroid function, and selenium helps the immune system to function properly.

When these nutrients are lacking, even slightly, the body notices: fatigue increases, defences are lowered, and the onset of chronic diseases, including cancer, becomes more likely. This is known as "hidden hunger": there is food on the plate, but these invisible nutrients that ensure healthy development and ageing are missing.

Too many toxins

An additional problem is exposure to toxic elements such as arsenic, lead, mercury and cadmium, which we come into contact with

through certain foods or our surroundings. Even in small amounts, they accumulate in the body and affect the nervous system and fertility, and increase cancer risk. Essential mineral deficiencies and exposure to toxins often go unnoticed. They do not show obvious signs until the problem is already serious.

While rural areas continue to suffer from a lack of access to varied foods, large cities experience "hidden" deficiencies linked to ultra-processed diets and excessive calorie consumption that lacks micronutrients.

In more developed societies, deficiencies tend to be more subtle. It is not a question of visible hunger, but rather of unobserved deficiencies associated with ageing, and with vegan diets or poorly planned diets low in meat and fish.

In Europe, for example, several countries in the north and centre of the continent suffer from low levels of selenium and iodine. This is likely linked to soils that lack these elements.

At the same time, exposure to toxic metals such as mercury or cadmium remains a concern, particularly through the consumption of certain fish or smoking.

This diversity of causes reflects the fact that "hidden hunger" takes many forms, and that ensuring a balanced intake of essential minerals is a global challenge that knows no borders or income levels. In veterinary medicine, we have been ahead of the curve in this area for some time, and not just with household pets. In dairy cows, for example, serum (the liquid part of blood) is routinely analysed to adjust diet and prevent deficiencies that could affect both the animal's health and milk production. The same applies to horses, pigs, and poultry; their nutrition is precisely adjusted to prevent problems and optimise results.

In human medicine, we continue to rely primarily on dietary surveys and general recommendations, as there are no universally accepted reference values. We calculate how much iron, zinc, or iodine the average population should consume and, based on that, we design nutritional guidelines. This approach is useful for guiding public health policies, but it is limited as it does not reflect individual circumstances. A person may be at risk of deficiency even if they follow the theoretical recommendations, or they may be unwittingly accumulating toxins.

If we take such good care of a cow's or a dog's diet, why don't we apply the same principles to our own health? If we know that a cow with selenium deficiency produces less milk and is less fertile, we act immediately to correct it. If a dog needs zinc to keep its coat shiny, we give it without hesitation. Why don't we do the same with humans? Veterinary medicine has been doing well for years: taking care of nutrition down to the last detail.

We already have a simple tool to make the leap to personalised nutrition: serum analysis. Serum allows both essential and toxic minerals to be measured at the same time. Just as we now receive cholesterol or glucose values in routine blood tests, we could also detect deficiencies in zinc or selenium, or whether we are accumulating lead or cadmium. This opens the door to more effective public health programmes that are not based solely on dietary estimates, and to truly personalised nutrition.

Targeted nutrition should also be applied to human health. A simple serum analysis could help us live healthier lives, prevent disease and age with a better quality of life.

News from the St Helena Cloud Forest Project





Welcome to another 'news bite' from the St Helena Cloud Forest Project!

Today, we share news on the arrival of a game-changing piece of technology that will support the St Helena National Trust with their important invertebrate work.

Our SHNT partners received a welcome boost in their efforts to better understand and protect St Helena's precious invertebrates with the arrival of an innovative AMI system (Automated Monitoring of Insects) from the UK Centre for Ecology & Hydrology (UKCEH), funded by the St Helena Cloud Forest Project.

The system utilises UV and white lights to attract and take images of moths and other insects, while high-capacity data storage allows for

> the collation of images over long sampling periods. Battery and solar power allow the system to be deployed away from mains power, while there are options for customisable sampling schedules

The AMI system has been described by the SHNT as a "game-changer" for their important invert work under the biodiversity pillar of the project!



England will open their tournament in Dallas on Wednesday, 17 June Scotland's first match at the men's World Cup for 28 years will be against Haiti on Saturday, 13 June

Where and When? The Details

England have been handed World Cup kick-off times which suit UK audiences - but Scotland fans face later finishes during next summer's World Cup.

England will play all three of their group games in the United States, with their first two matches against Croatia, on 17 June, and Ghana, on 23 June, kicking off at 20:00 GMT.

Their final group game against Panama on 27 June begins at 21:00.

Scotland will play their Group C games in Boston and Miami, with their opener against Haiti on 14 June at Gillette Stadium kicking off at 01:00.

Scotland's next two matches, against Morocco in Massachusetts on 19 June and five-time winners Brazil in Miami on 24 June, will both start at 22:00.

England's opening match in Dallas will be played under a closed roof, with air conditioning in the AT&T Stadium, because of the expected heat in Texas.

Their matches in Dallas and Boston - where Scotland play twice - will be on a temporary grass surface, as they normally operate with artificial turf.

Miami, the location of Scotland's final group match against Brazil - which will kick off at 18:00 local time - is

one place extreme heat might prove an issue during next summer's tournament.

Should they qualify through two rounds of UEFA play-off matches in March, Wales or Northern Ireland would play all three group matches at 14:00 GMT.

They would face Canada in Toronto on 12 June, Switzerland in Los Angeles on 18 June, and Qatar in Seattle on 24 June.

The World Cup final at the MetLife Stadium in New Jersey will kick-off at 19:00 GMT on 19 July.

The semi-finals, hosted in Dallas and Atlanta, will also begin at 19:00 GMT.

The final match schedule will be confirmed in March, following the conclusion of the FIFA and UEFA play-off tournaments to decide the final six places.

The tournament will be hosted across 16 cities, spanning four time zones and three countries, at locations up to 2,800 miles apart.
