On Munden's Path? Tanja didn't say – just went





German Consul General Visits St Helena

Finally, she lay a wreath at the Cenotaph honouring those lost on the RFA Darkdale. Tanja explained, "In WW II, St. Helena served as supply base for the British fleet in the South Atlantic. RFA Darkdale was sunk by German submarine U-68 in October 1941 and 41 lives were lost. To honour their memory, I laid down a wreath at the Cenotaph in Jamestown."

One purpose of Tanja Werheit's visit is to deepen existing ties and help create new ones. The most well-known link with Germany is through MACS Shipping. The Island works through the Cape Town Office but the Head Office is in Hamburg. The St Helena Research Institute also works closely with a German professor who has made two visits when he has brought a total of 20 students here to study aspects of what St Helena offers. The professor also works on some subjects with ENRP.

At a meeting with Minister Karl Thrower and Damian Burns, Director of Economic Development they discussed tourism and other business opportunities between St. Helena and Germany.

Tanja's message before leaving was, "Thank you to Governor Nigel Philipps and Chief Minister Rebecca Cairns-Wicks for our various conversations and for sharing your insights about St Helena. Looking forward to staying in touch!"

Pharmaceutical Supply Shortages Getting Worse

Recent reports highlight the longstanding global medical supply problems are getting worse. One report in South African media tells us – “Africa is grappling with a severe medical supply crisis, with fragmented procurement systems and high costs leading to stock shortages and the spread of counterfeit drugs.”

In Britain, counterfeit drugs are not a big issue but there is plenty of evidence the supply system does not work and is getting worse. A report by Healthcare Digital.com includes – “Manufacturing delays have pushed prices to unprecedented levels, leaving chemists unable to meet demand whilst facing substantial financial losses on every packet dispensed.”

Even aspirin cannot be supplied without widespread problems. UK pharmacies face critical aspirin shortages due to manufacturing delays, forcing rationing of supplies whilst prices soar and chemists face losses

Pharmacies across the UK are grappling with severe aspirin shortages, forcing healthcare providers to ration supplies of a medication that could prove critical for patients at risk of heart attacks and strokes.

The UK Government added aspirin to list of products that cannot be exported but industry reaction is a short-term fix and does nothing to improving the creaking supply system itself. An export ban may be a short fix for the UK, but without special exemptions it could be a big problem for St Helena. As supply shortages is a global problem, South African suppliers will have their own set of problems.

NHS underfunding vital medicines by up to 80%

Manufacturing delays are made worse by the UK government and NHS. Some weird payment/funding system is used to pay pharmacists. One UK media report tried to explain; pharmacies in UK buy prescription drugs from wholesalers and are paid (refunded?) via a central NHS contract which is supposed to reimburse them for the cost through a drugs tariff set in Whitehall. Immediately, there are all the signs of a longwinded, duplicated, expensive and ineffective payment system. The end result is, pharmacists are paid short, sometimes by up to 80% of the cost of drugs.

The big worry is St Helena, right at the end of any supply chain, will come off worst.

Harlyn House marks 200th anniversary, with plans for a year-long celebration

The 200th anniversary of Harlyn House was celebrated on Sunday, 1st February 2026 marking two centuries of history at this iconic residence. Mrs. Patsy Flagg, along with her family, commemorated the event with a heartfelt Thanksgiving Service at the house, located in the heart of Half Tree Hollow. The service, led by Bishop Dale, featured songs of praise, Bible readings, and prayer. Guests were invited to share their memories of the house, its role in the local community, and its history.

Harlyn House, built in 1826, has long been a focal point between Jamestown and St Pauls. Mrs. Flagg and her late husband Arnold acquired the house in 1973 from the Anglican Diocese, after it had been bequeathed by its previous owner, Mrs. Gilist. Mrs. Gilist, who had hoped the house would serve as a museum and a school of music, left it to the Diocese upon her death. The celebration was not only a time to reflect on the history of Harlyn but also on the culture of St Helena itself. The Director of the Museum of St Helena (Heritage Society) spoke about the historical significance of Half Tree Hollow, while the Director of the St Helena National Trust expressed gratitude to Mrs. Flagg and her family for preserving and celebrating the legacy the house.

“Culture is not just about what people did,” the Director commented. “It’s also about the imprint they leave on the buildings and places they inhabit. Harlyn is a testament to that legacy.”



Mrs. Flagg's brother, Anthony “Tony” Leo, concluded the service with a toast to the house and its storied past. Guests then enjoyed refreshments and shared reminiscences about their time at Harlyn House, with Mrs. Flagg giving tours of the house and showcasing the extensive renovations and enhancements made over the years.

As part of the celebration, Mrs Flagg revealed plans to continue honouring Harlyn's House legacy with a series of events spanning the entire year. The anniversary celebration also highlighted the Flagg family's deep ties to St Helena, particularly through

Mrs. Flagg's great-grandfather, Mr. George Alphaeus Flagg. An American national, Mr. Flagg arrived on St Helena in the 19th century aboard a whaling ship, shortly after having fought in the American Civil War. Mrs. Flagg treasures his medal to this day as a family heirloom, a physical reminder of the extraordinary journey that brought her ancestors to the island.

“The Flagg family's story is intertwined with the history of St Helena, and Harlyn House stands as a living testament to that connection,” Mrs. Flagg said, reflecting on the rich history passed down through the generations.

As part of the celebration, Mrs Flagg revealed plans to continue honouring Harlyn's House legacy with a series of events spanning the entire year. It was clear that Harlyn House continues to be not just a place of residence, but a symbol of the enduring legacy of the Flagg family and the wider St Helena community. The event was a reminder of the importance of preserving history, not only through objects and landmarks, but also through the stories and memories of those who lived in and around them.

Blue Belt - Beyond the Reef Caribbean Expedition

The RRS James Clark is spending January and February covering four Caribbean Islands, researching samples from offshore waters, fish populations, mapping sea floors, taking thousands of photos and identifying marine life below 1,000 feet depth.

The James Clark has finished collecting data from Anguillian waters and now moved on to Turks & Caicos.

Having collected all the data of various kinds, the work starts; sorting, analysing and learning from it.

One little gem is a photo of an anemone. . . .



This sea anemone seems happy enough growing out of the ocean floor 3,000 feet below sea level. Water pressure at that depth is around 1 tonne per cubic metre.

This specimen bears no relation to the land anemone. The sea version is not a flower, it's an animal. They are related to corals and jellyfish. Sea anemones can sting too. The frilly bits around the edge of the 'bloom' are tentacles, used to catch passing prey. What's that thing about beauty being skin deep?

Tristan Forever - Film Premiere in Berlin

Tristan Forever is a feature-length Swiss 'docufiction' film that features the story of French doctor Loran Bonnardot as he travels to Tristan da Cunha to fulfil a search for solitude.

For thirty years, the doctor from Paris has maintained a friendship with a fisherman on Tristan da Cunha, the most isolated inhabited island in the world. Now he travels back one more time, with the plan to stay there for good.

The film was shot on his journey with the film crew aboard MFV Edinburgh in November 2023 as he travelled to Tristan. The remainder of the film was shot on the island and includes local actors, including fisherman Martin Green. The plot centres on 50-year-old Loran's wish to become one of the island's permanent residents, but whether he stays there is subject to a decision of the Tristan Island Council.



Tristan Forever - Film Premiere in Berlin

The filming was completed in January 2024 by the film team consisting of Loran Bonnardot, Tobias Nölle and Linus Rieser before they departed on MS Hamburg. Producer is Christof Neracher, CEO of Zurich-based Hugofilm Features, with Swiss broadcasters SRF and SRG SSR as co-producers and the Community of Tristan da Cunha as associate producers. Worldwide distribution rights have been secured by China's Rediance.

Born in 1973 in France, Loran is a doctor and filmmaker, who works in Paris and around the world. The short film 37°4 S (2013), which he co-produced, also shot on Tristan da Cunha, won the Jury's Special Prize at the 2013 Cannes Film Festival.

It stars young Tristan actors Riaan Repetto, as Nick, and Natalie Swain, who plays Ann, with cameo supporting parts played by Harold Green and Edwin (Spike) Glass and the voice of Justin Green.

Loran Bonnardot has a real thirty-year association with Tristan da Cunha and has become a good friend of the island community. Loran has two Godchildren on Tristan, Rachel and Connor.

Writing in 2011 in her Agulhas trip report, and published elsewhere on this website, former Tourism Co-ordinator Dawn Repetto said 'It is with sadness that the island must say goodbye to our dear friend Loran Bonnardot. Loran has been a friend to the island for 15 years and has made three trips here where each time he has stayed for a few months. Whenever Loran has visited, he has always helped out voluntarily at the hospital or assisted with families who have been nursing elderly people at home. People like Loran don't come along every day, and the community is very grateful that he has found us and considers Tristan his second home. Loran will be missed dearly but we hope to see him back in the near future.'

The Tristan da Cunha Association plan to show 37°4 S for a second time at their 2026 Annual Gathering to be held at the voco hotel in Southampton on 7th March. It is hoped that Tristan Forever will be available to show at the TDCA's 40th anniversary Annual Gathering in 2027.

UK Government Forced to Release Report on Ecosystem Collapse

“A Sixth Mass Extinction May be Underway”

The UK Government report, ‘Global biodiversity loss, ecosystem collapse and national security’ is said to have been ready for publication last October but was only published in late January after an application under the Freedom of Information Act dashed the hopes of the UK government to permanently bury the report out of sight. The Green Alliance, an independent think tank and charity, who made the application for the report to be published said the report was published quietly on the GOV.UK website with no notifications or pre-publicity.

It Makes No Sense

Attempting to conceal that a sixth mass extinction is coming our way by making it secret does not make any sense. A simple question to Google search will tell anyone interested that many scientists argue that a sixth, human-driven, mass extinction is currently underway. Anyone capable of adding two and two together and coming up with four as the answer either knows about the threat of mass extinction already or could find it out in less than a minute – if the internet has not dropped out. The last mass extinction was 66 million years ago when a 6 to 9-mile-wide asteroid (bigger than St Helena) struck the Yucatán Peninsula in Mexico, creating a 124-mile-wide crater. Today, we know of it because it caused dinosaurs to become extinct. It wasn’t only dinosaurs, 75-80% of species were eliminated due to global wildfires, mile-high tsunamis and a long winter as the heat and light from the Sun was blocked by billions of tons of sulphur, dust, and CO₂ ejected into the atmosphere, causing immediate darkness, plunging global temperatures, and halting plant growth.

What Does Make Sense

It is claimed the report was kept under wraps because its conclusions were “too negative”, and because it would draw attention to the government’s consistent failure to act.

It’s not quite true to say the UK government did not act, they did. Six years ago, The UK counter terrorism police acted against Extinction Rebellion, a group who demonstrated stridently (but peacefully) against mass extinction. They were placed on a list of terrorists which included neo-Nazis, a pro-terrorist Islamist group and other lawless fanatics who were considered a threat to national security. Fast-forward to a week or so ago and the UK government has had to eat humble pie. Now, it’s mass extinction which is the threat to ‘national security’, not supporters of Extinction Rebellion and others who want all governments to make a strong global effort to avoid the mass extinction. Even six years ago, extinction was widely thought to be inevitable.

What does make sense is there must be many loyal and senior members of past and present governments feeling very uncomfortable right now. Now the UK Government is saying exactly the same as Extinction Rebellion and so many other ‘terrorists’ have said for years.

Who Are the World Leaders?

What preoccupies the minds of government leaders today? Ukraine has rare earth minerals deposits thought to be 5% of all world deposits and worth £trillions. Why is Greenland now dragged into the dirt of geo-politics by the world’s grubby, grasping leaders? Because Greenland holds some of the world’s largest untapped deposits of rare earth minerals (REES), with estimated reserves of 1.5 million tonnes, ranked eighth globally. The United States says grabbing Greenland is vital to their national security. What they really mean is they want Greenland’s rare earth minerals before China, Russia or the Europeans have a chance to plunder them. When the UK talk about national security and ecosystem collapse, they mean ‘we are all screwed’.

The situation is so desperate we cannot eat without contributing to our own downfall. The report tells us, “Food production is the most significant cause of terrestrial biodiversity loss. As the global

population grows, reaching 9.7 billion by 2050, the impact of food production on natural systems will intensify and it will become even more challenging to produce sufficient food sustainably.”

The leaders of multi-national mega corporations are world leaders too. Often, they use their extensive influence to succeed in defending their own interests when having a difference of opinion with governments. Avoiding tax is probably top of a long list. Outer Space is the new empire to be conquered. Mega corporations are busily conquering that with hundreds of satellites which obstruct the research of astronomers. There are plans for exploration of other planets. Governments, meanwhile, show their deep respect for tradition by sticking with a form of governance much the same as it was since the concept of parliamentary democracy was born.

Mass Migration

The threats to security are never-ending, “The world is already experiencing the impacts of biodiversity loss, including crop failures, intensified natural disasters and infectious disease outbreaks.” The report adds, “With current trends, global ecosystem degradation is highly likely to continue to 2050 and beyond.”

The Green Alliance believe one reason for the UK government wanting to hide the report is the prospect of mass migration as we follow the path to mass extinction. They suggest the degradation of rainforests in the Congo and the drying up of rivers fed by the Himalayas could mean people flee to Europe, leading to “more polarised and populist politics in the UK” and putting “additional pressure on already strained national infrastructure”.

Defence Before Assistance

The report strays to Central America to give an example of crop failures, intensified natural disasters and infectious disease outbreaks. Between 2012-14, the coffee leaf rust disease caused many Central American coffee farmers to have zero production. The loss of production and previous economic problems displaced 373,000 people across Central America according to some estimates. Since then, highly erratic weather patterns have led to increased drought and flooding, resulting in a loss of 60% in the Central American coffee harvest in 2018. The low-income groups whose livelihoods rely on coffee production, have been driven to migrate, both internally and to the USA.

Massive aid from the United States to El Salvador, Guatemala and Honduras to help ease this colossal problem failed to address root causes of migration, such as poverty, violence, and corruption. More than four million Central American migrants arrived in the U.S between 2014 and 2023.

In 2024, migration started to decrease. However, Trump, becoming president in 2025, adopted an iron fist approach, this drastically reduced the number of migrants entering from Mexico. They were detained, deported and often immediately turned back.

Trump also reduced aid to poorer countries. Most European countries, together with Canada, New Zealand, Switzerland and others have also drastically reduced foreign aid. Spending on defence has increased across all of these countries, and more besides. The Russian war in Ukraine is often given as the main reason, together with a number of other conflicts across the world.

Taking a wider and longer view, reducing aid puts poorer countries in an even weaker position and increasing defence spending strengthens the richer countries against the conflicts which are expected to arise. The report puts it so well, “Migration will rise as development gains begin to reverse and more people are pushed into poverty, food and water insecurity. A one percentage increase in food insecurity in a population compels 1.9 percent more people to migrate.”

Dear Editor,

I was pleased to learn about Omnitouch taking over from Sure as the telecom operator on Ascension, as there were concerns from people about what would happen to telephone services after Sure pulled out, and indeed, to telephone calls, not least those to and from St Helena.

While you can make calls to most parts of the world for pennies a minute over the internet, if you need to pay anything at all, making calls to St Helena, Ascension and the Falklands that way is astronomically expensive, if not plain impossible; I remember paying £1.40 a minute to call someone in Ascension.

As Omnitouch's Norfone service on Norfolk Island serves a place with many of the same challenges as Ascension, we hope that Ascension Island Mobile will be as welcome as Norfone has been on Norfolk Island, especially as, despite its name, it plans to offer fixed line telephone and internet services. Like the Saintel service proposed for St Helena by Karl Thrower some years back, this will use FWA (Fixed Wireless Access), not the copper wire network used by Sure, and before it, Cable & Wireless.

In Norfolk Island, fixed line services are still provided by Norfolk Telecom; despite having been stripped of its self-government and reduced to an appendage of New South Wales, it still has a separate telephone network and country code from Australia, leaving it with the worst of both worlds. However, Norfone does now offer Australian numbers, with the country code +61, thereby sparing people in Australia and the rest of the world the cost of calling numbers using Norfolk Island's code +672, so instead of paying £1.12 a minute to call it from the UK using BT, I'd only have to pay 10p a minute, or with other carriers, even less. By way of analogy, this would be like only me having to pay the same as a call to the UK to call Ascension, rather than 85p a minute with BT. (A call to St Helena is £1.31 a minute!)

Similarly, while Greenland has a separate country code from Denmark, +299, Tussass, the local telecom operator, offers its subscribers a free phone number in Denmark, country code +45. This not only allows people from Denmark and the rest of the world to call them at greatly reduced cost, but also allows people in Greenland to receive text messages to set up a MobilePay account in Denmark, which requires a Danish mobile number. In addition, Greenland has abandoned fixed line telephony completely, not even having an internet based service like BT's Digital Voice, with the handset plugged into the broadband router instead of the socket on the wall.

However, I don't think Ascension Island Mobile will go that far, and nor should it, as what digital gurus call 'leapfrogging', skipping a generation of technology, can smack of bullying; if a fixed line service can be available at no extra cost to those who want and prefer it, why not?

St Helena Enters First Stage of Drought Management – Public Urged to Conserve Water

St Helena has now entered the first stage of drought management as stored water levels continue to decline. Current reserves stand at 81,009 m³, equivalent to around 60 days of supply, and consumption remains high. Daily demand is approximately 1,433 m³, significantly exceeding the 887 m³ currently being abstracted.

This imbalance, combined with steadily falling surface water flows and rising temperatures, is placing increasing strain on the Island's water resources. The Red Hill zone—supplying Half Tree Hollow, St Paul's, and the Hutt's Gate system (which feeds Longwood and Alarm Forest)—remains the highest-demand area, adding further pressure to the water storage systems.

While seasonal reductions in rainfall are expected, recent weeks have seen a sharp drop in inflows, increasing reliance on boreholes to maintain supply. Without a change in weather patterns, St Helena could face severe water shortages in the coming weeks.

What this means for the community

- Stored water levels are declining..
- Consumption is outpacing supply.
- All districts are affected, with Red Hill under the greatest strain.
- Conservation is urgently needed to safeguard resources until the next rainy season.

Call to Action

Connect Saint Helena Ltd urges all domestic, commercial, and government consumers to use water sparingly and avoid unnecessary consumption. Every effort made now will help preserve supplies and support the Island through this challenging period.

St Helena's water resources are under significant pressure, and collective action is essential. Notably, 2025 shows a sharp drop in rainfall after July, highlighting reduced precipitation in the latter half of the year, which may be contributing to current drought conditions.

By reducing consumption today, the community can help safeguard supplies and strengthen resilience until the next rainy season, which we remain hopeful will arrive later this year.

Connect Saint Helena Ltd will continue to monitor conditions closely and provide regular updates as the situation changes.



Jean-Clair Todibo missed a glaring chance to put West Ham 3-2 up, and Nuno Espirito Santo's men were then left heartbroken when Fernandez stroked home in the second minute of stoppage time.

West Ham's misery was compounded as Todibo saw red for grabbing Joao Pedro around the throat as the Hammers stay 18th, five points adrift of safety, while Chelsea surge into the top four. Arsenal substitute Mikel Merino thought he had salvaged a point, but he was outdone by Cunha, who curled home superbly from distance only two minutes and 58 seconds later.

United's second win in as many games under Michael Carrick moves them above Chelsea and Liverpool into fourth, with Arsenal's lead at the top now only four points.
